THE ATTACK ON WESTERN CIVILIZATION

GLOBAL MIGRANCY

THROUGHOUT THE WORLD WHOLE POPULATIONS, OR SIGNIFICANT PARTS OF THEM, ARE ON THE MOVE SEEKING WHAT FROM THEIR HISTORICAL VIEWS AND EXPERIENCES ARE LIFE-CHANGING RESULTS. THESE MOVEMENTS ARE OFTEN INITIATED BY POLITICAL, ECONOMIC, RELIGIOUS AND SOCIAL DISTURBANCES OF LIVES ALREADY AT RISK BY FORCES THAT CANNOT BE RESOLVED LOCALLY. THESE INCLUDE WARFARE, ECONOMIC COLLAPSE, FAMINE AND A VARIETY OF NATURAL MISFORTUNES THAT SUCH AS CLIMATE CHANGE, CROP FAILURE, FLOODING, DROUGHT, AND SPECIES LOSS, AS WELL AS THE EXHAUSTION OF A VARIETY OF NATURAL RESOURCES WHOSE AVAILABILITY AND PROTECTION HAVE BEEN AVAILABLE ON A MOSTLY REGULAR BASIS TO WESTERN CIVILIZATION (WCIV) FOR CENTURIES.

THE GLOBAL MIGRANCY (GM) PROBLEM IS MADE UP OF THREE PARTS — MIGRANCY, IMMIGRATION AND IMMIGRANTS. THESE MAY SOUND AS IF THEY ARE ONE AND THE SAME, BUT THEY ARE NOT. EACH HAS DISTINGUISHING CHARACTERISTICS THAT REQUIRE DIFFERENT MEANS OF RESPONSE AND EACH DELIVERS ITS IMPACT IN DIFFERENT WAYS TO OUR SOCIETY.

WE SHALL START WITH MIGRANCY BY WHICH WE REFER TO THE MASS MOVEMENTS OF LARGE POPULATION GROUPS FROM ONE AREA, USUALLY OF THEIR BIRTH, TO ANOTHER TERRITORY WHOSE POLITICS, CULTURE, ETHNICITY, RELIGION, ETC. MAY BE STRIKINGLY DIFFERENT FROM THE LAND OF THEIR DEPARTURE.

SUCH MIGRATIONS GENERALLY ARE CAUSED BY DISRUPTION OR DYSFUNCTION OF THE SERVICES AND SUPPLIES UPON WHICH THEIR HOMELANDS HAVE INCREASINGLY COME TO DEPEND.

IN OUR PRESENT MOMENT, THE RELIGIOUS WAR IN THE NEAR EAST (NE) AND ITS NEARLY TOTAL DESTRUCTION OF GOVERNMENT, COMMERCE AND BASIC COMMUNITY SERVICES HAVE CAUSED THE SPONTANEOUS EXIT OF GROWING NUMBERS OF MIGRANTS TO GREECE AND TURKEY WITH THE ULTIMATE GOAL OF FINDING WELCOME WITHIN IN THE ALMOST BORDERLESS EUROPEAN UNION (EU).

SIMULTANEOUSLY, A SEPARATE FLOW FROM CENTRAL AFRICA MOVES NORTH TO LIBYA WHERE, AGAIN, THOSE IN FLIGHT GATHER TO UNDERTAKE THE SHORT, BUT DANGEROUS, VOYAGE INITIALLY TO SICILY AND THEN FURTHER TO THE EU'S NORTHERN RIM OF COUNTRIES SUCH AS ENGLAND, SWEDEN, GERMANY AND OTHERS WITH LAX ADMISSIONS POLITICS. ALTHOUGH AFRICA ALSO SUFFERS FROM DEEP TRIBAL AND RELIGIOUS DIVISIONS, WHAT HAS CAUSED ITS EXPLODING MIGRANCY IS NOT THE SOCIAL AND POLITICAL TURMOIL OF WARFARE, BUT RATHER THE INCREASING INABILITY OF CENTRAL AFRICA'S INHABITANTS TO SUPPORT THEMSELVES, AS THEIR ECONOMIES SUFFER COMPLETE COLLAPSE DUE TO A COMBINATION OF EXTREME DROUGHT, CROP FAILURE AND THE FAMINE AND DISEASE THAT ACCOMPANY THEM.

IN TWO DIFFERENT AREAS, FORCES BEYOND THEIR INDIVIDUAL CAPABILITY TO CONTROL HAVE COMBINED TO PUSH MILLIONS OF MEN, WOMEN AND CHILDREN ACROSS THE MEDITERRANEAN SEA

IN THIS ISSUE, ISSUE WE START TO EXPLORE THE NATURE OF THE EXTENSIVE ANTIWESTERN (AW) THOUGHT THAT EXISTS IN OUR WORLD, AND ITS FOCUS ON WESTERN CIVILIZATION. WE LOOK AT AMERICA'S POSITION AND WHAT WE MUST DO IF WE ARE TO RETAIN OUR CULTURAL HERITAGE.

TO ESTABLISH NEW LIVES IN EUROPE — THE BIRTHPLACE OF WCIV.

BUT MIGRANCY IS NOT JUST ABOUT NUMBERS AND LOCATIONS. IT IS ALSO ABOUT CULTURE, AS MIGRANTS BRING WITH THEM THEIR OWN CULTURES AND EXPECTATIONS WHICH OFTEN CONTRADICT THOSE OF THEIR NEW HOST COUNTRIES. ALTHOUGH CULTURE CAN INCLUDE SUCH PRESSURE POINTS AS LANGUAGE, RELIGION AND RACE, THE POLITICAL LEADERSHIP OF THE EU, CANADA AND THE US RESOLUTELY REFUSES TO CONFRONT, OR EVEN MENTION, THESE VERY REAL THREATS TO WCIV FROM WHICH WE HAVE DESCENDED. A NOTABLE EXCEPTION IS AUSTRALIA WHICH HAS ATTEMPTED TO DEFLECT A CONTINUING FLOW OF MIGRANTS FROM SOUTHERN ASIA AND INDONESIA. AS EUROPE SERVES AS THE NORTHERN ESCAPE VALVE FOR AFRICAN AND NE MIGRANCY, SO AUSTRALIA DOES THE SAME FOR SE ASIA.

THE SECOND ASPECT OF OUR GM PROBLEM IS IMMIGRATION AND IN DISCUSSING IT WE DO NOT REFER TO ANY ONE COUNTRY, BUT RATHER TO THE PROCESS ITSELF. IT DEALS WITH THE MOVEMENT OF INDIVIDUALS AND GROUPS ACROSS BOUNDARIES. IT IS A CIRCUMSTANCE SUBJECT TO LEGAL DEFINITIONS AND DERIVES FROM LEGISLATIVE ACTION. THIS PUBLIC AND POLITICAL STATUS ENABLES IT TO BE ENFORCED BY WHATEVER LOCAL, NATIONAL OR INTERNATIONAL MEASURES ARE AVAILABLE AT BORDERS TO PRESERVE THEIR INTEGRITY. IMMIGRATION IS A GOVERNMENT GATE-KEEPER.

EVER SINCE ONE PREHISTORIC MAN FIRST PICKED UP A ROCK OR A STICK TO BASH IN ANOTHER'S SKULL WE HAVE HAD ARMED AGGRESSION PRESENT IN THE COURSE OF OUR HUMAN DEVELOPMENT. THE HUNTER-GATHERERS ROAMED THE EARTH FREELY, AND MILLIONS OF YEARS AGO SET IN MOTION OUR PLANET'S FIRST GM WHEN THEY LEFT THEIR AFRICAN HOMELAND, PUSHED EAST AND NORTH ACROSS ASIA AND THEN, VIA A LAND BRIDGE OVER WHAT IS NOW THE BERING SEA, TO ALASKA AND SOUTH TO CANADA AND THE US.

IN THE PROCESS OF HIS EARLY TRAVELS, PRE-HISTORIC MAN ENCOUNTERED NO BORDERS. HE FOLLOWED HIS KNOWN NATURAL NEEDS OF GAME, WATER AND CLIMATE AS WELL AS THOSE OF HIS INNER SELF WHICH SET HIM IN MOTION IN WAYS AND DIRECTIONS HE COULD NOT UNDERSTAND. THROUGHOUT HIS EXPLORATIONS AND DISCOVERIES, HIS NEW WEAPONS AND AGGRESSIVE

BEHAVIOR INCREASED HIS CHANCE FOR SURVIVAL.

BUT WITH THE ARRIVAL OF AGRICULTURE EVERYTHING CHANGED. NOMADIC WAYS OF THE HUNT WERE ABANDONED IN FAVOR OF CULTIVATING A FIXED FOOD SUPPLY THAT WOULD PRODUCE REGULAR HARVESTS. PLANTED FIELDS BECAME BOTH INDIVIDUAL AND COMMUNAL ASSETS CAPABLE OF SUPPORTING MAN IN RETURN FOR HIS INVESTMENT OF TIME, ENERGY AND EFFORT.

AGRICULTURE BROUGHT WITH IT THE CONCEPT OF FIXED BOUNDARIES AND OWNERSHIP SO THAT THE INPUT OF LABOR, WOULD BE REFLECTED IN THE REWARD PRODUCED. AND BOUNDARIES COULD BE USED TO DESIGNATE LAND FOR SALE, INHERITANCE, GIFTS, ETC. THEY BECAME A KIND OF LANGUAGE FOR LAND AND LABOR WHICH SUITED THE EARLY AGRICULTURE OF PRIMITIVE, BUT FIXED, SETTLEMENTS.

BOUNDARIES THEN AND BOUNDARIES NOW ARE TWO TOTALLY DIFFERENT CONCEPTS, AS THE MILLIONS OF YEARS BETWEEN OF INCREASING WEALTH, POPULATION, USAGE, TECHNOLOGY AND CONFLICT OF THE HUMAN EXPERIENCE HAVE EMBEDDED THEM THROUGHOUT OUR PATTERN OF HUMAN ACTIVITY.

BOUNDARIES FUNCTION IN IMMEASURABLE WAYS IN OUR WORLD, BUT NONE MORE BASIC THAN IN THE MATTER OF IMMIGRATION WHERE SOVEREIGN NATIONS DRAW LINES THAT DETERMINE HOW MANY PEOPLE, WHICH ONES, UNDER WHAT CONDITIONS AND FOR WHAT PURPOSES WILL BE ALLOWED TO ENTER, LIVE AND PERHAPS WORK IN THEIR COUNTRIES.

IMMIGRATION IS A PROCESS OF CONTROL. AS POLITICAL, ECONOMIC AND SOCIAL PRESSURES BUILD FOR GREATER IMMIGRATION IN ONE OR MORE PARTS OF OUR WORLD, IT IS STILL THE RECEIVING COUNTRIES' RIGHT TO ACCEPT MIGRANTS OR NOT. DO THEY WANT TO MAINTAIN THE BENEFITS OF THEIR HISTORY AND CULTURE FOR THE NEXT GENERATION, OR SHARE THEM IN AN UNCONTROLLED WAY WITH ANYONE WISHING TO HAVE ACCESS ? IT IS EASY TO SEE HOW OUR PRESENT QUESTIONS AND ANSWERS RELATED TO THOSE FACED BY THE RESIDENTS OF EARLY AGRICULTURAL SETTLEMENTS IN ESTABLISHING BOUNDARIES TO BALANCE LABOR AND ITS REWARDS.

THE THIRD MEMBER OF GM'S TRIPARTITE STRUCTURE IS THOSE MIGRANTS WHO HAVE GAINED ENTRY AND BECOME IMMIGRANTS IN A COUNTRY. ONCE ADMITTED, THEY CAN ASSIMILATE OR CHOOSE

TO REMAIN DISTINCT; THEY CAN BE ANGRY OR GRATEFUL; THEY CAN LEARN THEIR NEW LANGUAGE OR NOT; THEY CAN ATTEMPT TO ACHIEVE A POLITICAL UNDERSTANDING OF THEIR NEW HOME OR THEY CAN CHOOSE TO BE PART OF A BLOC WHICH AIMS TO SERVE ITS OWN, OFTEN SEPARATIST, PURPOSE RATHER THAN ADVANCE THE UNDERSTANDING AND PROGRESS OF THE INDIVIDUAL.

IMMIGRANT STATUS IS THE CULMINATION OF THE MIGRANCY-IMMIGRATION-IMMIGRANT PROCESS. TODAY IT ENABLES THE BUNDLING OF PRIOR EXPECTATIONS, RESENTMENTS, HOPES, INJUSTICES, PENALTIES, PAIN AND LONG-GONE PROMISES INTO ONE MASS AND ITS TRANSFER TO A NEW HOME. IN AMERICA AND ELSEWHERE IT IS A FAR CRY FROM ITS MORE CAREFULLY MANAGED PAST. OUR WORLD IS DIFFERENT, TOO, AND YET WE CANNOT AVOID ASKING FOR OURSELVES AND OTHERS, "HOW DID WE GET HERE FROM WHERE WE WERE?"

BEFORE EXPLORING THE PARTICULARS OF THE GM SITUATION THERE ARE TWO VERY POWERFUL GLOBAL FORCES SPECIFIC TO OUR ERA THAT HAVE SERVED TO MAGNIFY AND ACCELERATE ITS PROGRESS. THE FIRST IS THE EXPONENTIAL GROWTH IN GLOBAL POPULATION OVER THE PERIOD OF THE PAST TWO CENTURIES WHICH WE REFER TO AS THE INDUSTRIAL REVOLUTION (IR). THIS INCREASE FROM ABOUT 1 BILLION TO OUR CURRENT 7.5 BILLION HAS CHANGED EVERYTHING.

EVEN GREATER IN TERMS OF ITS SCOPE AND IMPACT HAS BEEN THE EMERGENCE OF NEW TECHNOLOGIES, MOST CONSPICUOUSLY IN THE FIELD OF COMMUNICATIONS, THAT HAVE ALLOWED DISTANT, POOR AND PREVIOUSLY INACCESSIBLE POPULATIONS TO VIEW BY SATELLITE OR TV TRANSMISSION IMAGES OF HOW LIFE IS LIVED IN THE UPPER LEVELS OF THE DEVELOPED WORLD. THIS WAS ESPECIALLY TRUE IN AFRICA AND ITS MUCH SMALLER NEIGHBOR, THE NE.

BOTH AREAS SUFFERED CENTURIES OF EXTREME POVERTY, POOR EDUCATION, RELIGIOUS HOSTILITIES, SERIOUS UNEMPLOYMENT AND CLIMATIC HARDSHIPS AND, ALTHOUGH OIL EXPLORATION HAD COMMENCED IN THE NE IN THE EARLY 20TH CENTURY, IT WAS NOT UNTIL AFTER WW II THAT OIL BECAME THE WORLD'S PRIMARY ENERGY SOURCE. THROUGH THE MARVELS OF MODERN CHEMISTRY, IT DELIVERED A CONTINUING FLOW OF NEW PRODUCTS AND SERVICES WHICH LED US TO REFER TO OUR 20TH CENTURY AS THE "OIL AGE".

ENTER TELEVISION AND ITS ABILITY TO SEE EVERYTHING EVERYWHERE. ARABS TENDING GOATS IN THE DESERT COULD GLIMPSE THE LIFESTYLES OF THEIR ROYAL RULERS MADE POSSIBLE BY THEIR NATIONS' OIL. OTHER IMPOVERISHED POPULATIONS THROUGHOUT THE WORLD HAD ACCESS TO VISIONS OF LIFE THEY COULD NOT IMAGINE — A SOCIAL, POLITICAL AND CULTURAL IRRITANT THAT STIMULATED THOUGHTS AND EFFORTS OF GM.

POPULATION AND TECHNOLOGY ARE MEGA-FORCES FAR BEYOND THE REACH OF PAST GOVERNMENTS OR THE COLLECTIVE MODEL NOW OFFERED BY THE EU. GIVEN THEIR PRESSURE ON GM AND THE NATURE OF THAT PROCESS WE CAN EXPECT THAT CULTURAL CROSS-PURPOSES AND COUNTER CONSEQUENCES WILL RESULT.

PROPHETS WITH AND WITHOUT HONOR

THIS IS THE TRUTH OF GM TODAY: THERE ARE MILLIONS OF NEWLY AWARE, BUT STILL POVERTY STRICKEN, PEOPLE IN MOTION AROUND THE WORLD PURSUING RELIEF FROM THEIR NATIVE AND HISTORICAL CIRCUMSTANCES; AND ATTEMPTING TO RELOCATE AND ACQUIRE SOME, IF NOT ALL, OF THE BENEFITS OF LIFE THAT THEY NOW KNOW ARE AVAILABLE TO THEIR COMPATRIOTS AND TO THOSE BEYOND THEIR BORDERS.

WE SHOULD MAKE NO MISTAKE IN IDENTIFYING THE DIRECTION OF THESE MOVEMENTS. THERE, ARE NO WAVES OF IMPOVERISHED MIGRANTS SEEKING TO TRANSFORM THEIR LIVES WASHING UP ON THE SHORES OF SOMALIA, INDIA, ETHIOPIA, EGYPT OR THE SOVIET STATES THAT BORDER ON THE BLACK AND CASPIAN SEAS, EVEN THOUGH RUSSIA IS HOST TO A MULTI-MILLION MUSLIM MINORITY ON AND WITHIN ITS SOUTHERN BORDER.

NO, THE NE AND AFRICAN MIGRATIONS HAVE POINTEDLY TARGETED EUROPE, THE PROSPEROUS, CULTURALLY AND ECONOMICALLY ADVANCED HEART OF WCIV. A FAR SMALLER NUMBER HAVE BEEN ABLE TO REACH WCIV'S WEALTHY EXTENSIONS IN OUR HEMISPHERE — CANADA AND THE US. WCIV ALSO EXISTS IN THE SPANISH LANGUAGE AND CHRISTIAN RELIGION THAT DOMINATE LATIN AMERICA, BUT THEY ARE OVERLAID ONTO A MIXED NATIVE POPULATION BASE. SOUTH AMERICA'S MOSTLY TROPICAL CLIMATE AND LANDSCAPE, AS WELL AS ITS LACK OF NORTHERN EUROPEAN HERITAGE, ALSO FAIL TO OFFER MIGRANTS THE OPPORTUNITIES OF ITS NORTHERN NEIGHBORS.

THE HUMAN CAPABILITY FOR FOLLY IS ABSOLUTE, ESPECIALLY IN MATTERS POLITICAL. AS THE NUMBERS OF MIGRANTS MASSING IN THE SOUTHERN AND EASTERN MEDITERRANEAN GREW, ANGELA MERKEL THREW OPEN GERMANY'S DOORS AND OFFERED REFUGE TO ALL. SHE COUCHED HER OFFER IN HUMANITARIAN TERMS, BUT IT IS MORE THAN LIKELY THAT, KNOWINGLY OR NOT, SHE DID SO WITH THE NAZI PAST IN MIND.

UNDER THE SCHWENGEN AGREEMENT THE EU HAS NO INTERNAL BORDERS. ACCORDINGLY, ONCE A MIGRANT ENTERS ANY STATE ON ITS RIM, HE/SHE CAN PASS FREELY THROUGH THE INTERIOR. AND THIS IS WHAT MOST MIGRANTS DID, AIMING FOR DESTINATIONS IN GERMANY, FRANCE, THE UK, SWEDEN, THE NETHERLANDS, ETC. ALL OF WHOM HAD LIBERAL LABOR, RESIDENCY AND SOCIAL ASSISTANCE POLICIES IN PLACE.

INTERVIEWS WITH THESE MOSTLY MUSLIM MIGRANTS INDICATE THAT THEY HOPE AND EXPECT TO BE GIVEN HOUSING, LANGUAGE INSTRUCTION, MEDICAL CARE, JOB TRAINING AND EDUCATION FOR THEMSELVES AND THEIR OFFSPRING. EDUCATION AMBITIONS OFTEN INCLUDE POST GRADUATE STUDY AND THE ADDITIONAL EXPENSE IT ENTAILS. GIVEN THE CONSIDERABLE ECONOMIC BURDEN THIS MIGRATION IMPOSED ON THE EU'S MEMBER STATES, SOME ON ITS BORDER, WHEN THEY SAW THE NUMBERS WERE TOO LARGE TO

ABSORB, CHOSE TO NOT RETAIN THEM FOR LONG, BUT TO MOVE THEM TO THE INTERIOR TO SETTLE WHERE THEY WISHED.

THE EU CROWD WAS NOT ALONE IN TRYING TO MAKE POLITICAL CAPITAL OUT OF THE MIGRANCY CRISIS. HERE, THE OBAMA ADMINISTRATION DID EVERYTHING POSSIBLE TO CIRCUMVENT OUR IMMIGRATION LAWS AND INCREASE MIGRANT ADMISSIONS; AND IN CANADA, PRIME MINISTER (PM) TRUDEAU DELIGHTED IN ECHOING MERKEL'S INVITATION AND ACCELERATING CANADA'S MOVE TO THE LEFT ON IMMIGRATION ISSUES SUCH AS CITIZENSHIP, WELFARE ASSISTANCE, RIGHT TO WORK AND ENTRY VISAS.

WE HAVE OFFERED HERE THE STRUCTURE AND FORCES THAT COMBINE TO SUPPORT GLOBAL MIGRANCY. THIS ISSUE IS CULTURALLY EXISTENTIAL AND POLITICALLY TREACHEROUS. IT IS KNOWN BY MANY DIFFERENT WAYS AND NAMES BEHIND WHICH POWERFUL INTERESTS COMPETE FOR STATUS AND CONTROL, AND YET OUR ELECTED POLITICAL LEADERS AND OUR MAINSTREAM MEDIA (MSM) ARE COMPLICIT IN PREVENTING FULL AND HONEST DISCUSSION OF ITS CONSTITUTIONAL CONFLICTS AND ITS BROAD RANGE OF CULTURAL, SOCIAL AND ECONOMIC CONSEQUENCES.

IN THE REMAINING PART OF THIS CHAPTER WE WILL EXAMINE SOME OF THE THREATS AND CONSEQUENCES THAT OUT-OF-CONTROL MIGRATION POSES TO THE NATIONS AND INSTITUTIONS OF THE WESTERN WORLD.

PROPHECY #1

GEERT WILDERS (1963-)

WILDERS IS A DUTCH POLITICIAN, MEMBER OF PARLIAMENT AND HEAD OF THE RIGHT-WING PARTY FOR FREEDOM (PVV). HE HAD A DUTCH FATHER AND INDONESIAN MOTHER, AND HAS TRAVELLED EXTENSIVELY IN THE ISLAMIC NE AND IN ISRAEL. IN THE COURSE OF HIS MANY SPEECHES IN PARLIAMENT AND WHILE CAMPAIGNING HE HAS FREQUENTLY WARNED HIS AUDIENCES OF ISLAM'S THREAT TO THE NETHERLANDS AND TO EUROPE. LISTED BELOW ARE SOME QUOTES FROM A 2010 ADDRESS HE GAVE IN NEW YORK :¹

“ ... THE ISLAMIZATION OF EUROPE. THIS NOT ONLY IS A CLEAR AND PRESENT DANGER TO THE FUTURE OF EUROPE ITSELF, IT IS A THREAT TO AMERICA AND THE SHEER SURVIVAL OF THE WEST. THE UNITED STATES AS THE LAST BASTION OF WCIV, FACING AN ISLAMIC EUROPE.”

“THE EUROPE YOU KNOW IS CHANGING ... THERE IS ANOTHER WORLD. IT IS THE WORLD OF THE PARALLEL SOCIETY CREATED BY MUSLIM MASS-MIGRATION.”

“THESE ARE MUSLIM NEIGHBORHOODS AND THEY ARE ... THE BUILDING BLOCKS FOR TERRITORIAL CONTROL OF ... EUROPE, STREET BY STREET, NEIGHBORHOOD BY NEIGHBORHOOD, CITY BY CITY.”

“MANY STATE SCHOOLS IN BELGIUM AND DENMARK SERVE ONLY HALAL ² FOOD TO ALL PUPILS.”²

“IN FRANCE ... THE HISTORY OF THE HOLOCAUST CAN NO LONGER BE TAUGHT BECAUSE OF MUSLIM SENSITIVITY.”

“LET NO ONE FOOL YOU ABOUT ISLAM BEING A RELIGION ... IN ITS ESSENCE ISLAM IS A POLITICAL IDEOLOGY. IT LAYS DOWN

DETAILED RULES FOR SOCIETY AND THE LIFE OF EVERY PERSON.”

“ISLAM MEANS SUBMISSION.”

“THE WAR AGAINST ISRAEL IS ... A WAR AGAINST THE WEST. IT IS JIHAD.”

“ONE CENTURY AGO THERE WERE APPROXIMATELY 50 MUSLIMS IN THE NETHERLANDS. TODAY, THERE ARE APPROXIMATELY 1 MILLION ...”³

THESE ARE HIGHLIGHTS EXCERPTED FROM A MUCH LARGER TEXT WHICH WAS INTENDED AS A WARNING IN 2010, BUT TIME PASSES AND WILDERS' WARNING HAS SINCE BECOME A PROPHECY AND THEN A STATEMENT OF FACT.

IN THE FIRST QUOTATION ABOVE, FOR THOSE WHO CAN REMEMBER, THERE IS A STARTLING SIMILARITY BETWEEN WILDERS' PORTRAYAL OF “THE UNITED STATES AS THE LAST BASTION OF WCIV, FACING AN ISLAMIC EUROPE” AND CHURCHILL'S WORDS OF WARNING IN THE 1930S. JUST CHANGE ONE WORD, “ISLAMIC”, TO NAZI AND THE INTERVENING YEARS DISAPPEAR.

THE NETHERLANDS IS A COUNTRY SMALL IN POPULATION AND AREA SANDWICHED BETWEEN BELGIUM AND DENMARK. LIKE ITS NEIGHBORS, IT HAD ONLY A MINOR ROLE IN THE RECENT GRAND WARS AND POLITICS OF EUROPE AND DEVELOPED A LEFT OF CENTER LIBERAL POLITICAL TRADITION. UNFORTUNATELY, IN ALL THREE COUNTRIES THEIR LIBERAL OUTLOOK PROVED AN INVITING TARGET FOR ISLAMIC MIGRATION AND SETTLEMENT.

WILDERS' VIEWS WERE CONSIDERED EXTREME BY THE ESTABLISHED MAJORITY POLITICAL PARTIES. HIS PVV CAME CLOSE TO ASSEMBLING A COALITION THAT, HAD IT WON, COULD HAVE MADE WILDERS THE PRIME MINISTER, BUT IT WAS NOT TO BE. IN CAPSULE FORM: FOR ABOUT 20 YEARS IN ROTHERHAM, SOUTH YORKSHIRE, ENGLAND AT LEAST 1,400 CHILDREN, MOST OF THEM WHITE GIRLS AGED 11-15, WERE SEXUALLY ABUSED BY A GROUP OF MAINLY BRITISH-PAKISTANI MEN. ABUSE INCLUDED GANG RAPE, FORCED WATCHING OF RAPE, THREAT OF RAPING

MOTHERS AND SISTERS, TRAFFICKING TO OTHER TOWNS, DOUSING WITH PETROL AND THREATENING TO SET FIRE AND MORE. LOCAL AUTHORITIES WERE INFORMED AND TOOK NO ACTION. AN ARTICLE IN THE TIMES BY A REPORTER AND YOUTH WORKER FINALLY CAUSED HEARINGS IN PARLIAMENT FOLLOWED BY A FULL 8 YEAR INVESTIGATION AFTER WHICH TWENTY-FOUR MEN AND TWO WOMEN WERE BROUGHT TO TRIAL AND CONVICTED. IN THE COURSE OF THE INVESTIGATIONS AND SUBSEQUENT PROSECUTIONS THE MOST FREQUENT REASON CITED BY DEFENDANTS FOR PERMITTING THIS WIDESPREAD ABUSE WAS THAT THEY DIDN'T WANT TO OFFEND EITHER THE PAKISTANIS INVOLVED OR THE LOCAL PAKISTANI COMMUNITY.

THIS WIKIPEDIA REPORT IS EQUALLY SHOCKING IN ITS REVELATION OF PERPETRATORS' AGONIZINGLY ABUSIVE ACTIONS, THEIR MOTIVATION AND THE CRIMINALLY NEGLIGENT RESPONSE OF ROTHERHAM'S CIVIC ADMINISTRATORS.

WE SHOULD NOT BE DIVERTED FROM REALIZING THE ENORMOUS HUMAN FAILURE THAT ALLOWED ROTHENHAM'S ABUSE AND TERROR BY THINKING IT WAS A ONE-OFF, A SINGLE, ANOMALOUS OCCURRENCE. FAR FROM IT; FEW THINGS SCALE UP AS QUICKLY AND EASILY AS HUMAN ERROR, AND ROTHENHAM'S TWISTED DEFERENCE TO ITS PAKISTANI POPULATION HAS COUNTERPARTS ELSEWHERE.

PROPHECY #3

THE STOCKHOLM SYNDROME

A MOST NOTABLE EXPANSION TO NATIONAL SCALE IS SWEDEN WHICH FOR DECADES HAS SOUGHT AND SECURED THE STATUS OF WCIV'S MOST SUCCESSFUL SOCIALIST STATE. IT WAS BLESSED BY A NORTHERN CLIMATE, SMALL POPULATION, GORGEOUS SCENERY, NATURAL RESOURCES AND A POLITICALLY AND SOCIALLY ENERGETIC CITIZENRY. ONE OTHER DISTINGUISHING AND KEY FACTOR IN ITS POLITICAL DEVELOPMENT IS THAT IT DID NOT SERVE AS A BATTLEFIELD IN THE TWO 20TH CENTURY WORLD WARS THAT ENGULFED MOST OF EUROPE.

IN 1973, FOUR SWEDISH BANK EMPLOYEES WERE TAKEN HOSTAGE AND HELD IN THEIR BANK'S VAULT FOR FOUR DAYS BY A KIDNAPPER AND HIS ACCOMPLICE. DURING THE COURSE OF NEGOTIATIONS AND IN COMMENTS FOLLOWING THEIR RELEASE IT BECAME APPARENT THAT THE PRISONERS HAD DEVELOPED SOME BONDS OF TRUST AND AFFECTION WITH THEIR CAPTORS. THIS UNUSUAL EMOTIONAL TRANSFERENCE WAS REFERRED TO AS THE STOCKHOLM SYNDROME BY A SWEDISH PSYCHIATRIST AND THE FOLLOWING YEAR GAINED GLOBAL NOTORIETY WHEN IT WAS USED IN PATTY HEARST'S DEFENSE OF HER JOINING HER KIDNAPPERS IN A SERIES OF BANK ROBBERIES.

STRANGELY, IT CAN NOW BE APPLIED TO SWEDEN'S NATIONAL

POLITICAL POSITION. FROM OUR POSTWAR TRANSATLANTIC VANTAGE POINT, IT WAS EASY FOR AMERICANS TO CONDEMN SWEDEN AND OTHER EUROPEAN NATIONS THAT MADE A 20TH CENTURY PEACE WITH SOCIALISM AND THEN EVEN ENCOURAGED IT. IT WAS NOT A FAR MOVE FROM THEIR BENIGN MONARCHIES TO LIFE UNDER A BENIGN FORM OF STATE CONTROL. MORE IMPORTANTLY, SOCIALISM OFFERED A POLITICAL SIDESTEP AND ESCAPE FROM THE BLOODY INDUSTRIAL CLASHES BETWEEN COMMUNISM AND FASCISM, THEIR PROXY SPANISH CIVIL WAR AND THE GROWING ANTI-SEMITISM OF THE INTER-WAR PERIOD.

SWEDEN'S HOMOGENEOUS POPULATION AND PEACEFUL CHARACTER ENABLED IT TO EMBRACE AND EXPERIMENT WITH SOCIALISM AT ITS OWN PACE, UNHINDERED BY THE LIFE OR DEATH COMPETITION WITH OTHER NATIONS OR SYSTEMS TO CREATE SUCCESS BY DENYING IT TO OTHERS. ON A CONTINENT WHERE SOME FORM OF WAR HAD BEEN WAGED ALMOST CONSTANTLY FOR A THOUSAND YEARS, SWEDEN'S PARTICIPATION WAS VERY LIMITED, AND IT PURSUED SOCIALISM WITH THE INTENTION OF IMPROVING LIFE AND GOVERNMENT FOR ITS PEOPLE.

ALTHOUGH ITS EFFORTS BORE FAINT WHIFFS OF THE SCENT OF MONARCHY FROM THE 19TH CENTURY, TIMES WERE GOOD, MONEY WAS AVAILABLE, AND THE SWEDISH GOVERNMENT AND PEOPLE VIEWED POSTWAR EUROPE AS A TIME TO UNDERTAKE NEW DIRECTIONS CONSISTENT WITH THEIR HISTORICAL VALUES. SWEDISH LEADERS, PRESIDING OVER THEIR HOMOGENEOUS AND SOMEWHAT ISOLATED CULTURE, HAD NO IDEA OF THE DEMOGRAPHIC/POLITICAL CHANGES IN EUROPE'S FUTURE THAT WOULD RESULT FROM THE UN, THE EU AND THE MARSHALL PLAN. OF ALL THESE THE LATTER MOST DRAMATICALLY ILLUSTRATES UNINTENDED CONSEQUENCES. IT WAS A VAST PROGRAM TO REBUILD POSTWAR EUROPE THAT PROVIDED FUNDS FOR RECONSTRUCTION AND, IN RETURN, SUBSTANTIAL PURCHASES OF AMERICAN GOODS AND SERVICES. BY ALL MEASURES IT WAS A SPECTACULAR SUCCESS — A WIN/WIN FOR EUROPE AND THE US.

BUT BECAUSE GERMANY HAD EXPERIENCED THE MOST EXTENSIVE LOSS OF PLANT, INFRASTRUCTURE AND LABOR, IT HAD TO GO BEYOND THE USUAL POSTWAR, GENERATIONAL METHOD OF RECOVERY, AND FOR LABOR IT TURNED TO TURKEY TO PROVIDE A QUICK RESUPPLY OF LOW COST, INDUSTRIAL AND AGRICULTURAL WORKERS, MOST OF WHOM WERE MUSLIMS WITH A HIGH FERTILITY CULTURE. THESE NEW ARRIVALS PRODUCED OFFSPRING THAT ENJOYED GERMAN CITIZENSHIP, BUT RETAINED MUCH OF THEIR ISLAMIC IDENTITY AND ATTRACTED CONTINUING MUSLIM IMMIGRATION FROM TURKEY AND OTHER PARTS OF THE NE.

WHILE GERMANY REACHED OUT TO TURKEY TO SOLVE A SPECIFIC AND IMMEDIATE LABOR/ECONOMIC PROBLEM, THE ADDITION OF A PERMANENT PRESENCE OF ISLAMIC CULTURE MAY HAVE CONSIDERABLY GREATER LONG-TERM CONSEQUENCES. AND ONE HAS TO WONDER WHETHER ANGELA MERKEL CONSIDERED OR REFLECTED THIS MUSLIM ELEMENT WHEN SHE RECENTLY OPENED EUROPE'S DOORS AND INVITED MILLIONS OF NE MIGRANTS TO ENTER AND LIVE IN GERMANY. HER NEIGHBORS, KNOWING THAT ONCE ADMITTED THESE NEW ARRIVALS HAD OPEN ACCESS TO OTHER EU NATIONS, HAVE PAID A HIGH PRICE FOR MERKEL'S GENEROSITY.

GERMANS INTERVIEWED OFFERED THE OPINION THAT “ISLAM DOES NOT BELONG IN GERMANY”.

PROPHECY #4

OUR NEIGHBOR TO THE NORTH

HOMOGENEOUS SOCIETIES SUCH AS SWEDEN TEND TO ENERGIZE POLITICAL MOVEMENT BY CONSENSUS RATHER THAN BY ARGUMENT FROM WHICH ONE SIDE EMERGES AS VICTOR. ACCORDINGLY, AS TWO POSTWAR GENERATIONS PASSED, IT FITTED ITSELF MORE COMFORTABLY TO CONTROLLED SOCIALISM AND VICE-VERSA. THE ONE, GREAT MISTAKE IT MADE WAS THAT IT COULD NOT ENVISION THE THREAT TO SWEDISH IDENTITY POSED BY MIGRATION, NOR HOW ITS LAWS WRITTEN TO BENEFIT THE SWEDISH PEOPLE COULD BE TURNED AGAINST THEM.

MANY OF SWEDEN'S LAWS AIDED RESIDENTS, AS WELL AS CITIZENS, WITH EXTREMELY GENEROUS FORMS OF PUBLIC ASSISTANCE. AS THE RECENT WAVE OF MIGRANTS BROUGHT HUNDREDS OF THOUSANDS OF MUSLIMS TO SWEDEN, THEY WERE ABLE TO CLAIM RESIDENCY BENEFITS NOT AVAILABLE TO SWEDISH CITIZENS. FOR INSTANCE, GOVERNMENT CONSTRUCTED OR RENOVATED PUBLIC HOUSING IN MALMO WAS MADE AVAILABLE TO MUSLIM MIGRANTS WHILE SWEDISH CITIZENS WORKED THEIR WAY UP A THREE-YEAR WAITING LIST.

THROUGHOUT SWEDEN THE MOSTLY YOUNG, MALE, MUSLIM MIGRANTS BROUGHT WITH THEM THEIR CULTURE OF SEXUAL VIOLENCE AND FEMALE ABUSE. AND IN MALMO, AGAIN, YOUNG SCHOOL GIRLS, ABUSED BY A GROUP OF MUSLIMS, WHO LODGED A COMPLAINT WITH SCHOOL AUTHORITIES WERE TOLD TO WEAR CLOTHES THAT COVERED MORE OF THEIR BODIES.

HERE AGAIN, IN HOUSING AND SEXUAL ABUSE, THE INSTITUTIONAL PROTECTION THAT SWEDISH NATIVES EXPECTED WAS DENIED. IN SOME AREAS SWEDISH POLICE, WHO LACK THE BACKGROUND OF SERVING IN NYC, CHICAGO OR LA, ARE OUTNUMBERED AND UNDERARMED; AND SWEDEN HAS FAILED TO MAKE THE NATIONAL EFFORT REQUIRED TO TURN THE SITUATION AROUND AND RECLAIM IT'S FORMER WAY OF LIFE. THE STATUS IS FRAUGHT WITH FEAR, DANGER AND BETRAYAL FOR THE SWEDISH PEOPLE WHICH RAISES THE QUESTION OF WHETHER THEY OR THEIR GOVERNMENT CAN TAKE COUNTER ACTION. IF NOT, IT IS A STRONG POSSIBILITY THAT WHEN IT'S INSTITUTIONS FAIL, A MODERATE, HOMOGENEOUS SOCIALIST STATE MAY TAKE LEAVE FROM THE EUROPEAN FAMILY AND ITS OWN HISTORY.

ARE WE TO ASSUME THAT LOCAL ROTHERHAM AND NATIONAL SWEDEN ARE UNIQUE ? OR EVEN RARE ? MANY OBSERVERS OF BOTH PLACES SEEK REFUGE FROM RESPONSIBILITY BY SUCH A JUDGEMENT. IT IS A COLOSSAL ERROR THAT REFUSES TO ACCEPT THAT WCIV IS AT RISK AND THAT THE STOCKHOLM/ROTHERHAM BEHAVIORS ARE PRACTICED IN MANY OTHER PARTS OF EUROPE.

WE SHOULD RECALL THAT IN 2015 IN A PUBLIC NEW YEARS EVE CELEBRATION IN COLOGNE, 1,200 SEXUAL ASSAULTS AND ROBBERIES WERE COMMITTED. ARRESTS MADE THAT NIGHT AND DURING THE FOLLOWING INVESTIGATION INDICATED THAT MOST OF THOSE TAKEN INTO CUSTODY WERE MUSLIM MALES. THERE WAS NO PROMPT REPORTING OF THIS EVENT BY THE POLICE OR MEDIA, BUT PERSISTENT PUBLIC INQUIRY BY INDEPENDENT INTERESTS ENDED THE COVER-UP AND BELATEDLY ACTIVATED COLOGNE'S JUSTICE SYSTEM. IN A POLL THAT FOLLOWED IN 2016, 60% OF

CANADA ON ITS SOUTHERN BORDER IS SEPARATED FROM THE US BY SUCH SMALL DISTANCES AS THOSE OF LAKES, RIVERS, BRIDGES AND A LINE ON OUR MAPS. ITS RUGGED LANDMASS EXTENDS FROM OUR GREAT LAKES REGION TO NORTH OF THE ARCTIC CIRCLE WHERE IT IS TRANSFORMED INTO AN ARCHIPELAGO OF FROZEN ISLANDS AND WATERS.

WE SHARE OTHER ASPECTS OF OUR EXISTENCE WITH CANADA. IT IS REPEATEDLY TOUTED IN GOVERNMENT AND COMMERCIAL SECTORS AS OUR LARGEST TRADING PARTNER, WHICH IT IS, BUT FAR MORE IMPORTANT TO BOTH OF OUR HISTORIES IS OUR SHARED WCIV CULTURE AND ITS COMMON ORIGINS OF 17TH CENTURY ENGLISH AND FRENCH EXPLORATION.

THIS EARLY AND FORMATIVE DUAL CULTURE ENDED IN 1759 ON THE PLAINS OF ABRAHAM OUTSIDE QUEBEC WHEN ENGLISH FORCES DEFEATED THE FRENCH, CAUSING FRANCE FOUR YEARS LATER TO EFFECTIVELY CONCLUDE ITS TERRITORIAL AMBITIONS IN NORTH AMERICA. BUT THE CULTURE HAD BEEN PLANTED AND SURVIVED IN CANADA'S LANGUAGE AND HISTORY LONG AFTER FRENCH MILITARY AND CIVIC AUTHORITY WERE WITHDRAWN. TODAY, EASTERN CANADA, INCLUDING THE PROVINCE OF QUEBEC, IS A BILINGUAL AREA IN WHICH A RECENT REFERENDUM TO MAKE FRENCH ITS OFFICIAL LANGUAGE FAILED BY THE NARROWEST OF MARGINS.

BECAUSE OF OUR SIMILAR TIMELINES, CULTURE AND COLONIAL EXPERIENCES, CANADA WAS ABLE TO DEVELOP POLITICALLY, SOCIALLY AND ECONOMICALLY IN WAYS MUCH LIKE OURS. BUT THERE HAS ALWAYS BEEN ONE ENORMOUS DIFFERENCE — AND THAT IS CLIMATE. MOVING NORTH FROM ITS SOUTHERN BORDER AND POPULATION CENTERS, THE TEMPERATURE DROPS STEADILY, THE LAND BECOMES INCREASINGLY HARD, SPARSELY POPULATED AND MAINTAINS A FROZEN OR SEMI-FROZEN STATE THROUGHOUT THE YEAR. MINERALS AND TIMBER ARE PLENTIFUL AND MOST HUMAN ACTIVITY IS GEARED TO SUBSISTENCE OR SURVIVAL. LIFESTYLE, WHICH WE USE TO DESCRIBE OUR TEMPERATE ZONE ACTIVITIES, IS MEANINGLESS IN THE CANADIAN NORTH. TOIL AND HARDSHIP ARE CONSTANTS WITHOUT WHICH LIFE CANNOT BE MAINTAINED. AS WE MIGHT EXPECT, CANADA'S POPULATION IS NOT EVENLY DISTRIBUTED AND MOST OF IT IS CONCENTRATED IN A BAND THAT RUNS FROM VANCOUVER ISLAND ON IT'S WEST COAST EAST TO QUEBEC AND NEWFOUNDLAND ON THE ATLANTIC.

THESE DIFFERENCES OF CLIMATE, LANGUAGE AND POPULATION HAVE INFLUENCED CANADA'S CULTURAL DEVELOPMENT; AND ALSO ITS POLITICS, ALTHOUGH THE DEMOGRAPHICS OF ITS SOUTHERN URBAN, COMMERCIAL, MORE POPULOUS AREAS REMAIN DOMINANT.

JUSTIN TRUDEAU (B. 1971) BECAME PM OF CANADA WHEN HE LED ITS LIBERAL PARTY TO VICTORY IN THE 2015 ELECTIONS. HE FOLLOWS HIS FATHER, WHO DIED IN 2000, IN CANADIAN POLITICS AND OFFERS VOTERS A YOUNG, FRESH FACE AND A NEW LABEL AND

DIRECTION.

THE LABEL, WHICH NOW DESIGNATES LIBERALS AS PROGRESSIVES, IS PART OF A REBRANDING EFFORT UNDERWAY ALSO IN AMERICA AND, WE SUSPECT, IN EUROPE AIMED AT CREATING A NEW PROGRESSIVE IMAGE THAT LOOKS TO THE FUTURE AND LEAVES BEHIND THE FAILURES AND EXCESSES OF ITS LIBERAL PAST. DESPITE THE REBRANDING, JUSTIN TRUDEAU'S "NEW DIRECTION" APPEARS TO BE AN INCREASING EMPHASIS AND EXPANSION OF PAST PROGRAMS.

NOT LONG AGO, AS THE MIGRANCY PROBLEM IN EUROPE REACHED LEVELS UNMANAGEABLE BY EVEN EU METHODS, TRUDEAU HELD A PRESS CONFERENCE WITH A REFUGEE SYRIAN FAMILY TO CELEBRATE ITS ARRIVAL AND, LIKE MERKEL, TO DECLARE THAT CANADA'S IMMIGRATION POLITICS WOULD BE ADJUSTED TO WELCOME IMMIGRANTS SEEKING A NEW HOME AND "BETTER LIFE". THEN, AS CAMERAS FLASHED, PM TRUDEAU INTRODUCED THE PARENTS AND THEIR FIVE CHILDREN ALL DRESSED IN NEW WESTERN CLOTHES.

SOME OBSERVERS SAW THIS AS A REACH TOO FAR, AS AN ACT OF EXCESS FROM WHICH THEIR COUNTRY MUST RETREAT; OTHERS, MORE REALISTICALLY VIEWED IT AS A STARTING POINT WITH MORE AHEAD. TRUDEAU WENT ON, WITH THE COOPERATION OF HIS PARTY'S APPOINTEES AND REPRESENTATIVES IN GOVERNMENT, TO REFRAME CANADA'S IMMIGRATION POLICY/REGULATIONS IN WAYS THAT OFTEN RAN COUNTER TO EXISTING LAW. SO AS NOT TO BE TOO ALARMING TO THE PUBLIC, THESE CHANGES WERE OFTEN EXPRESSED OR ACCOMPANIED BY THE WARM AND GENERAL LANGUAGE WITH WHICH THE LIBERAL LEFT (LL) PRESENTS ITS POSITIONS AND PRACTICES.

HOWEVER, AT ONE EVENT, WHEN ASKED TO COMMENT ON HIS INCREASINGLY OPEN BORDERS POLICY, HE STATED:

"THE VERY CONCEPT OF A NATION FOUNDED BY EUROPEAN SETTLERS IS OFFENSIVE TO ME. OLD STOCK, WHITE CANADIANS ARE AN UNPLEASANT RELIC, AND QUITE FRANKLY, REPLACEABLE. AND WE WILL REPLACE THEM."⁴

THIS IS A VERY TROUBLING STATEMENT FOR ANYONE TO MAKE, BUT TO COME FROM THE POLITICAL LEADER OF ONE OF THE TWO MOST IMPORTANT MEMBERS OF THE ENGLISH COMMONWEALTH OF NATIONS, IT IS NOTHING LESS THAN TERRIFYING; AND FOR THOSE WHO CAN RECALL, IT STANDS IN STARK AND PAINFUL CONTRAST TO THE ENDURING GOOD WILL AND GENUINE AFFECTION FOR THE COMMONWEALTH NATIONS THAT WINSTON CHURCHILL OFTEN EXPRESSED IN HIS WARTIME ADDRESSES.

PM TRUDEAU CALLS ON THE STATE POWER AFFORDED HIS POSITION TO RID CANADA OF ITS "OLD STOCK, WHITE CANADIANS" AND TO REPLACE "THEM" WITH SOME OTHER UNNAMED POPULATIONS MORE TO HIS LIKING. HIS COMMENT IS CERTAINLY RACIALLY CHARGED AND SUGGESTS THAT WHAT HE HAS IN MIND IS A SLOW MOTION, NON-VIOLENT VERSION OF HITLER'S HOLOCAUST, STALIN'S PURGING OF THE KULAKS OR MAO'S CULTURAL REVOLUTION. FOR THOSE WHO THINK THE AW THREAT TO WCIV IS NOT REAL, THINK AGAIN. NOTE THAT TRUDEAU COULD EASILY HAVE MADE HIS POINT BY REFERRING TO CANADA'S FOUNDERS AS "OLD STOCK CANADIANS". THE ADDITION OF "WHITE" TO HIS DESCRIPTION ALTERS BOTH ITS TONE AND MEANING BY INCLUDING THE ELEMENT OF RACE.

BUT, THE TRUDEAU SUPPORTERS MIGHT OFFER, HE IS NOT AW. TRUE; BUT HE IS WESTERN WHICH MAKES HIS POSITION EVEN MORE REPREHENSIBLE. WE LOOKED BACK FOUR GENERATIONS AND TWO CENTURIES OF HIS DIRECT LINE GENEALOGICAL DESCENT (FATHERS AND MOTHERS; NO SIBLINGS, AUNTS, UNCLES, ETC.) AND FOUND 31 NAMES EVERY ONE OF WHICH WAS OF EITHER ENGLISH OR FRENCH ORIGIN.

THESE ARE HIS ANCESTORS, HIS LINEAGE, HIS LINE OF CULTURAL AND GENETIC DESCENT. HE IS ONLY WHAT HE IS BECAUSE OF WHAT THEY WERE. AND IT IS THEY THAT GIVE HIM HIS HISTORICAL IDENTITY, NOT HIS CHOICE OF POLITICAL AFFILIATION OR THE PHOTO-OPS, CONVENTIONS OR UN APPEARANCES OF POLITICAL LIFE. TRY AS HE MAY TO REJECT HIS NATIVE IDENTITY, IT WILL ALWAYS BE A PART OF HIM.

A STATEMENT SUCH AS HIS DOES NOT HAVE THE SOUND OF CAMPAIGN TRAIL ORATORY. IN ITS OWN WAY IT IS SHOCKING AND VICIOUS. IT IS WHAT IT IS AND SHOULD BE RECOGNIZED ON ITS FACE VALUE AS THE KIND OF THOUGHT THAT DRIVES MANY "PROGRESSIVES" OR "LIBERALS" TO THEIR GOALS.

IS IT UNIQUE ? PROBABLY NOT; BUT WHAT IS UNIQUE IS ITS PUBLIC DELIVERY. PRES. OBAMA AND TRUDEAU SAW EACH OTHER AS "KINDRED SPIRITS", "BROTHERS UNDER THE SKIN" AND OFTEN EXPRESSED THEIR MUTUAL INTERESTS AND RESPECT, BUT OBAMA NEVER SPOKE PUBLICLY IN TERMS AS SPECIFIC AS TRUDEAU'S EVEN THOUGH THEIR IMMIGRATION POLICIES AND RESULTS MUST LEAD TO THE SAME CONCLUSION — REPLACEMENT OF WCIV POPULATIONS BY THOSE FROM THE MANY LESS DEVELOPED AND THIRD WORLD AREAS OF AFRICA, ASIA AND LATIN AMERICA.

OCCASIONALLY, IN OUR HISTORY WE HAVE BEEN ABLE TO COMBINE CULTURAL AND POLITICAL ISSUES IN WAYS THAT YIELD BENEFITS FOR BOTH CONSTITUENCIES AND HAVE PROVIDED THE IMPETUS NECESSARY FOR CHANGE. SUCH CHANGE IS STILL POSSIBLE TODAY, BUT THE CIRCUMSTANCES WE MUST FACE TO ACHIEVE IT ARE CONSIDERABLY MORE COMPLICATED.

MOST PROMINENT AMONG THESE IS THE INCREASE IN WEALTH, TECHNOLOGY, SPEED AND REACH OF OUR MSM WHICH IS NOW A VAST CONGLOMERATION OF PUBLISHING, BROADCAST, SPORTS, HOSPITALITY, WAGERING AND OTHER INTERESTS AVAILABLE 24/7 ON MOVIE, TV, COMPUTER AND SMART PHONE SCREENS. THE POLITICAL PERSPECTIVE OF THIS FORCE'S EDITING, REPORTING AND CONTENT ARE ALL FIRMLY ALIGNED WITH THE LL.

THERE IS, HOWEVER, ONE MEDIA ELEMENT THAT IS INEXPENSIVE AND AGILE ENOUGH TO REACH, MARSHAL AND CO-ORDINATE THE ACTIONS OF MEMBERS OF A NEW AND SPONTANEOUS EFFORT. IT IS THE INTERNET WHERE CHANCE AND UNPREDICTABILITY CAN GIVE NEW MEANING TO SUCH UNDERTAKINGS AND CONVERT THEM INTO PURPOSEFUL MOVEMENTS.

NONE OF THIS IS POSSIBLE UNLESS A SMALL GROUP IS WILLING TO CLEARLY SPELL OUT THE NATURE OF THE CHANGE IT HOPES TO BRING ABOUT AND THE DIRECTIONS IT WILL PURSUE. BOTH ARE SUBJECT TO ADJUSTMENT, BUT NO ENERGY WILL BE GENERATED,

NO PROGRESS CAN BE MADE UNTIL THE FIRST STEP IS TAKEN, UNTIL A CONVERSATION COMMENCES.

THE QUESTION THAT THE PEOPLE OF THE WEST, NOT JUST THEIR GOVERNMENT, MUST FACE IS “HOW DO WE RESPOND TO THIS GRADUAL DESTRUCTION OF OUR CULTURE ?” AMERICANS PRIDE THEMSELVES ON BEING “A NATION OF LAWS, NOT MEN”. THIS EXTRAORDINARY PERSONAL VIEW OF JOHN ADAMS IS ALMOST 300 YEARS OLD NOW AND HAS SURVIVED AS ONE OF OUR MOST BASIC VALUES. MORE THAN A CONVENIENT QUOTE FOR POLITICIANS, IT HAS TRANSCENDED PERSONAL AND POLITICAL DIFFERENCES AND EVEN TODAY IS POPULARLY CLAIMED, IF NOT HONORED, AS ONE OF OUR MOST VALUED AND DISTINCTIVE BONDS.

“...WE WILL HAVE NO OTHER LAW THAN THAT OF THE JUNGLE.”

BOTH THE VALUES AND BONDS OF WCIV ARE UNDER INTENSE ATTACK BY THE GM PROBLEM AND THE FORCES BEHIND IT. “A NATION OF LAWS, NOT MEN” HAS A LOFTY AND INSPIRING SOUND WHICH IS MUFFLED BY WCIV’S RELUCTANCE TO CONFRONT THE ENEMY WITHIN. IF WCIV DOES NOT RECOGNIZE THIS ENEMY AND TAKE ACTION AGAINST IT, WE WILL HAVE NO OTHER LAW THAN THAT OF THE JUNGLE.

NOT SURPRISINGLY, THIS WILL REQUIRE A COMMUNAL REBIRTH WITHIN WCIV OF MANY OF ITS FORMER, BUT NOW DORMANT, PRINCIPLES. AS AN ACKNOWLEDGED LEADER OF THE WORLD AND THE WEST, THE US WILL BE CALLED UPON TO ACCEPT A LARGER SHARE THAN OTHERS OF BOTH THE OBLIGATIONS AND OPPORTUNITIES THAT WILL BE OFFERED. WE MUST BE CLEAR ABOUT WHAT THESE ARE AND THE FORCES PRESENTLY AT WORK AMONG BOTH THEIR DENIERS AND DEFENDERS.

WHO’S WHO?

OUR 21ST CENTURY MIGRANCY CRISIS IS ONE ELEMENT IN THE MASSIVE PATTERN OF CHANGE THAT CHALLENGES OUR TIME AND PLACE. TO VIEW MIGRANCY IN ITS PROPER PERSPECTIVE WE HAVE TO RECOGNIZE THAT IT IS A PUSH/PULL PROCESS CAPABLE OF DISTORTING THE THOUGHTS, CONFLICTING THE EMOTIONS AND SHIFTING THE PERSPECTIVES OF THOSE WHO ENGAGE IT AT ANY LEVEL.

THE PUSH COMES FROM THE PHYSICAL, ECONOMIC AND SOCIAL DESTRUCTION CAUSED BY WAR, CLIMATE CHANGE, OVERPOPULATION, NATURAL RESOURCE LOSS AND THE FAILED POLITICS THAT ACCOMPANY THEM. AREAS AFFECTED BY THESE EXTREME DISLOCATIONS ARE FOUND THROUGHOUT THE WORLD; AND WHERE THEIR PAIN BECOMES TOO GREAT TO BEAR, THEIR POPULATIONS ARE LEFT WITH NO OTHER OPTION THAN TO CUT THEIR TIES AND MOVE ELSEWHERE.

THE PULL PART OF THE MIGRANCY IS THE PRODUCT OF POLITICAL AND ECONOMIC INTERESTS IN MORE STABLE COUNTRIES

WHO WELCOME MIGRANTS’ VOTES AND LOW LABOR COSTS. THESE SPECIAL INTERESTS GO BEYOND WELCOME; THEY WOO THEIR NEW ENTRANTS WITH THE CONSIDERABLE GUILT AND POWER AVAILABLE FROM MODERN COMMERCE AND TECHNOLOGY. RECALL OUR PREVIOUSLY MENTIONED EXAMPLE OF RESIDENTS OF HIGH POVERTY AREAS BEING EXPOSED TO THE LUXURY OF WESTERN LIFE. IT IS A CLASSIC “DOUBLE WHAMMY” WITH TWO “WINNERS” AND ONE “LOSER”. THE SPECIAL INTERESTS GET THE BENEFITS OF IMMIGRANT LABOR AND VOTES; THE NEWCOMERS GET A NEW LIFE IN A NEW COUNTRY WITH GENEROUS GOVERNMENT FUNDING TO SUPPORT IT. AND THE TAXPAYER GETS THE BILL !

THERE’S SOMETHING ELSE THAT’S TRULY UNSETTLING ABOUT THIS PROCEDURE, AND THAT IS THAT MANY NEW ARRIVALS HERE AND ELSEWHERE, HAVING BEEN PROVIDED WITH A WAY OF LIFE UNIMAGINABLE IN THEIR HOMELANDS, CAN QUICKLY BECOME POLITICALLY ACTIVE AND PARTICIPATE IN PROTESTS OR OTHER DEMONSTRATIONS ORGANIZED TO OBTAIN “MORE” FROM GOVERNMENT — MORE MONEY, OPPORTUNITY, RESPECT, ATTENTION, HOUSING, HEALTHCARE, ETC. IT IS ONE OF THE ENDURING CONTRADICTIONS OF THE MIGRANCY ISSUE THAT TWO SUCH CONTRADICTORY TALES AS OPEN BORDERS/WELCOME TO ALL AND ROTHERHAM/MALMO CAN BE TAKING PLACE SIMULTANEOUSLY.

WE MUST TRY TO HAVE AS COMPLETE AN UNDERSTANDING AS POSSIBLE OF THE IDENTITIES OF THE WEST’S ENEMIES DESPITE THEIR FREQUENT ATTEMPTS TO MASK THEIR NAMES, LOCATIONS, SOURCES AND TRUE INTENTIONS.

THE GM PROBLEM IS A TOOL OF THE POWERFUL FORCES PRESENTLY AT WORK TO DESTROY WCIV’S LEADERSHIP AND POWER. THESE FORCES GO BY MANY NAMES AND WEAR DIFFERENT HATS AND UNIFORMS DEPENDING UPON DEMANDS OF THE MOMENT. SOME OF THESE NAMES ARE COMMUNISTS, SOCIALISTS, GLOBALISTS, LIBERALS, THE LEFT, MULTICULTURALISTS (MC) AND OTHERS. BECAUSE MASKS AND LABELS ARE FREQUENTLY CHANGED, OUR CATCH-ALL TITLE OF AW INCLUDES THOSE ORGANIZATIONS, ACTIVITIES AND PHILOSOPHIES ENGAGED IN THE CONSISTENT SUBVERSION, OPPOSITION OR DESTRUCTION OF WCIV HISTORY, ACHIEVEMENTS, THOUGHT, POLITICS, RELIGION, CULTURE, ETC.

THAT’S A LONG AND BROAD LIST WHICH CONTAINS NO MORE AND NO LESS THAN THE EXPECTED AMOUNT OF HUMAN ERROR. THE WEST HAS NO CREDIBLE CLAIM TO PERFECTION, ALTHOUGH IN ITS EARLY POLITICAL (GREECE), AND RELIGIOUS (CHRISTIANITY) EXPRESSIONS IT CLAIMED PERFECTION AS A GOAL. THIS CLAIM PROVED TO BE REMARKABLY ABSENT AT BOTH INSTITUTIONAL AND PERSONAL LEVELS. STILL, THE AW COHORT TARGETS WESTERN EUROPEAN THOUGHT, ART AND SOCIETY AND THE PREDOMINANTLY WHITE, NORTHERN EUROPEAN INDIVIDUALS AND INSTITUTIONS THAT HAVE CONTRIBUTED SO MUCH TO ITS SUCCESS.

GIVEN THE AW’S CONSIDERABLE PRESENCE IN AFRICA, ASIA AND IN OUR OWN HEMISPHERE, MUCH OF ITS MESSAGE IS DIRECTED TO POPULATIONS IN AREAS OF SEVERE PRESENT AND PAST POVERTY WHERE ISSUES OF RACE, ENVY, AND DEPRIVATION ARE CONSTANT REMINDERS OF THEIR FAILED SOCIO-ECONOMIC STRUCTURES. NOT SO EASILY RECOGNIZED BY THESE POPULATIONS IS THE HEAVY AND CONTINUING BURDEN IMPOSED ON THEIR LIVES BY THEIR TRADITIONAL TRIBAL DIVISIONS. NO MATTER FROM WHAT ANGLE WE REGARD THE AW’S HOSTILITY, IT SHIMMERS WITH REFLECTIONS

OF RACE, CLASS, ENVY, HATE, RELIGION, IDENTITY AND INEQUALITY.

NOT BAD FOR STARTERS; BUT IN ADDITION TO THE DIRECT IMPACT ON THEIR SOCIETIES THESE SEVEN DRIVERS TARGET POLITICAL CIRCUMSTANCES AND FORMS THAT SPREAD PUBLIC DIVISION AND DISSATISFACTION. THE FIRST SIX ARE ISSUES WE RARELY DEAL WITH DIRECTLY IN OUR POLITICS AND THE LAST, HAVING TO DO WITH EQUALITY, HAS BEEN THE TOPIC OF SO MUCH POLITICAL RHETORIC THAT IT HAS LOST MUCH OF ITS MEANING. THE REAL TRUTH OF THIS LIST IS THAT AW GROUPS AROUND THE WORLD WORK THESE PAINFUL ISSUES OF RACE, CLASS, ENVY, ETC. INTO THEIR MESSAGING, AND IF WE CANNOT BRING OURSELVES TO USE THEM IN OUR RESPONSE ON BEHALF OF WCIV, OUR CHANCE OF SURVIVAL WILL BE GREATLY DIMINISHED.

LET'S TAKE A LOOK AT RAPE. FOR MUCH OF OUR HISTORY IT WAS RARELY REPORTED AND EVEN LESS PROSECUTED, AS IT CHALLENGED THE SEX AND GENDER CODES OF OUR PAST. TODAY IT IS PRINT/BROADCAST TOP STORY MATERIAL IN THE US, AND IN EUROPE HAS BECOME SO EXTENSIVE THAT ENFORCEMENT AND PROSECUTION EFFORTS ARE SERIOUSLY COMPROMISED.

SO FAR, THERE ARE STILL IMPORTANT POLITICAL, SOCIAL AND LEGAL DIFFERENCES BETWEEN THE US AND EUROPE IN THEIR RESPONSES TO THE INCREASE IN RAPE IN THEIR SOCIETIES, BUT THEY HAVE ONE THING IN COMMON — RAPE AS AN EXPRESSION AND AGENT OF CULTURE.

CONTEMPORARY SOCIOLOGISTS AND PSYCHOLOGISTS VIEW RAPE AS A CRIME OF POWER, AS IT MAY WELL BE. BUT IN ITS WIDESPREAD OCCURRENCE TODAY IT IS ALSO A VERY EVIDENT FORM OF CULTURAL CHANGE WHICH, AS WE HAVE NOTED BEFORE, IS SUBJECT TO HUMAN AGENCY.

THROUGHOUT THE COURSE OF HUMAN DEVELOPMENT THESE TWO ELEMENTS — OUR CHANGE AND OUR AGENCY — HAVE OFTEN BEEN INSEPARABLE AND HAVE MOVED OUR DEVELOPMENT IN DIRECTIONS THAT ARE INFLUENCED BY HUMAN CONSIDERATIONS SUCH AS ETHICS, MORALITY LEGALITY AND COMMONALITY.

THESE ARE POWERFUL HUMAN MECHANISMS WHICH WE, AND WCIV, IN THE PAST COULD DISCUSS AND PURSUE TO ENERGIZE OUR PROGRESS, BUT TODAY IN OUR PUBLIC LIFE THEY ARE SEEN AS RELICS MORE THAN GUIDES. THEY HAVE BEEN HIJACKED BY OUR OWN INSTITUTIONS AND LEADERS, GIVEN A HEAVY COAT OF PAINT, NEW NAMES AND CLOTHES AND MOVE OUR VIEWS OF OUR CONSTITUTION, OUR GOVERNMENT AND OUR OWN RELATION TO BOTH IN UNFAMILIAR DIRECTIONS.

THERE HAS BEEN NOTHING MORE IMPORTANT IN THE LEFTIST AW POLITICS OF OUR POSTWAR ERA THAN ITS PERSISTENT PUSH HERE AND IN EUROPE TO DISCREDIT AND DIMINISH WCIV CULTURE. ROTHERHAM AND MALMO ARE ONLY TWO EXAMPLES OF THE BROADER MORAL FAILURE AT THE HEART OF POLITICAL CORRECTNESS (PC). THERE ARE OTHERS HERE AND IN EUROPE THAT, LACKING MEDIA EXPOSURE, HAVE PASSED FROM THE PROLONGED PUBLIC SCRUTINY AND FOCUS REQUIRED TO BRING ABOUT EXPOSURE, TRIAL AND CONVICTION. ⁵

A CHOICE OF WEAPONS

THE AW HAS AN AMPLE SUPPLY OF WEAPONS AT ITS COMMAND. SOME WORK BETTER AT DIFFERENT TIMES AND PLACES THAN OTHERS, BUT MOST ARE EMPLOYED IN THE US AND ARE EASILY VISIBLE IF WE LOOK FOR THEM.

THE CURRENT AND, SADLY, MOST SUCCESSFUL HAS BEEN THE INTRODUCTION OF PC AS BOTH A GUIDE AND MEASUREMENT OF OUR POLITICAL SUCCESS AT EVERY LEVEL FROM LOCAL TO NATIONAL. PC, WHICH WAS INITIALLY IDENTIFIED BY KARL MARX IN 1921, WAS ORIGINALLY INTENDED TO ASSURE THAT MINORITY ELEMENTS COULD RECEIVE POLITICAL BENEFITS AND STATUS COMMENSURATE WITH THEIR POPULATION OR OTHER PRESENCE.

MULTICULTURALIST THINKING/PRACTICE GREATLY EXPANDED THE NUMBER AND VOICE OF MINORITIES AND IS BASICALLY A PROCESS OF DIVISION OF THE WHOLE AND MULTIPLICATION OF PARTS. UNDER IT THE PC CONCEPT WAS EXPANDED TO INCLUDE REPRESENTATION OF ALL MINORITIES, NOT JUST INDIVIDUAL NATIONALITIES, RACES, RELIGIONS, ETC. FOR THIS NEW SHAPE OF PC, LATINOS, ASIANS, AFRICANS AND OTHERS WERE PARTS OF A LARGER AND MORE POWERFUL GLOBAL UNDERTAKING, AND YET COULD BE ADDRESSED INDIVIDUALLY WHEN NECESSARY. AIDED BY OUR MSM, WHICH ENABLED GROWTH THAT MARX COULD NEVER HAVE ENVISIONED, PC THOUGHT SPREAD RAPIDLY THROUGHOUT THE POLITICAL SYSTEMS AND INSTITUTIONS OF THE WEST.

“IT WAS NOTHING LESS THAN A GAME-CHANGER.”

HOW AND WHY DID THIS HAPPEN? FIRST, THE NEW PC PROVIDED A RALLYING CRY FOR THE LL ON WHICH ITS MANY SHADES OF LIBERAL THOUGHT COULD AGREE AND COMBINE, PUTTING THEIR OFTEN SHARP BUT MINOR DIFFERENCES OUT OF SIGHT. ALTHOUGH UNITY AMONG THE LL IS NOT EASY TO ATTAIN AND USUALLY CAN ONLY BE HAMMERED OUT FOR NATIONAL ELECTIONS, PC CREATED AN OPPORTUNITY THAT BRIDGED THE ELECTORAL GAP. IT WAS A NEW WEAPON WITH A NEW MESSAGE AND METHODS. IT WAS NOTHING LESS THAN A GAME-CHANGER.

* * *

IN OUR EFFORTS TO UNDERSTAND THE CHANGES WE HAVE PERMITTED IN OUR CULTURE, WE MUST INCLUDE THE FOUNDING OF THE UN IN 1946 AND ITS SUBSEQUENT ADMISSION OF DOZENS OF SMALL, POOR, NON-WESTERN NATIONS, MANY OF WHICH HAD BEEN FORMER COLONIES OF EUROPEAN POWERS.

THE POWER STRUCTURE OF THE UN IS AN INTERESTING ONE. IN THE GENERAL ASSEMBLY EACH MEMBER HAS ONE VOTE, BUT THE REAL POWER RESTS IN THE SECURITY COUNCIL, COMPOSED OF FIVE PERMANENT MEMBERS AND 10 OTHERS WHO SERVE ON A TWO-YEAR ROTATING BASIS. GIVEN ITS COMPOSITION AND THE COMPLEXITY OF OUR TIME, THE UN HAS BEEN TOO UNWIELDY TO ACT AS A FORCE OF

GLOBAL GOVERNMENT, BUT IT HAS BEEN ABLE TO FOCUS OPINION AND SUPPORT ON ISSUES IN WAYS THAT ENCOURAGE DISCUSSION AND DEFUSE HOSTILITIES. THE PRICE TO ITS MEMBERSHIP FOR ITS MIXED RESULTS HAS BEEN EXCEPTIONALLY HIGH INSTITUTIONAL COSTS AND CORRUPTION.

IT HAS, HOWEVER, SERVED ANOTHER PURPOSE QUITE WELL. IN OUR AGE OF INCREASING INSISTENCE ON VISIBILITY THE UN HAS CONDUCTED OPEN DEBATE ON MANY WORLD ISSUES. IT HAS GIVEN DIPLOMACY A WORLD CENTER WHERE IT IS CONDUCTED 24/7, AND IT ALSO PROVIDES THE STAGE WHERE ISSUES OF URGENCY CAN BE PRESENTED TO THE WORLD. HAD NOT WW II'S LEADERS JOINED TOGETHER TO CREATE THE UN, THE TECHNOLOGY THAT FOLLOWED WOULD HAVE BROUGHT SOMETHING VERY SIMILAR TO IT INTO BEING.

ANOTHER BENEFIT, PERHAPS MOSTLY PSYCHOLOGICAL, IS THAT REGARDLESS OF ITS CORRUPTION AND INEFFICIENCIES IT SERVES AS A SYMBOL OF WORLD UNITY AND AUTHORITY TO WHICH ALL COUNTRIES, NO MATTER HOW SMALL OR IMPOVERISHED, CAN APPEAL AND BE HEARD. WHILE THE SUBSEQUENT PROCESS OF RESOLUTION WITHIN THE UN BUREAUCRACY MAY BE LENGTHY AND DIFFICULT, THE SYMBOLIC VALUE OF A WORLD AUTHORITY ACCESSIBLE TO ALL HAS WIDE ACCEPTANCE.

* * *

IN THE COURSE OF ITS WAR ON WCIV, THE AW MOVEMENT EMPLOYS A VARIETY OF OTHER WEAPONS BESIDES PC WHICH ARE EVIDENT IN ITS ACTIVITIES IN AMERICA, BUT HAVE DRAWN LITTLE NOTICE OR COMMENT FROM OUR POLITICAL LEADERSHIP. A COMMON PRACTICE IS TO WRAP ITS MESSAGE IN LOFTY LANGUAGE THAT GIVES THE IMPRESSION OF WIDE LEGAL, MORAL, POPULAR AND ETHICAL SUPPORT. OFTEN SUCH LANGUAGE IS DRAWN FROM MANIFESTOES OR PURPOSE STATEMENTS OF "FRONT" ORGANIZATIONS SUCH AS THOSE RECENTLY ESTABLISHED BY GEORGE SOROS⁶ IN EASTERN EUROPE AND THE BALKANS.

THE AW'S USE OF LANGUAGE GOES BEYOND ITS POLITICAL MESSAGES. IT REGULARLY TIES ITS ACTIVITIES ON BEHALF OF IMMIGRANTS OR OTHER GROUPS TO HUMAN CHARITY VALUES ESPOUSED BY CHRISTIANS AND MUSLIMS ALIKE. AND, SIMILARLY, THE ACCUSATION OR IMPLICATION OF GUILT IS AN EFFECTIVE TOOL IN WEARING DOWN RESISTANCE AND SECURING COOPERATION. AGAIN, GUILT IS PRESENTED AS A FORM OF HUMAN FAILURE.

THESE TACTICS AND MESSAGES ARE AT WORK THROUGHOUT OUR WCIV. THEY ARE IN PLAIN SIGHT FOR ALL TO SEE, HEAR AND FEEL, AND ARE AMPLIFIED FAR BEYOND THEIR ORIGINAL FORM AND REACH BY OUR MSM. AND YET NO ONE RISES IN CONGRESS TO WARN FELLOW MEMBERS OR THE PUBLIC OF THE POLITICAL PERIL AND CULTURAL LOSS THAT WILL OCCUR IF WE DO NOTHING AND ALLOW THE AW FORCES TO HAVE THEIR WAY. WHY ?

THE COMPLEXITY OF COMPLICITY

TO A LARGE DEGREE WE ARE COMPLICIT IN THE FATE THAT WOULD HAVE SEEMED IMPOSSIBLE A CENTURY, OR EVEN A HALF CENTURY, AGO. THERE IS NO PATRICK HENRY, NO FDR, NO REAGAN TO CALL OUR ATTENTION TO THE DANGER THAT AWAITS US AND THE SEVERE CULTURAL DAMAGE THAT WILL ACCOMPANY IT IF WE CONTINUE TO DO NOTHING. THE AWFUL TRUTH IS THAT OUR INACTION IS COMPLICIT IN A FATE AGAINST WCIV PLANNED AND PURSUED BY ITS ENEMIES.

"IF WE DO NOTHING NOW, WE WILL LOSE ALL."

THIS IS A TRULY INCREDIBLE OUTCOME FOR A COUNTRY THAT FOUGHT THE WORLD'S MOST UNIQUE REVOLUTION, SURVIVED AN EXTREMELY BITTER CIVIL WAR AND THEN WITHIN THE SPAN OF A GENERATION, TWICE SAVED THE NATIONS OF EUROPE FROM GERMAN MILITARY CONQUEST, POLITICAL DOMINATION AND THE LOSS OF THEIR SOVEREIGNTY. WHAT BOGGLES THE MIND IS THAT OF THESE WARS NONE WAS FOUGHT FOR TERRITORIAL, RELIGIOUS OR COMMERCIAL EXPANSION. THEY WERE FOUGHT FOR IDENTITY, CULTURE AND VALUES THAT WE HAD ACQUIRED FROM TWO THOUSAND YEARS OF WCIV'S DEVELOPMENT. IF WE DO NOTHING NOW, WE WILL LOSE ALL.

OUR INABILITY TO CONFRONT THIS IMMEDIATE THREAT IS LARGELY THE RESULT OF THE CHANGED ROLE OF CONGRESS OVER THE PAST HALF CENTURY, FOR RATHER THAN CREATING LEGISLATION THAT REFLECTS OUR PRINCIPLES IT BECAME CAPTIVE TO ITS REPRESENTATIONAL FUNCTION. CAUGHT UP IN THE WEALTH/ PROSPERITY OF OUR POSTWAR GLOBAL DOMINANCE, CONGRESS INCREASINGLY VIEWED REPRESENTATION AS A DOLLAR-DIRECTED DUTY TO MAKE FEDERAL FUNDS AVAILABLE TO SPECIAL INTERESTS IN THE COMMERCIAL SECTOR AND TO PROJECTS IN THEIR HOME STATES.

THE CONCEPT OF CONGRESSIONAL SERVICE AS A TWO-WAY CONDUIT OF OPINION BETWEEN GOVERNMENT AND ITS CITIZENS WAS OVERWHELMED BY CONGRESS' NEED TO KEEP PACE WITH THE MONEY, TECHNOLOGY AND MEDIA DEMANDS OF OUR TIME. USUALLY AROUND ELECTION TIME WE CAN PICK UP REFERENCES IN CONGRESS TO "WHAT THE AMERICAN PEOPLE EXPECT", BUT EVEN THESE RESULTS ARE AS MUCH, IF NOT MORE, DETERMINED BY POLLS AND SATURATION TV ADVERTISING THAN MEANINGFUL DEBATES OR POLICY POSITION SPEECHES BY CANDIDATES.

WE HAVE PUT OURSELVES IN A VERY DANGEROUS POSITION IN WHICH THE ENERGIES OF OUR ELECTED REPRESENTATIVES AND MANY OF OUR INSTITUTIONS ARE MOVED BY IDEOLOGY RATHER THAN THE GOAL OF MAINTAINING THE PRINCIPLED GOVERNMENT ESTABLISHED IN OUR CONSTITUTION. DURING THE YEARS OF SUCH A 180° REVERSAL MANY ACTIONS AND ELEMENTS COMBINE TO FURTHER THE PROCESS, BUT NONE MORE EVIDENT OR CONSISTENT THAN THE FACT THAT "IDEOLOGY PAYS; GOVERNMENT DOESN'T".

THIS SUBVERSION OF OUR POLITICAL PROCESS HAS HAD

A GENERAL EFFECT OF DIMINISHING OUR RESPECT FOR OUR NATIONAL AND LOCAL LAWS, AND MORE SPECIFICALLY IN CONGRESS' PRESENT ACCEPTANCE OF SELECTIVE ENFORCEMENT OF EXISTING LAW, EVIDENT IN IMMIGRATION, VOTING PRACTICES AND IRS ISSUES. THESE FAILURES ARE EXCUSED BY MANY IN AND OUT OF GOVERNMENT BECAUSE THEY VIEW OUR LAWS AS BEING MALLEABLE TARGETS OF MANIPULATION, RATHER THAN A FIRM FRAME THAT SUPPORTS GOVERNMENT AND PROTECTS AGAINST THE EXCEPTIONALLY GENEROUS PROMISES OF OUR DEMOCRACY.

BUT, "THE MONEY TRAIL" IS NOT THE ONLY THREAT TO OUR TRADITIONAL GOVERNMENT IMPOSED BY IDEOLOGICAL CONTROL. IT IS ALSO AN ENABLER OF PC IN BOTH SUBTLE AND OBVIOUS FORMS. REGARDLESS OF ITS MARXIST ORIGIN AND MC ENDORSEMENT, MILLIONS OF AMERICANS ACCEPTED PC IDEOLOGY'S CONTRADICTIONS OF OUR POLITICAL CULTURE.

PC IS BOTH AN ACTIVE AND PASSIVE WEAPON AND CAN BE USED BY EITHER TAKING ACTION OR BY TAKING NO ACTION. IN ROTHERHAM, MALMO AND OTHER EUROPEAN COMMUNITIES THE CHOICE OF NO ACTION WAS AN IMMORAL ONE WITH DISASTROUS CONSEQUENCES FOR ITS VICTIMS AND THE PUBLIC AT LARGE.

ARE WE TO SAY THAT AMERICANS' EMBRACE OF PC WILL NOT PRODUCE SIMILAR FAILURES AND RESULTS ? WE WOULD LIKE TO THINK NOT, BUT AS OUR SCALE IS FAR LARGER THAN ENGLAND'S OR SWEDEN'S, IT MAY ONLY BE A MATTER OF TIME BEFORE A SIMILAR ERROR IS REVEALED HERE. AS IN ROTHERHAM AND MALMO, WE CAN BE ASSURED THE MSM WILL DO ALL IT CAN TO AVOID OR MINIMIZE COVERAGE, ALTHOUGH WE HAVE HAD A POWERFUL TRADITION OF INVESTIGATIVE REPORTING THROUGHOUT OUR HISTORY WHICH COULD BE REVIVED AND BROUGHT TO BEAR.

WHETHER SOME INDIVIDUAL CIRCUMSTANCE IGNITES A PUBLIC RESPONSE IS NOT THE MAIN POINT. THE LARGER ISSUE IS THAT PC, BY WRAPPING ITSELF IN HUMANITARIAN LANGUAGE AND PURPOSE, IS A HIGHLY EFFECTIVE POLITICAL WEAPON THAT IS ANTITHETICAL TO WCIV AND IS BEING USED GLOBALLY TO CAUSE ITS DEMISE.

GATHERING STRINGS

AMERICA HAS BEEN EXTREMELY FORTUNATE — IN ITS ORIGINS, IN ITS VALUES, IN ITS SUCCESSES AND EVEN SOME OF ITS FAILURES, IN ITS NATURAL RESOURCES AND ABUNDANCE, IN THE INDUSTRY AND GENEROSITY OF ITS PEOPLE, IN ITS FREEDOM AND RESILIENCE, IN OUR VIEW OF HONOR AND DUTY AND OUR STEADFAST BELIEF IN GOVERNMENT BOTH AS PROTECTOR AND INSTRUMENT OF ITS CITIZENS.

SOME OF THESE ARE VIEWED AS GOD-GIVEN; OTHERS AS THE PRODUCT OF OUR WCIV. WHICHEVER, WE ARE THEIR INHERITORS AND THEIR STEWARDS — CHARGED BY HISTORY TO KEEP THEM SAFE AND PASS THEM ON TO OUR PROGENY. AT THIS MOMENT, UNLIKE ANY WE HAVE KNOWN BEFORE, WE MUST ASK OURSELVES NOT ONLY HOW DO WE DO THIS, BUT ALSO WHO AND WHAT WILL DEFINE OUR PROGENY AND THE WORLD IN WHICH THEY WILL LIVE.

"UNLIKE ANY WE HAVE KNOWN BEFORE" IS A SWEEPING STATEMENT THAT INCLUDES MUCH OF OUR PAST HISTORY. WHY DO WE USE IT ? FIRST, BECAUSE MANY OF OUR CITIZENS AND LEADERS

HAVE FALLEN PREY TO PC AS THEIR EUROPEAN COUNTERPARTS HAVE. THE MOST SHOCKING AND EGREGIOUS EXAMPLE OF THIS, IF WE FACE IT, IS THE LACK OF NATIONAL UNITY, ESPECIALLY AT OUR LEADERSHIP LEVEL, WHICH WOULD ENABLE US TO MOUNT A CREDIBLE DEFENSE OF OUR CULTURE AND PRINCIPLES. THE KIND OF UNITY WITH WHICH WE INSTANTLY RESPONDED TO ATTACKS UPON US IN 1917 AND 1941 IS NOWHERE TO BE SEEN IN OUR CONTEMPORARY AMERICA. EVEN WORSE, OUR LEADERS TAKE POLITICAL REFUGE IN PC AND AVOID EVEN ANY MENTION OF THE FORCES, BOTH INTERNAL AND EXTERNAL, THAT OPPOSE OUR CULTURE AND VALUES AND SEEK TO CONVERT THEM TO THEIR OWN PURPOSE AND TO USE THEM AGAINST US.

UNITY CANNOT BE CREATED OUT OF THIN AIR. IT MUST RELATE TO SHARED EXPERIENCES AND/OR GOALS. IT TRANSCENDS SUCH DEMARCATIONS AS REPUBLICAN/DEMOCRAT, CONSERVATIVE/LIBERAL, LABOR/CAPITAL, AGRICULTURAL/INDUSTRIAL, RICH/POOR, ETC. WHICH POLITICIANS EMPLOY TO SECURE SUPPORT AT THOSE MAGICAL DEMOCRATIC MOMENTS WHEN VOTES ARE CAST THROUGHOUT AMERICA.

THE POLITICIAN WHO WOULD USE HIS/HER CAMPAIGN TO ALERT VOTERS TO THE PERILS THAT OUR COUNTRY AND WCIV NOW FACE WOULD BE TAKING AN ENORMOUS RISK, AS ANY EFFORT TO INTRODUCE A NEW, HIGHLY CONTROVERSIAL ISSUE AND GAIN BACKING FOR IT, WOULD BE MET WITH DENIAL, CRITICISM AND RIDICULE. PUNDITS AND POLLS FROM THE MSM COULD BE COUNTED ON TO PROVIDE ADDITIONAL ADVERSARIAL ENERGY. ADMITTEDLY, ANY CANDIDATE CONCERNED AND COURAGEOUS ENOUGH TO CITE THE THREATS THAT CONFRONT US AND TO ASK FOR THE NATIONAL UNITY NEEDED TO OPPOSE THEM WOULD SURELY RECOGNIZE THAT THE ODDS AGAINST MIGHT BE INSURMOUNTABLE.

AND YET, THERE IS THE POSSIBILITY THAT BENEATH THE CORRUPTION, GREED AND DISHONESTY THAT NOW OVERLIES OUR GOVERNMENT AND ITS OPERATION THERE ARE TRACES OF WHAT WE WERE IN FINER MOMENTS AND BETTER TIMES THAT WE CAN CALL UPON TO GUIDE US IN RECLAIMING OUR UNITY AND PATRIOTISM.

SUCH A POSSIBILITY CAN PROBABLY ONLY OCCUR VIA OUR ELECTRONIC, ONLINE COMMUNICATION CAPABILITY. IT, AND ONLY IT, COULD PROVIDE A WAY TO CIRCUMVENT THE MSM AND TO DEVELOP A WIDE AND ENTHUSIASTIC CONSTITUENCY WITHIN REASONABLE TIME AND MONEY LIMITS. IS THERE A CANDIDATE WHO MIGHT CONSIDER SUCH AN EFFORT WITH EVERY RISK IN FULL VIEW AND SAY TO HIMSELF, "I'LL GIVE IT A TRY. WIN OR LOSE, IT'S WORTH IT." ?

THE WORK AHEAD FOR THIS KIND OF OPERATION CANNOT BE DONE BY ONE MAN ON A WHITE HORSE RIDING INTO THE SUNSET. IF IT IS TO SUCCEED, IT WILL REQUIRE THE SAME CONTINUOUS PROCESS OF MEETINGS, SPEECHES, PHOTO-OPS, FUNDING EVENTS, MEDIA INTERVIEWS, ETC. AS ANY OTHER CAMPAIGN. BUT BEFORE ALL THOSE BEGIN IT MUST HAVE A STARTING POINT — ONE PERSON TO STEP FORWARD AND SAY "THIS MUST BE DONE, I WILL GIVE WHATEVER I CAN TO MAKE IT HAPPEN."

THE CLASSIC EXAMPLE FOR THIS START FROM NOTHING, GROUND UP, KIND OF MOVEMENT WAS CITIZENS FOR EISENHOWER FOUNDED IN 1951 BY TWO RETURNED AIR FORCE OFFICERS⁷ DISCOURAGED BY THE POLITICAL STATE OF THE COUNTRY. THEY WERE ABLE TO ATTRACT YOUNG VOTERS IN LARGE NUMBERS WHICH

PLAYED A KEY ROLE IN PERSUADING GEN. EISENHOWER TO RUN AND THE REPUBLICAN PARTY TO ACCEPT AND SPONSOR HIM.

THEN, AS NOW, THE PROBLEM(S) HAD TO BE CLEARLY PROJECTED AND A CENTRAL, FOUNDING FIGURE IDENTIFIED AROUND WHICH AN ORGANIZATION OF MANY PARTS AND ENERGIES COULD BE FORMED.

* * *

THERE IS ANOTHER ASPECT OF COMPLICITY WE SHOULD ENGAGE. OUR COUNTRY HAS OPERATED UNDER A TWO-PARTY SYSTEM SINCE ITS EARLIEST DAYS. ON OCCASION A PARTY HAS FOUND SUFFICIENT DISFAVOR WITH VOTERS TO LOSE THEIR SUPPORT AND THAT OF ITS BACKERS. IT IS THEN REPLACED BY A NEW ENTITY WITH A NEW NAME. OVER TIME, THE LABELS HAVE CHANGED, BUT THE TWO-PARTY SYSTEM HAS REMAINED IN PLACE. WHAT PLAGUES OUR POLITICS NOW IS NOT THE SYSTEM; IT IS WHAT THE TWO PARTIES HAVE BECOME.

OUR ELECTORAL STRUCTURE IS ONE OF NUMEROUS LOCAL/ STATE/FEDERAL CONFLICTS WHICH INVITES ABUSE, AND, BECAUSE OF ITS UNWIELDY NATURE, HAS NOT BEEN ABLE TO KEEP PACE WITH THE VERY RAPID TECHNOLOGICAL ADVANCES OF OUR TIME. THESE STRUCTURAL PROBLEMS HAVE LIMITED ANY IMPROVEMENTS IN OUR ELECTORAL PROCESS TO WHAT AMOUNTS TO TWEAKING AT THE EDGES. WE ARE LEFT WITH ARCHAIC RULES OR PRACTICES THAT NEITHER PARTY RISKS CHANGING BECAUSE OF THE FEAR OF LOSING SOME OF ITS POWER.

THE RESULT IS THAT FROM LOCAL ELECTIONS AT THE BOTTOM OF THE PROCESS TO THE ELECTORAL COLLEGE AT THE TOP, THERE ARE INEFFICIENCIES AND INEQUITIES AND TOO MANY SPACES WHERE THE INFLUENCE OF LARGE AMOUNTS OF "SPECIAL INTERESTS" MONEY CAN BE APPLIED.

THIS IS AN AREA OF GOVERNMENT WHERE AN INQUIRY, REPORT AND RECOMMENDATIONS BY A PRESIDENTIAL COMMISSION COULD BE USEFUL. IT COULD BRING THE TOPIC TO THE PUBLIC'S ATTENTION AND PUT A SPOTLIGHT ON SOME OF ITS PROPOSED REMEDIES. UNFORTUNATELY, LIKE MOST PRESIDENTIAL COMMISSIONS, IT WOULD PROBABLY SLIP QUIETLY INTO HISTORY, BUT SOME, LIKE THE 9/11 AND JORDAN COMMISSIONS⁸ DEVELOP AFTER-LIVES AND ARE SEEN AS HELPFUL ENDEAVORS, ALTHOUGH THEIR MOMENTS OF POLITICAL IMPACT HAVE PASSED.

. . . . AND WEAVING A LIFELINE

IN EUROPE, WE SEE ITS AND OUR CIVILIZATION UNDER RELENTLESS ATTACK FROM CULTURES OTHER THAN OUR OWN. THE ELECTED LEADERS OF THE NATIONS GATHERED IN THE EU HAVE THE POWER IN THEIR OWN COUNTRIES AND THROUGH THE EU TO TAKE COUNTER MEASURES, TO CONSTRUCT A STRONG DEFENSE AGAINST THE DESTABILIZING MOVE OF ISLAMIC MIGRANTS THAT HAS ALREADY ALTERED THEIR POPULATIONS, THEIR POLITICS AND THE SOCIETIES IN WHICH THEY EXIST. THESE SOCIETIES, THE PRODUCT OF MORE THAN TWO THOUSAND YEARS OF CIVILIZATIONAL DEVELOPMENT, HAVE CHANGED DRAMATICALLY FROM THEIR FORM

AND CHARACTER OF A HALF CENTURY AGO, AND ARE ON A PATH OF INCREASING DIVERGENCE.

THIS TRANSFORMATION OF WESTERN EUROPE COULD NOT HAVE OCCURRED WITHOUT THE COMPLIANCE OF ITS MEMBER STATES WHOSE LEADERS, THROUGH WHAT APPEARS TO BE A COMBINATION OF IGNORANCE AND CULTURAL COWARDICE, HAVE NOT OPPOSED THE EXISTENTIAL THREATS THAT TARGET WCIV.

WE HAVE REPORTED ON WHAT HAS TAKEN PLACE IN ENGLAND, SWEDEN, GERMANY AND THE NETHERLANDS. THERE IS NO REASON TO THINK THAT THESE COUNTRIES AND THE COMMUNITIES WITHIN THEM ARE UNIQUE. THEY ARE NOT. THERE ARE OTHERS, MANY OTHERS, INCLUDING FRANCE, NORWAY AND HUNGARY. NOT SURPRISINGLY, PERHAPS, THE MOST DETERMINED RESISTANCE CAN BE FOUND IN HISTORICALLY INDEPENDENT, ALPINE SWITZERLAND.

“...AS THE REALIGNMENT OF RELIGION, POLITICS, ECONOMICS AND TECHNOLOGY IN OUR ERA WILL HAVE CONSEQUENCES FOR ALL.”

ISLAM IS NOT THE ONLY FORCE AT WORK IN AGITATING FOR A DIFFERENT EUROPE. ALONG WITH THE MILLIONS OF MOSTLY MUSLIM MIGRANTS THAT HAVE ARRIVED, AND CONTINUE TO ARRIVE, IN EUROPE THERE IS A BODY OF THOUGHT THROUGHOUT THE GLOBE, AND ESPECIALLY THE THIRD WORLD, THAT VIEWS WCIV AS AN ARCHAIC, WEALTHY ENTITY WHOSE TIME HAS COME AND GONE; AND THAT SHOULD NOW BE DISMANTLED TO GIVE WAY TO THE NEW GLOBAL POLITICS, POPULATIONS AND ECONOMIES OF THE 21ST CENTURY. WE HAVE USED THE WORD "EXISTENTIAL" IN ITS STRONGEST SENSE, AS THE REALIGNMENT OF RELIGION, POLITICS, ECONOMICS AND TECHNOLOGY IN OUR ERA WILL HAVE CONSEQUENCES FOR ALL.

* * *

JUST AS THERE ARE WIDESPREAD, UNREPORTED INCIDENTS OF AW VIOLENCE IN EUROPE, THERE IS NO REASON TO BELIEVE THAT THEY CANNOT OR DO NOT EXIST HERE. WE MAY BE DIFFERENT AND SEPARATED FROM THE PUBLIC FAILURES IN EUROPE, BUT WE ARE NOT EXEMPT FROM THEM. ALTHOUGH MANY OF OUR INSTITUTIONS ARE JOINED BY OUR COMMON PAST, THEY MUST OFTEN BE DEFENDED BY EFFORTS THAT START WITH INDIVIDUALS.

IN AMERICA, UNFORTUNATELY, THERE ARE TWO WIDELY HELD ATTITUDES THAT ACT AGAINST OUR RESPONDING TO THREATS IN A PROMPT AND DETERMINED MANNER. ONE IS OUR AMERICAN EXCEPTIONALISM AND THE OTHER DERIVES FROM OUR POSTWAR SUPER STATUS IN POWER/WEALTH/POLITICS.

AIDING THIS MODERN COMBINATION, FOR TWO CENTURIES OUR FOREIGN RELATIONS WERE BASED ON A BELIEF, RESULTING FROM THE PROTECTION AFFORDED BY THE OCEANS ON OUR EASTERN AND WESTERN COASTS, THAT "IT CAN'T HAPPEN HERE". THIS SHIELD TOOK HARD HITS WHEN KHRUSHCHEV ATTEMPTED TO ESTABLISH A MISSILE BASE IN CUBA IN 1963 AND WHEN ISLAMIC TERRORISTS STRUCK THE WORLD TRADE CENTER IN 2001, BUT IT HAS NEVER BEEN ENTIRELY REMOVED FROM OUR WAY OF THINKING.

THE TRUTH IS THAT BOTH IN LARGE SCALE PUBLIC AND SMALLER SCALE PERSONAL WAYS WE ARE ENGAGING IN THE SAME KIND OF CULTURAL COWARDICE WHICH WE HAVE NOTED IN EUROPE. ON THE LARGE SCALE WE CAN OBSERVE HOW OUR OWN LEGAL AND POLITICAL SYSTEMS CAN DEFER TO THE INTERESTS, ALSO DEEMED "RIGHTS", OF ILLEGAL ALIENS CHARGED AND/OR CONVICTED OF SERIOUS CRIMES. MANY JURISDICTIONS/COMMUNITIES HAVE DECLARED THEMSELVES TO BE SANCTUARIES FOR ILLEGAL IMMIGRANTS WHERE THEY CAN LIVE AND WORK SAFE FROM THE REACH OF OUR FEDERAL IMMIGRATION LAWS. THIS VIEW SUGGESTS THAT THE ACTIONS OF LOCAL POLITICIANS AND THEIR LAWS CAN SERVE AS REFERENDUMS ON FEDERAL LAW, A POSITION FOR WHICH THERE IS NO EVIDENCE IN OUR CONSTITUTION.

THE POLITICIANS WHO BACK SANCTUARY LAWS DO SO TO KEEP THE SUPPORT OF THEIR LARGE IMMIGRANT POPULATIONS IN THEIR COMMUNITIES, AND HAVE CONTRIVED THE ARGUMENT THAT THEIR COOPERATION WITH POLICE IN CRIMINAL INVESTIGATIONS WILL VANISH IF FEDERAL LAW IS ENFORCED. THIS CLAIM IS BLOWN UP BEYOND ITS TRUE PROPORTION. THERE ARE MANY OTHER EFFECTIVE WAYS TO PRACTICE COMMUNITY POLICING.

NOT SURPRISINGLY, CALIFORNIA (CA), WHICH BOASTS THE LARGEST POPULATION (BOTH NATIVE AND IMMIGRANT) AND STATE ECONOMY IN THE COUNTRY, IS AT THE CENTER OF THIS ARGUMENT.

OTHER STATES INCLUDING IL AND CT, AS WELL AS CITIES SUCH AS CHICAGO, NYC AND BOSTON, HAVE FOLLOWED WITH THE RESULT THAT WE NOW HAVE A GENUINE CONSTITUTIONAL ISSUE WHICH WILL ALMOST CERTAINLY WORK ITS WAY UP TO THE SUPREME COURT. BUT THIS IS A HIGHLY EMOTIONAL TOPIC WITH POWERFUL BACKERS OF EACH SIDE. NO MATTER WHAT A COURT DECISION MAY AFFIRM, ITS IMPLEMENTATION COULD BE DIFFICULT BECAUSE THE LANGUAGE AND INTENT OF OUR LEGAL/POLITICAL SYSTEMS AND THE AUTHORITIES THAT ADMINISTER THEM HAVE BEEN TURNED INWARD TO LOCAL PURPOSES RATHER THAN THOSE OF THE WIDER PUBLIC FOR WHOSE BENEFIT THEY WERE INTENDED.

* * *

DESPITE THE ENORMOUS DISTORTION TAKING PLACE IN OUR GOVERNMENTAL SYSTEMS AND STRUCTURE, IT IS AT THE PERSONAL SCALE WHERE AMERICANS AND THEIR CULTURE HAVE BEEN MOST MANIPULATED AND WHERE THE MOST DAMAGE HAS BEEN DONE. THIS DAMAGE MUST BE REPAIRED, IF WE ARE TO AVOID FOLLOWING EUROPE'S PATH AND FATE.

TO SUCCEED IN SAVING OUR WCIV AND OUR COUNTRY, WE MUST FIRST RECOGNIZE OUR ENEMY AND THEN TAKE BROAD AND NEW ACTION TO REVERSE THE TREND OF THE LAST HALF CENTURY. THESE NEW ACTIONS AND ATTITUDES WILL BE UNCOMFORTABLE AT FIRST, BUT, AS WE BECOME FAMILIAR WITH THEM, WE WILL BE REMINDED THAT THEY WERE AN IMPORTANT PART OF OUR CULTURE FOR ITS FIRST 150 YEARS UNTIL THEY CAME UNDER ATTACK BY AW FORCES DURING THE SOCIO-POLITICAL TURMOIL OF THE

GENERATION FOLLOWING WW II.

ONE SUCH FORCE, LESS PUBLICLY AND MORE QUIETLY AT WORK, WAS THE POLITICIZATION OF THE CURRICULA, THE TEACHING AND THE ADMINISTRATION IN OUR EDUCATIONAL SYSTEM. THIS WAS AN EXTENSION OF LL, AND SOMETIMES MARXIST, OPINION AND PURPOSE. IT WAS APPLIED IN VARIOUS WAYS OFTEN COMMENCING IN THE ELEMENTARY YEARS AND CONTINUING THROUGH OUR COLLEGES AND UNIVERSITIES WHERE PC HAS BECOME A GUIDING PRINCIPLE OF CAMPUS LIFE FOR STUDENTS, FACULTY, ADMINISTRATORS AND BOARDS OF DIRECTORS OR TRUSTEES.

* * *

THE FREEDOMS EXPRESSED IN THE UN CHARTER AND CONSTANTLY REPEATED BY POLITICAL LEADERS THROUGHOUT THE WORLD GAVE HOPE AND STRENGTH TO MANY MOSTLY AFRICAN AND ASIAN GREAT-POWER COLONIES TO PRESS FOR THEIR FREEDOM. THE RESULTING PROCESS OF DECOLONIZATION GAINED MOMENTUM AND PROCEEDED TO CHANGE THE WORLD'S POLITICAL, SOCIAL AND ECONOMIC POWER MAPS. THIS PATH TO INDEPENDENCE COULD BE PEACEFUL OR VIOLENT, RESISTED OR COOPERATIVE, BUT IT COULD NOT BE STOPPED. BY THE TIME IT HAD RUN ITS COURSE, MEMBERSHIP IN THE UN HAD GROWN FROM ITS 50 ORIGINAL MEMBERS TO ITS PRESENT 193.

FINALLY, DURING THE TIME OF THIS CULTURAL AND POLITICAL VOLATILITY WORLD COMMUNISM, ACTING THROUGH RUSSIA AND/OR CHINA, KEPT UP ITS PRESSURE ON THE WESTERN DEMOCRACIES IN EUROPE AND OUR HEMISPHERE. FOR YEARS, THIS PRESSURE WAS EXERTED THROUGH "THE COLD WAR", A HALF CENTURY LONG, VIOLENT, GLOBAL CHESS GAME BETWEEN EAST AND WEST DURING WHICH COMMUNISM'S AW EFFORT GAINED GROUND IN THE UN, IN EDUCATIONAL POLITICIZATION AND IN THE DECOLONIZATION MOVEMENT.

"HISTORY DOES NOT WORK THAT WAY."

OUR COUNTRY IS IN DEEP TROUBLE WITH LONG LASTING CONSEQUENCES AHEAD IF IT DOES NOT TAKE ACTION. IT CAN NO LONGER AFFORD AN "IT CAN'T HAPPEN HERE" ATTITUDE, NOR THE BELIEF THAT SOME DIVINE GIFT OF INTELLIGENCE OR GENETIC PRESENCE WILL ENABLE US TO COMFORTABLY REPEL ATTACKS AND MAINTAIN OUR PRESENT POWER. HISTORY DOES NOT WORK THAT WAY.

WE MUST REDECLARE OUR INDEPENDENCE, THIS TIME FROM THE RESTRICTIONS ON OUR THOUGHT AND ACTIONS THAT WE HAVE ALLOWED MC/PC TO IMPOSE ON US. IN DOING SO, WE MUST BREAK THEIR CONTROLLING GRIP ON OUR LANGUAGE; WE MUST BRING OURSELVES TO USE WORDS AND PHRASES THAT THE PC LANGUAGE POLICE HAVE BANISHED — NOT IN MEANNESS, BUT FRANKLY AND FACTUALLY AS THEY WERE INTENDED. AND WE MUST TAKE A STRONGER AND MORE ACTIVE ROLE IN ALERTING EUROPE TO THE DANGERS FACING WCIV AND ITS NEED TO DEFEND ITSELF.

SUCH A ROLE WILL HAVE ITS CONSEQUENCES. WE WILL BE ROUNDLY CRITICIZED AND TOLD TO MIND OUR OWN BUSINESS. BUT WCIV IS OUR BUSINESS, AS IT ALSO IS EUROPE’S. THE POPULATION, POLITICAL AND CULTURAL CHANGES OF THE LAST HALF CENTURY WILL ONLY INCREASE IF NO ACTION IS TAKEN. WCIV IS UNDER ATTACK THAT IS AS DEADLY AS THOSE OF ITS TWO RECENT WORLD WARS FROM WHICH IT DIFFERS IN TWO IMPORTANT WAYS. THIS CULTURAL WAR IS NOT A MILITARY ONE THAT WILL BE DECIDED BY ARMAMENTS AND BATTLES; IT IS ONE OF CULTURE AND OF HUMAN VALUES, WILL AND POWER. AND IT IS ONE THAT EUROPE MUST ENGAGE AND WIN LARGELY THROUGH ITS OWN EFFORTS, AS WE WILL NOT BE ABLE TO STEP IN “LATE IN THE GAME” WITH A MIRACULOUS RESCUE. IN THIS EXISTENTIAL STRUGGLE “LATE” WOULD BE TOO LATE.

AMERICA CAN BE TURNED AROUND. IT CAN REGAIN ITS CULTURAL DIRECTION AND INTEGRITY. MORE IMPORTANTLY, IT CAN, THROUGH A CONCERTED EFFORT, RESTORE THE UNITY THAT IT WAS ABLE TO CALL UPON IN THE PAST. WE HAVE THE ENERGY. WHAT IS NEEDED IS WILL AND THE LEADERSHIP THROUGH WHICH IT CAN BE EXPRESSED.
