PREFACE

THIS, OUR 60TH ISSUE, MARKS THE END OF OUR FIRST FIFTEEN YEARS OF PUBLICATION. AT THE SAME TIME, IT SIGNALS NEW EDITORIAL DIRECTIONS THAT WE THINK WILL BE NECESSARY TO MEET THE GROWING CHALLENGES TO OUR COUNTRY AND TO ANYONE ENGAGED IN RESTORING OUR TRADITIONAL HISTORICAL AND POLITICAL VALUES.

WHEN WE BEGAN PUBLICATION OF MOC, WE HARBORED NO ILLUSIONS THAT WHAT WAS MOSTLY AN INDIVIDUAL EFFORT WITH ONLY LIMITED RESOURCES OF TIME AND MONEY COULD ACHIEVE THE CRITICAL MASS OF MARKETING, DISTRIBUTION AND PUBLICITY SUCCESS THAT WOULD PROVIDE THE LEVELS OF SUBSCRIPTION REVENUES AND DONATIONS NECESSARY TO GAIN THE ATTENTION OF A WIDELY CONCERNED READERSHIP AND A LESS THAN CONCERNED MAINSTREAM MEDIA (MSM). ADDING TO THE DIFFERENCES IN MONEY, SIZE AND REACH WAS ONE OF TECHNOLOGY, FOR WITH THE EXCEPTION OF OUR WEBSITE (W/S), OUR MESSAGE HAS BEEN DIRECTED TO THE PUBLIC VIA THE PRINT MEDIUM WHICH NO LONGER HOLDS THE DOMINANT POSITION IN REPORTING AND COMMENTING ON AMERICAN LIFE THAT IT DID A CENTURY, OR EVEN A HALF CENTURY, AGO. TODAY THE CLAMOR AND THE GLAMOUR

OF OUR INSTANT AUDIO, VISUAL AND EVERYTHING ELSE AGE ONLY ACCEPTS ASSISTANCE FROM PRINT WHEN NECESSARY, AND FADING MEMORY IS LEFT TO REMIND US THAT FOR THE PERIOD OF OUR GREATEST GROWTH AND SUCCESS, FROM 1800 TO OUR SUPER-POWER STATUS OF THE POSTWAR PERIOD, PRINT WAS THE DOMINANT COMMUNICATIONS MEDIUM FOR GOVERNMENT, COMMERCE, EDUCATION, ART, FASHION, NEWS, POLITICS, RELIGION, ETC.

WE MENTION THESE ENORMOUS CHANGES IN OUR SOCIETY AND TECHNOLOGY IN THE BRIEF PERIOD OF THE LAST HALF CENTURY BECAUSE WE HAVE RECENTLY ENTERED INTO ANOTHER PERIOD OF SIMILARLY FAR REACHING CHANGE WITH THE POTENTIAL TO DEVASTATE OUR VALUES, COMPLETELY ALTER OUR CULTURE AND TURN AMERICA AWAY FROM THE DESTINY WHICH PAST GENERATIONS IMAGINED WOULD BE THEIRS AND STROVE TO ATTAIN. THESE THREATS ARE REAL AND HAVE BEEN ENABLED BY OUR EDUCATIONAL, CULTURAL AND POLITICAL AVOIDANCE.

IN THIS ISSUE, WE TAKE A MORE ACTIVIST APPROACH TO THE CURRENT ATTACKS ON WESTERN CIVILIZATION. IT IS ALSO LONGER THAN OUR PREVIOUS ONES SO THAT IT CAN SERVE AS AN EDITORIAL FRAME FOR FUTURE TOPICS. IN OUR NEXT CHAPTER WE WILL RESUME OUR USUAL LENGTH. OUR MOVE AWAY FROM COMMENTARY TOWARDS ACTIVISM HAS BEEN DICTATED BY INCREASING OPPOSITION TO WESTERN PRINCIPLES AND CULTURE IN MANY PARTS OF THE WORLD; AND THE WEST'S COLLECTIVE FAILURE TO MOUNT A DETERMINED DEFENSE OF ITS UNIQUE CHARACTER AND SUCCESS. BECAUSE OF AMERICA'S GENERALLY ACKNOWLEDGED LEADERSHIP ROLE, OUR SHARE OF FAULT IN THE WEST'S DELINQUENCY IS EVIDENT.

IN OUR NEXT ISSUE WE WILL BEGIN TO SHOW HOW THE PRESENT ATTACK ON WESTERN CIVILIZATION ENTERS INTO AND INFLUENCES OUR PATTERNS OF THOUGHT, BEHAVIOR AND DAILY ACTIVITIES; AND HOW THE EUROPEAN UNION HAS WEAKENED, RATHER THAN STRENGTHENED, ITS MEMBER STATES.

THERE ARE MULTIPLE FACTORS THAT CONTRIBUTE TO THE LASSITUDE THAT HAS GRIPPED OUR GOVERNMENT, CORRUPTED OUR POLITICAL CLASS AND TURNED THE TYPE OF NATIONAL UNITY WE HAVE BEEN ABLE TO CALL UPON IN THE PAST INTO A DISTANT MEMORY. IF WE CANNOT REGAIN OUR PAST ABILITY TO VIEW OURSELVES AND FUNCTION AS ONE NATION, THEN THE AMERICAN DREAM — HOWEVER, IT IS DEFINED — WILL NO LONGER EXIST.

AND OUR TIME FRAME IS SHRINKING MORE RAPIDLY THAN WE CAN KNOW FROM THE INFORMATION OR OPINIONS PROVIDED BY OUR GOVERNMENT AND/OR MSM. IT IS THIS RAPIDLY CONTRACTING TIME FOR CORRECTIVE ACTION THAT HAS GIVEN RISE TO THIS SERIES OF CHAPTERS WE CALL THE ATTACK ON WESTERN CIVILIZATION (WCIV). IT IS ALSO WHAT WILL LEAD US TO PURSUE THE NEW DIRECTIONS THAT WE THINK ARE CALLED FOR BY THE CIRCUMSTANCES THAT MARK THE END OF OUR FIRST FIFTEEN YEARS OF COMMENTARY.

AMERICA IS THE YOUNGEST AND STRONGEST MEMBER OF WHAT WE REFER TO AS WCIV — A MIXTURE OF THOUGHT, ART, RELIGION, GOVERNMENT, POLITICS, MUSIC, SCIENCE, COMMERCE, GENETICS AND POPULATION WITH PRE-CHRISTIAN ORIGINS IN THE CULTURES OF GREECE AND ROME. AS WAR BETWEEN THE VARIOUS WESTERN EUROPEAN STATES WAS A CONSTANT FOR CENTURIES, UNITY WAS AN INFREQUENT AND FLEETING EXPERIENCE, MOST NOTABLY EXERCISED TO TURN BACK MUSLIM INVASIONS AT TOURS, VIENNA AND THE CRIMEA AND TO RECAPTURE THE CHRISTIAN HOLY LAND VIA THE CRUSADES OF THE 11TH, 12TH AND 13TH CENTURIES; AND IN MORE MODERN TIMES TO DENY THE DESIGNS FOR CONQUEST AND TERRITORIAL ACQUISITION BY NAPOLEON, KAISER WILHELM, HITLER AND STALIN.

EUROPE'S MONARCHIES CONTROLLED ITS POWER UNTIL THEY SELF-DESTRUCTED IN THE FAILING VALUES AND LEADERSHIP OF WORLD WAR I (WW I). THEIR SYSTEM DID NOT ALLOW FOR REAL UNITY BECAUSE POWER COULD SHIFT INSTANTLY DUE TO BIRTH, DEATH, MARRIAGE, INSANITY, RELIGION, AS WELL AS THE USUAL STATE CAUSES SUCH AS THE EXPANSION OF COMMERCE, TERRITORY AND POPULATION.

IT BECAME CLEAR THAT THIS FITFUL, GLIMMERING SENSE OF UNITY NEEDED DETERMINED LEADERSHIP AND IMPROVEMENT TO SURVIVE IN THE MASSIVE REBUILDING OF EUROPE AFTER WW II. AND ALTHOUGH EUROPE HAS BEEN STRENGTHENED BY NEW METHODS AND INSTITUTIONS, OLD WAYS

AND MEMORIES PERSIST BECAUSE THEY HAVE BEEN TRIED AND HARDENED AND HAVE ENDURED CENTURIES OF HISTORY AND CONFLICT. EVEN SO, EUROPEAN UNITY PALES BESIDE THAT WHICH THE U.S. DISPLAYED SO POWERFULLY IN THE TWO GREAT WARS OF THE 20TH CENTURY. THE REASON LIES IN OUR ORIGIN WHEN THE FIRST STEP IN BECOMING A FREE NATION REQUIRED SURRENDERING OUR COLONIAL IDENTITIES OF ALMOST 200 YEARS, AND ESTABLISHING THE UNITY THAT ALLOWED OUR FOUNDERS DREAMS OF FREEDOM, HONOR AND EQUALITY TO SURVIVE AND BE PASSED ON TO FUTURE GENERATIONS.

WHILE WE HAVE DEPARTED FROM OUR WCIV FORBEARS IN MANY WAYS, OUR CULTURE IS PREDOMINANTLY THE SAME. OUR LANGUAGE, LAW, DRESS, RELIGION, FOOD, HISTORY, MUSIC, LITERATURE, ARCHITECTURE AND SCIENCE HAVE EUROPEAN ROOTS AND BRANCHES ONTO WHICH WE HAVE GRAFTED OUR OWN FORMS FOR OVER 200 YEARS. SOME HAVE BEEN BEAUTIFUL, OTHERS OFFENSIVE; BUT CULTURE, LIKE HISTORY, IS A LONG SPAN, AN ENDLESS GAME IN WHICH WE PARTICIPATE ONLY BRIEFLY. IT THANKS US, OR NOT, FOR OUR CONTRIBUTIONS; IT USES THEM, OR NOT, AS IT PREFERS. WE HAVE BEEN PRIVILEGED TO HAVE A PART IN IT, AND WE HAVE TAKEN PRIDE IN THAT PART.

WE HAVE GONE INTO SOME DETAIL BECAUSE CULTURE, HISTORY, UNITY AND OTHER ELEMENTS OF WCIV ARE NOW UNDER GLOBAL ATTACK AND, ONCE AGAIN, IF WE IN THE WEST ARE TO DEFEND OURSELVES, AMERICA WILL HAVE TO LEAD. THE PERIL WE FACE IS ONE OF MANY PARTS, AS ARE THE PROBLEMS THAT IT WILL INCREASINGLY FORCE UPON US. IN THIS AND SUCCEEDING CHAPTERS WE WILL DESCRIBE THE BACKGROUND AND THE THREATS THAT WE MUST CONFRONT. AND WE WILL OUTLINE WHAT WE MUST DO AND HOW IT SHOULD BE DONE. FOR MATTERS OF CONSCIENCE THIS WILL REQUIRE A TRANSFORMATIVE EDITORIAL MOVE AWAY FROM COMMENTARY TOWARDS ACTIVISM WHICH WE WOULD NOT CONSIDER UNLESS THE STAKES WERE AS HIGH AS THEY ARE.

THE POPULATION PROPHECY

IN OUR PREVIOUS CHAPTER WE CITED AS PROPHECIES FOUR INSTANCES OF HUMAN BEHAVIOR, MOSTLY IN EUROPE, THAT CHALLENGE OUR SENSE OF SOCIAL BALANCE. ELECTED POLITICAL REPRESENTATIVES WERE PRINCIPALS IN

ALL BUT ONE.

THERE IS ANOTHER TYPE OF HUMAN BEHAVIOR THE RESULTS OF WHICH APPEAR AS MASS NUMBERS THAT CAN PROVIDE NATIONAL OR GLOBAL MEASUREMENTS, BUT TO WHICH NO INDIVIDUAL NAMES ARE ATTACHED. POPULATION IS AN EXAMPLE OF SUCH A STATISTIC. WHETHER IT APPLIES TO SMALL COMMUNITIES OR LARGE CONTINENTS, IT IS ANONYMOUS.

UNCHECKED POPULATION GROWTH IS ONE OF MANY FORCES THAT ANTIWESTERN (AW) ELEMENTS EMPLOY IN THEIR ATTACKS ON WCIV. LIKE OTHERS, MANY WCIV PEOPLE AND THEIR LEADERS ARE EITHER UNINFORMED ABOUT THIS THREAT OR DISMISS IT AS FALSE OR IRRELEVANT. IT IS NEITHER; IT IS BOTH REAL AND URGENT.

TODAY, OUR PLANET’S POPULATION IS 7.6 BILLION, UP FROM 1 BILLION AT THE START OF THE 19TH CENTURY AND THE INDUSTRIAL REVOLUTION (IR). BY OUR MID-CENTURY IT IS EXPECTED THAT OUR WORLD’S POPULATION WILL REACH 9.7 BILLION AND THEN, BY 2100, 11.2 BILLION¹. SO FAR THESE ARE ONLY NUMBERS THAT PROVIDE A GLOBAL OVERVIEW. IN THE CHART BELOW, WE OFFER GREATER DETAIL BY SHOWING THE POPULATIONS OF THE WORLD’S 10 LARGEST CITIES IN 1950 (ACTUAL) AND 2050 AND 2100 (PROJECTED)².

AS WE DIAL DOWN TO THE LOCAL LEVEL, WE FIND, NOT JUST NUMBERS, BUT EVIDENCE OF THE SEVERE CULTURAL CHANGES THAT WE CAN ANTICIPATE OUR CHILDREN AND GRANDCHILDREN WILL EXPERIENCE IN THE REMAINDER OF THE 21ST CENTURY.

IN 1950, HALF OF THE CITIES LISTED (NYC, LONDON, PARIS, CHICAGO, RUHR) WERE IN WCIV COUNTRIES. BY 2050 ONLY ONE, NYC WILL REMAIN AND BY 2100 IT, TOO, WILL BE GONE; AND NOTE THE MIX PROJECTED FOR 2100 — 6 AFRICAN CITIES, 3 INDIAN AND 1 FROM AFGHANISTAN. THAT IS A CULTURAL MESSAGE THAT IS DIFFICULT TO IGNORE, NO MATTER HOW HARD WE MAY TRY. SUPPORTING THIS FUTURE NON-WESTERN URBAN DOMINATION ARE A COUPLE OF OTHER PROJECTIONS — THAT AFRICA’S PRESENT

POPULATION OF 1.3 BILLION WILL INCREASE TO 4 BILLION BY 2100 AND THAT ITS SHARE OF THE GLOBAL POPULATION WILL THEN HAVE GROWN FROM 9% IN 1950 TO 39%³.

THERE IS ANOTHER ASPECT OF THESE FIGURES ON WHICH WE MUST FOCUS. IN 1950 THE 10 LARGEST CITIES’ TOTAL WAS 64.3 MILLION; BY 2100 IT IS ANTICIPATED TO REACH JUST UNDER 640 MILLION. URBAN AREAS DEMAND MANY NECESSITIES AND CONVENIENCES TO SUPPORT THEIR HIGH DENSITY, HIGH-RISE CULTURE — WATER, POWER, TRANSPORT, PARKING, FOOD, SCHOOLS, COMMERCE, ETC. AND THEY MUST BE AVAILABLE IN QUANTITIES PROPORTIONAL TO THEIR POPULATIONS.

THESE MEANS OF EXISTENCE COME WITH A SUBSTANTIAL FINANCIAL COST AND AN ENVIRONMENTAL/ECONOMIC CONTRADICTION IN THAT, ESPECIALLY IN AGRICULTURALLY CHALLENGED AREAS, THE ENORMOUS ENVIRONMENTAL FOOTPRINTS OF MEGACITIES DISPROPORTIONATELY DEplete THE SUPPLY OF ENERGY AND OTHER RESOURCES IN SURROUNDING AREAS.

NUMBERS ARE QUIETER AND MORE EASILY AVOIDED THAN POLITICAL MESSAGES AND THE NOISE THAT ACCOMPANY THEM. THEY ALSO HAVE LESS IMPACT ON OUR CONSCIENCES AND DAILY LIVES THAN PERSONAL AND COMMUNITY FAILURES WHICH DOMINATE OUR MSM.

WE HAVE SHOWN THESE MEGACITIES’ POPULATION PROJECTIONS FOR TWO REASONS. FIRST, BECAUSE THEY REFLECT THE ENORMOUS CULTURAL CHANGE THAT WILL RESULT FROM AFRICA’S EXTRAORDINARY GROWTH. ADD THE FACT THAT BOTH CHINA’S AND INDIA’S POPULATIONS WILL EXCEED 2 BILLION BY 2100 AND WE FACE HAVING OVER 8 BILLION OF THE WORLD’S PROJECTED 11.2 BILLION POPULATION CONCENTRATED IN THREE CENTERS WHOSE RELIGIOUS, POLITICAL, ECONOMIC AND SOCIAL PRACTICES CLASH WITH, AND ARE OFTEN INIMICAL TO, THOSE OF WCIV.

THE SECOND REASON FOR CITING THESE MEGACITIES’ GROWTH PROJECTIONS IS THAT THEY CLEARLY SHOW HOW MUCH IN OUR AGE OF INSTANT EVERYTHING THE WORLD AROUND US, IN WHICH WE MUST LIVE OR VANISH, CAN CHANGE WITHOUT OUR BEING AWARE OF THE FORCES AT WORK OR HOW THEY WILL IMPACT OUR LIVES. VERY FEW EUROPEANS, AND PROBABLY FAR FEWER AMERICANS, HAVE A MENTAL PICTURE OF HOW UNCHECKED POPULATION WILL TRANSFORM OUR WORLD. THE CHART TELLS ALL. IT SHOULD NOT BE DISMISSED.

AFRICA IS A LAND OF EXTREMES — DROUGHTS/MONSOONS; JUNGLE/DESERT; URBAN/PRIMITIVE; TRIBES/COUNTRIES; WEALTH/POVERTY; FOOD/HUNGER. THE LAST IS ESPECIALLY IMPORTANT BECAUSE IN CAPSULE FORM IT TELLS THE SAME TALE AND ASKS THE SAME QUESTION AS THE 10 LARGEST CITIES TABLE.

IN EARLIER PRE-COLONIAL, PRE-INDUSTRIAL, PRE-HISTORIC TIMES, ALL HUMAN LIFE IN AFRICA WAS TRIBAL. FOOD WAS OBTAINED FROM VEGETATION, DOMESTICATED GRAZING ANIMALS SUCH AS GOATS AND CATTLE AND NATURALLY ABUNDANT FISH, BIRDS OR GAME. NATURE DETERMINED THE BALANCE BETWEEN HUMAN/ANIMAL POPULATIONS AND THE ENVIRONMENT THAT

SUSTAINED THEM. DROUGHTS, FIRES, PLAGUES AND FLOODS COULD CHALLENGE THE SUSTAINABILITY FOR LARGE AREAS, AS COULD LESSER DISRUPTIONS THAT COULD DESTABILIZE LOCAL SUPPLIES OF WATER AND THE TREES THAT PROVIDED FORAGE AND THE FIREWOOD ESSENTIAL TO TRIBAL COOKING.

THE OLD RELATIONSHIP BETWEEN ANIMAL/HUMAN LIFE AND ITS ENVIRONMENT IS GONE; IT WAS SIMPLY OVERCOME BY HUMAN POPULATION WHICH HAS ALTERED AFRICA'S LANDMASS AND DECIMATED ITS NATIVE WILDLIFE. THE UN PROJECTION OF AFRICA'S POPULATION INCREASING FROM ONE TO FOUR BILLION IN THIS CENTURY AND THE 10 MEGACITIES TABLE ARE CLEAR WARNING SIGNS; AFRICA WILL HAVE TO DO MORE WITH LESS RETURN PER CAPITA.

THERE ARE THOSE WHO ARGUE THAT RECENT AND CONTINUING FOREIGN INVESTMENT IN ADVANCED TECHNOLOGY AGRICULTURE IN AFRICA WILL OFFSET THE EFFECTS OF ITS POPULATION GROWTH, BUT THE NUMBERS DO NOT SUPPORT THIS CLAIM. MOREOVER, THE TWO MAIN INVESTORS IN AFRICAN MEGA-AGRICULTURE PROJECTS HAVE BEEN CHINA AND INDIA (WITH RELENTLESS POPULATION PRESSURES OF THEIR OWN) WHO HAVE ALREADY ANNOUNCED THEY WILL SEND THEIR HARVESTS BACK TO THEIR HOMELANDS. ADD THAT CHINA AND INDIA ARE USING THEIR OWN LABOR FOR THESE PROGRAMS AND THE AFRICAN ECONOMY DOES NOT COME AWAY WITH EVEN A LOCAL LABOR BENEFIT.

THERE IS ONE MORE, VERY RELEVANT NOTE TO MAKE ABOUT AFRICA'S AND WCIV'S FUTURE INTERACTION IN THE REMAINING THREE GENERATIONS OF OUR PRESENT CENTURY. NOT WITHSTANDING THE INTENTIONS/EFFORTS OF BILL GATES, THE UN, NUMEROUS RELIGIOUS AND SOCIAL MISSIONS, THE PEACE CORPS AND MANY PRIVATE CHARITIES, NO SUBSTANTIAL IMPROVEMENT IN AFRICA'S ECONOMIC/EDUCATIONAL/HEALTH STATUS IS POSSIBLE IF ITS POPULATION INCREASES BY ALMOST 3 BILLION. INDEED, THE CONSEQUENCES OF SUCH GROWTH WILL BE FELT FAR BEYOND AFRICA'S BORDERS AND ESPECIALLY IN EUROPE AND AMERICA.

NUMBERS AT THIS TIME ARE ONLY PROJECTIONS OF POSSIBILITIES, BUT CARRY WITH THEM THE CREDIBILITY OF HISTORY. LET'S ESTIMATE THAT OF THE ANTICIPATED 3 BILLION INCREASE 33%, OR ONE BILLION, WILL WANT OR TRY TO RELOCATE TO OTHER COUNTRIES AND THAT OF THESE APPROXIMATELY 20% OR 200 MILLION, WILL ATTEMPT TO LIVE THEIR NEW LIVES IN WCIV'S PRIMARY CENTERS — EUROPE AND THE U.S. GIVEN THE OPPORTUNITY AND OUR PAST PRACTICES, MOST WOULD FAVOR AMERICA, BUT TO BE CONSERVATIVE IN OUR FORECAST, WE'LL PROJECT THAT THIS 20% IS DIVIDED EQUALLY BETWEEN THOSE WANTING TO MIGRATE TO EUROPE AND THOSE PREFERRING THE U.S.

THAT MEANS THAT EUROPE, IF IT DOES NOT CHANGE ITS MIGRANCY POLICY, WILL BECOME HOME TO 100 MILLION NON-EUROPEANS PLUS OFFSPRING AND THE SAME NUMBER WILL PUT INTENSE AND CONTINUING PRESSURE FOR ADMISSION ON OUR IMMIGRATION SYSTEM. WE NOTE WITH SOME FOREBODING THAT MATTERS OF GLOBAL MIGRATION POLICY AND NUMBERS ARE LARGELY DETERMINED BY THE UNITED NATIONS HIGH COMMISSION FOR REFUGEES.

"...WHERE WILL THE FOOD COME FROM ?"

AS OUR POPULATION IS ALREADY PROJECTED TO REACH ABOUT A BILLION BY 2100, THE ADDITION OF THE NEW AFRICAN NUMBERS COULD PUSH US WELL PAST THAT NUMBER AND INTRODUCE US TO THE POPULATION DENSITIES WE NOW ASSOCIATE WITH THE THIRD WORLD. CHINA AND INDIA ARE UNABLE TO FEED THEIR OWN PEOPLE NOW, AND THEIR PROSPECTS FOR DOING SO AT OUR CENTURY'S END, WITH HUNDREDS OF MILLIONS MORE TO FEED, ARE NOT ENCOURAGING. WITHOUT EFFECTIVE POPULATION CONTROL METHODS WHERE WILL THE FOOD COME FROM ?

THE WEST VS. THE REST

WCIV FINDS ITSELF IN A POSITION OF GROWING ISOLATION FACING THE REST OF THE WORLD WHERE POPULATION AND POVERTY FUEL THE POLITICS OF NEAR GLOBAL RESENTMENT THAT TARGETS WCIV'S CULTURE AND INSTITUTIONS. ONE THING IS CERTAIN — THE NEW FORCES ATTEMPTING TO DO AWAY WITH WCIV WILL CONTINUE THEIR EFFORTS AND INTENSIFY THEM BY USING THE WORLD'S GROWING POPULATION NUMBERS TO THEIR ADVANTAGE. THIS ATTACK HAS BEEN IN PROGRESS FOR HALF A CENTURY WITHOUT RECEIVING THE ATTENTION OF OUR PEOPLE AND GOVERNMENT THAT IT DESERVES. THE NEXT 50 YEARS ARE CRITICAL! WHAT CAN WE EXPECT FROM OUR LEADERS ? WHAT WILL WE DO ? WHO CARES ? AND WHY DON'T WE ?

NEVER BEFORE IN HISTORY HAS MANKIND BEEN ABLE TO SO EFFECTIVELY REACH BACK INTO THE PAST, GATHER INFORMATION, STUDY IT IN THE PRESENT AND THEN PROJECT INTO THE FUTURE THE VARIETY AND CONSEQUENCES OF ITS IMPACT ON OUR HUMAN AND NATURAL WORLDS. THE QUESTION REMAINS, HOWEVER, AS TO HOW WE WILL USE OUR NEW KNOWLEDGE AND SKILLS.

THE FIRST THING WE MUST RECOGNIZE ABOUT CONTEMPORARY AW ANIMOSITY TOWARDS WCIV IS THAT IT IS WIDESPREAD AND COMPOSED OF MANY PARTS. NOT SURPRISINGLY, PERHAPS, IT IS FOUND WHEREVER WESTERNERS EXPLORED, SETTLED, DEVELOPED, TRADED, FOUGHT WARS, SIGNED TREATIES AND CREATED GOVERNMENTS AND/OR BOUNDARIES. THIS LIST COVERS MOST OF THE EARTH'S LAND MASSES AND SEA ROUTES.

GRIEVANCES HAVE A WAY OF STARTING SMALL AND GROWING LARGER OVER TIME, OFTEN AIDED BY TECHNOLOGY, POPULATION, POVERTY AND NATURAL DISASTERS. IN THE ONGOING DRAMA OF THE ATTACK ON WCIV WE WILL POINT OUT WHAT WE THINK ARE THE MOST DANGEROUS FORCES, THEIR SOURCES AND THE BEST WAY TO COMBAT, DEFLECT OR NEUTRALIZE THEM.

THERE IS ANOTHER FACTOR INVOLVED THAT IS EVERY BIT AS ESSENTIAL AS RESISTING EXTERNAL ATTACKS. IT IS WHETHER THE WEST, AND ESPECIALLY THE U.S., CAN UNDERTAKE THE WORK OF EDUCATING THEMSELVES TO THE REALITY OF THE SITUATION, TO RESIST POLITICAL CORRECTNESS (PC) AND OTHER FORMS OF INTIMIDATION AND TO RENEW THOSE VALUES OF COURAGE AND UNITY WITHIN OUR CHARACTER THAT WE HAVE BEEN ABLE TO CALL UPON AND EXERCISE IN OTHER TIMES, BUT WHICH ARE NOW ABSENT.

THIS BRINGS US FACE TO FACE WITH THE CRUX AT THE HEART

OF OUR AW CRISIS, AND THAT IS THAT BY OUR RESPONSE WE HAVE MANAGED TO DO AS MUCH HARM TO OURSELVES AS OUR OPPONENTS HAVE. THIS FAILURE HAS PREVENTED US FROM TAKING DECISIVE ACTION AND ACHIEVING REAL RESULTS. FOR INSTANCE, IN OUR IMMIGRATION POLICY WE MUST DECIDE WHETHER OUR LAW SHOULD SERVE OUR NATIONAL INTERESTS OR THOSE OF AMERICAN AND FOREIGN ELEMENTS WHO FAVOR THE ADMISSION OF MILLIONS OF MIGRANTS "SEEKING A BETTER LIFE" (I.E., TAXPAYER FUNDED FOOD, CLOTHING, EDUCATION, SHELTER, MEDICAL CARE, ETC.)

WE HAVE ALLOWED THIS PROCESS OF SELF-DEFEAT AND THE PSYCHOLOGY THAT INSPIRES IT, WHICH CONTRADICTS TWO CENTURIES OF AMERICAN THOUGHT AND DEVELOPMENT, TO TAKE ROOT AND GROW. AND IT HAS BEEN EFFICIENTLY EXPLOITED BY DOMESTIC POLITICAL ELEMENTS WHICH VIEW THE WEST AS A DECLINING CULTURE THAT MUST YIELD TO THE GROWING NUMBERS, DEMANDS AND POLITICAL AUTHORITY OF THE EMERGING "NEW WORLD ORDER".

"...A MONUMENTAL FAILURE ON THE PART OF THE WEST."

THESE ARE HARD WORDS TO HEAR, BUT HEAR THEM WE MUST, BECAUSE ONLY BY ARTICULATING OUR REAL VALUES CAN WE REGAIN THEM. WHILE OUR ELECTED LEADERS ARE GIVEN TO FREQUENT HYPERBOLE ABOUT THE SUPERIORITY OF OUR LEGAL, MILITARY AND ECONOMIC SYSTEMS, THEY SEEM NOT TO REALIZE HOW THEIR POLICIES AND ACTIONS FAIL TO PROTECT WCIV AND INCREASE THE THREATS AGAINST IT AND US. THIS HAS BEEN A MONUMENTAL FAILURE ON THE PART OF THE WEST. CAREFUL STUDY CAN REVEAL BOTH REASONS AND EXCUSES FOR ITS SUPINE POSTURE, BUT IT IS A FAILURE NEVERTHELESS.

A BIRD'S EYE VIEW

IN MOST PARTS OF OUR WORLD WE CAN OBSERVE BIRDS OF PREY SUCH AS EAGLES, CONDORS, HAWKS, OWLS AND VULTURES SOARING AND CIRCLING HIGH ABOVE THE EARTH IN SEARCH OF THE ANIMALS, OR THEIR REMAINS, THAT SERVE AS THE BASIS OF THEIR DIET. THEIR EYESIGHT IS EXTRAORDINARY, EVEN BY ANIMAL STANDARDS, AND PROVIDES THEM WITH A RANGE OF VIEW NECESSARY FOR SURVIVAL COMPARABLE IN WAYS TO THAT WHICH OUR TECHNOLOGY HAS PROVIDED US TO EXTRACT INFORMATION FROM OUR DISTANT PAST AND PROJECT ITS COURSE AND CONSEQUENCES FOR OUR FUTURE.

THE BIRD'S VISION ENABLES IT TO SPAN A VERY LARGE AREA, NOTE WHAT IS OCCURRING IN REAL TIME AND THEN DECIDE UPON AND TAKE WHATEVER ACTION SEEMS MOST LIKELY TO OFFER FOOD OR PROTECTION. IN DESCRIBING THE CONDITION IN WHICH WCIV NOW FINDS ITSELF WE MUST BORROW THE BIRD'S VIEW, APPLY IT TO THE LAST CENTURY, CONNECT SOME KEY DOTS AND ARRIVE AT AN EXPLANATION IN CAPSULE FORM OF HOW WCIV ALLOWED ITSELF TO BE ATTACKED, DEMONIZED AND DAMAGED BY MULTIPLE ELEMENTS WITHIN THE WORLD ORDER.

* * *

OUR STARTING POINT FOR REVIEW IS WW I. THAT DOES NOT MEAN THAT WCIV DID NOT INCUR ANTAGONISMS AND RESENTMENTS BEFORE THEN. IT DID, MOSTLY IN EUROPE'S AGES OF 16TH CENTURY EXPLORATION AND 19TH CENTURY COLONIALISM, BUT IT HAS BEEN IN OUR MODERN PERIOD (WW I TO THE PRESENT) THAT AW THOUGHT AND SPEECH HAVE GROWN IN NUMBER AND INTENSITY.

WW I, ALTHOUGH IT FAILED IN ITS INTENT TO "END ALL WARS", WAS A GAME CHANGER IN OTHER WAYS. IT ENDED EUROPE'S CENTURIES OLD SYSTEM OF GOVERNMENT BY MONARCHY; IT KILLED OFF THE BEST PART (PHYSICALLY AND NUMERICALLY) OF A GENERATION OF MALES FROM YOUTHS TO PARENTS ON BOTH THE GERMAN AND ALLIED SIDES; AND IT OMINOUSLY INTRODUCED THE NEW TECHNOLOGIES OF TANK AND AIRPLANE WARFARE THAT WOULD SO GREATLY INCREASE COMBAT AND CIVILIAN CASUALTIES A GENERATION LATER IN WW II.

IT WAS THE DIRECT CAUSE OF ECONOMIC DISLOCATIONS IN GERMANY, BROUGHT ABOUT BY POSTWAR REPARATIONS AND UNCHECKED INFLATION, WHICH ENABLED HITLER'S RISE TO POWER AND USHERED IN AN ERA OF PROLONGED LABOR VIOLENCE THROUGHOUT EUROPE BETWEEN FASCIST AND COMMUNIST WORKERS, UNIONS AND ORGANIZERS.

GERMANY HAD ALSO BECOME A PLACE OF REFUGE FOR RUSSIAN COMMUNISTS FLEEING STALIN'S FREQUENT PURGES FOLLOWING THE DEATH OF LENIN IN 1924. AS HITLER LOATHED THE COMMUNIST MOVEMENT AND FEARED ITS POLITICAL POWER, HE INITIATED A PROGRAM OF EXPELLING AND/OR EXECUTING KNOWN COMMUNISTS IN GERMANY AND ELSEWHERE.

THESE TWO EVENTS, ONE IN RUSSIA AND THE OTHER IN GERMANY, UPROOTED MANY COMMUNIST AGENTS, ACADEMICS, SYMPATHIZERS, ARTISTS, PROFESSIONALS, ETC. WHO FOUND THEIR WAY TO THE U.S. IN THE MIDST OF OUR GREAT DEPRESSION (GD). IT WAS THEN IN THE SOCIAL AND FINANCIAL AGONY OF THE GD, WHEN ANY MESSAGE THAT OFFERED RELIEF COULD GET ATTENTION HERE AND IN EUROPE, THAT THE AW FORCES WERE ABLE TO ACT WITH A NEW DEGREE OF UNISON AND TO ESCALATE THEIR EFFORTS TO TARGET AND INFILTRATE ACADEMIC, POLITICAL AND GOVERNMENT INSTITUTIONS.

AGAIN, IT IS IMPORTANT TO REMEMBER THAT THE PAIN OF THE GD WAS GLOBAL, THAT MANY FORCES AND FUNCTIONS OF GOVERNMENT WERE DEDICATED TO RELIEVING IT AND THAT, GIVEN THIS ALMOST TOTAL FOCUS ON ECONOMIC/SOCIAL SURVIVAL, WCIV'S OPPONENTS COULD INITIATE THEIR PLANS AND ACTIONS WITH LITTLE CHALLENGE OR NOTICE.

WW II, WHICH BEGAN IN EUROPE IN 1939 AND HERE TWO YEARS LATER, ESTABLISHED ALLIANCES WHICH REQUIRED DIPLOMATIC AND MILITARY SUPPORT SYSTEMS IN THE CAPITALS OF BOTH COMBAT AND NEUTRAL NATIONS. THE PERSONNEL THAT STAFFED THESE ADJUNCT BODIES USUALLY ARRIVED FROM A MIXTURE OF CIVILIAN AND MILITARY BACKGROUNDS INCLUDING THOSE OF ESPIONAGE AND INTELLIGENCE OPERATIONS; AND MANY, ESPECIALLY THOSE FROM RUSSIA AND OTHER COMMUNIST BLOC NATIONS, STAYED ON IN PEACE TIME TO CONTINUE THEIR COVERT ACTIVITIES.

THIS WAS A MOMENTOUS TIME OF INTENSE EAST/WEST COMPETITION WHICH INCLUDED THE FORMATION OF THE UNITED

NATIONS (UN) AND THE WRITING OF ITS CHARTER IN BOTH OF WHICH COMMUNIST EFFORT AND INFLUENCE WERE LATER CONFIRMED. ESTABLISHED IN 1945 WITH 51 MEMBERS, THE ALLIED DEMOCRACIES ENVISIONED THE UN AS AN OVERSIGHT BODY CAPABLE OF GUIDING THE DEVELOPMENT AND DESTINIES OF THIRD WORLD NATIONS ALONG THE PATH OF WCIV'S PAST AND PRESENT SUCCESSES.

IT BECAME CLEAR, HOWEVER, THAT, AS COLONIAL TIES WERE CUT AND NEW, INDEPENDENT NATIONS CREATED IN MOSTLY NON-WESTERN CULTURES, SWELLING THE UN MEMBERSHIP TO 193, THE RESULTING IMBALANCE SET THE UN ON A DIFFERENT COURSE THAN ORIGINALLY CONTEMPLATED. TODAY IT IS A VAST GLOBAL ENTERPRISE WITH MYRIAD FUNCTIONS AND A HIGH LEVEL OF CORRUPTION WHOSE INTERESTS AND ACTIVITIES PRIMARILY REFLECT THE AFRICAN, ARAB, INDIAN AND ORIENTAL ORIGINS OF ITS THIRD WORLD MEMBERS.

POSTWAR CHANGES

JUST ABOUT HALF WAY THROUGH OUR LAST CENTURY, GENERAL DWIGHT D. EISENHOWER ACCEPTED THE GOP'S INVITATION TO RUN FOR PRESIDENT IN THE 1952 ELECTION AND WON A RESOUNDING VICTORY. "IKE" WAS A MAN OF UNUSUAL ACCOMPLISHMENTS AND CHARACTER. AFTER HIM, HISTORY DREW A DEEP LINE OF SEPARATION IN ALMOST ALL ASPECTS OF OUR NATIONAL LIFE — IN OUR POLITICS, OUR CULTURE, OUR MEDIA AND OUR SENSE OF OUR INDIVIDUAL AND NATIONAL IDENTITIES. IN A CHANGING AMERICA ALL THESE GAVE GROUND TO THE 1960S AND THEIR LEGACIES — VIETNAM, WATERGATE, WATTS RIOTS, OUR NATIONAL DRUG CULTURE, A MAN ON THE MOON, CHAPPAQUIDDICK, THE GREAT SOCIETY, DEFICIT FINANCING, INFLATION AND MORE. AND PERHAPS MOST SIGNIFICANTLY, OUR MSM, WITH NEW TECHNOLOGY IN HAND, BEGAN THE PROCESS OF BECOMING A MANIPULATOR, NOT MERELY A REPORTER, OF THE NEWS IT COVERED.

THIS IS A MIXED MENU PICKED AT RANDOM. EACH EVENT WAS SIGNIFICANT IN ITS OWN WAY AND TIME, BUT BENEATH THE LABELS ON THE SURFACE SOMETHING REALLY IMPORTANT WAS TAKING PLACE. AMERICAN INDUSTRY AND CAPITAL WAS REBUILDING THE WORLD. IN THE PROCESS AMERICA BECAME RICHER AND MORE POWERFUL THAN IT HAD EVER BEEN BEFORE.

IN SHORT TIME, AND WITH LITTLE FANFARE, LOBBYISTS FROM COMPANIES THAT OPERATED IN EVERY INDUSTRIAL, AGRICULTURAL OR MINING ACTIVITY, AS WELL AS EVERY SERVICE INDUSTRY, ARRIVED IN WASHINGTON TO ADVISE CONGRESS ON ISSUES THAT AFFECTED THEIR COMPANIES, AND TO ASSIST IN THE WRITING OF LEGISLATION THAT COULD FURTHER THEIR COMPANIES' INTERESTS. NOT SURPRISINGLY, THEY WERE WILLING, AND EVEN ANXIOUS, TO PAY HANDSOMELY TO CREATE THE NEW PERSPECTIVE.

MAKE NO MISTAKE. THIS WAS BY ANY DEFINITION EASY MONEY THAT REQUIRED IN RETURN ONLY A MOMENT OF LOYALTY WHEN LEGISLATION WAS PRESENTED FOR A VOTE. AND THERE WAS ALWAYS MORE TO COME. BY TAKING POSITIONS ON TOPICS PUSHED BY A HANDFUL OF LOBBYISTS, MEMBERS COULD COMFORTABLY SUPPLEMENT THEIR CONGRESSIONAL SALARY WHILE IN OFFICE AND OFTEN DRAMATICALLY INCREASE THEIR RETIREMENT INCOME.

INDEED ONE OF THE FIRST "DUTIES" OF AN INCOMING MEMBER OF CONGRESS IS TO APPEAR AT COCKTAIL PARTIES GIVEN BY LOBBYISTS TO INTRODUCE THEMSELVES AND THE MANY VIRTUES OF THEIR CLIENTS. THESE EVENTS HAVE BEEN LIKENED TO PROFESSIONAL SPORTS' DRAFTS AND SIGNING EVENTS WHEN HIGH SCHOOL ATHLETES ANNOUNCE AND COMMIT TO THEIR CHOICE OF COLLEGE.

BUT LOBBYISTS COMPRISE ONLY ONE SIDE OF THE SHIFTS IN CONGRESSIONAL COMPENSATION AND SERVICE THAT MARKED OUR POSTWAR PERIOD OF ESCALATING WEALTH AND POWER. SEEMINGLY TO KEEP PACE WITH OUR NEW IMAGE, CONGRESS AWARDED ITSELF FREQUENT PAY RAISES AND GENEROUS RETIREMENT BENEFITS TO MATCH.

AT THE END OF WW II CONGRESSIONAL SALARIES AMOUNTED TO ABOUT \$12,500 A YEAR⁴ AND, WHEN IN SESSION, MEMBERS WERE EXPECTED TO WORK A FIVE-DAY WEEK WHICH WAS OFTEN SHORTENED TO FOUR BY MID-DAY ARRIVALS ON MONDAY AND DEPARTURES ON FRIDAY. TODAY, ANNUAL CONGRESSIONAL PAY IS \$174,000 WITH ADD-ONS FOR COMMITTEE CHAIRMANSHIPS AND OTHER FUNCTIONS; AND WITH A RETIREMENT PLAN THAT VESTS AFTER ONLY FIVE YEARS AND PAYS AT 80% OF SALARY LEVEL FOR LIFE. SIMULTANEOUSLY WITH THIS INCREASE IN COMPENSATION, THE CONGRESSIONAL WORK WEEK HAS BEEN REDUCED TO 2.5 DAYS WHILE IN SESSION, REDUCING THE TOTAL NUMBER OF DAYS WORKED DURING THE YEAR TO 133.

THE REASON CONGRESS OFFERS FOR ITS STEADILY SHRINKING WORK WEEK IS THAT ITS MEMBERS MUST BE IN THEIR DISTRICTS TO SEEK AND RECEIVE VOTER OPINION. THE TRUTH IS THAT, MORE OFTEN THAN NOT, WHAT IS BEING SOUGHT AND OBTAINED IS ADDITIONAL POLITICAL AND FINANCIAL SUPPORT OFTEN SCREENED BY LOCAL ACTIVITIES AND CAUSES.

THIS MAY SEEM LIKE AN UNNECESSARILY LONG ATTENTION TO CONGRESSIONAL PRACTICES, BUT THE LARGER TALE OF OUR AND OTHERS' SERIOUS AND SERIAL ERRORS (POLITICAL, SOCIAL, CULTURAL) CANNOT BE FULLY UNDERSTOOD WITHOUT RECOGNIZING CONGRESS' FAILURES AND ITS CONTRIBUTION TO THE EXISTENTIAL THREATS THAT NOW PRESS UPON WCIV.

WE CITED THE 1960S AS BEING THE GATEWAY DECADE TO THE REST OF THE 20TH CENTURY. IT WAS PROPHETIC IN THE SENSE THAT IT DISPLAYED IN DIFFERENT TIMES AND FORMS BOTH GREAT PROMISE AND REAL PERIL. THIS IS A CONTRADICTION THAT HAS BEEN PRESENT THROUGHOUT HISTORY IN VARYING DEGREES, BUT WHAT MAKES IT PARTICULARLY NOTABLE IN OUR TIME AND PLACE IS THE UNEQUALLED WEALTH AND POWER THAT ACCRUED TO OUR NUCLEAR ARMED, COMMERCIALY DOMINANT, TECHNOLOGICALLY ADVANCED, RESOURCE RICH, VASTLY WEALTHY, PEACETIME, SUPERPOWER UNITED STATES.

IN TOO MANY INSTANCES IT SEEMED OUR GOVERNMENT HAD LITTLE IDEA OF HOW TO WIELD THIS POWER SO THAT IT WOULD BENEFIT THE AMERICAN PEOPLE. WE HAVE TO ASK WHAT MENTALITY WAS AT WORK WHEN CONGRESS WITHDREW FROM THE SOCIAL SECURITY (SS) TRUST FUND THE DEPOSITS OF MILLIONS OF AMERICANS' EARNED RETIREMENT FUNDS AND SPENT THE MONEY ON ITS OWN POLITICAL AGENDA. THESE WORKERS' SAVINGS, PAID OUT OF WAGES OVER YEARS OF EMPLOYMENT, WERE REPLACED BY WORTHLESS IOUS FOR WHICH NOT EVEN PARTIAL PAYMENT HAS

BEEN MADE, WHILE IN THE MEANTIME THE AMOUNT OF THE SS PAYROLL DEDUCTION HAS STEADILY INCREASED.

* * *

OTHER INSTANCES OF OUR POLITICAL LEADERS' INABILITY TO FULLY COMPREHEND THE CONSEQUENCES OF THEIR ACTIONS HAVE BEEN AS PREDICTABLE, BUT NOT AS OUTRAGEOUS, AS THE SS TRUST FUND DEBACLE. PRESIDENT EISENHOWER PROPOSED AND CONGRESS PASSED LEGISLATION THAT CREATED OUR NATIONAL INTERSTATE HIGHWAY SYSTEM WHICH, UPON ITS COMPLETION, BECAME THE ENVY OF THE WORLD.

IT BENEFITED FARMERS, INDUSTRY, COMMUTERS, VACATIONERS, STUDENTS, TRUCKERS, AS WELL AS OUR MANY STATE AND FEDERAL PARKS AND HISTORIC SITES THAT ATTRACT TOURISTS FROM ALL OVER THE WORLD. IT WAS A GAME CHANGER, A WIN FOR EVERYONE, AND AS ITS FUNDING FOR MAINTENANCE WAS INCLUDED IN THE FEDERAL GASOLINE TAX, CONGRESS COULD ANTICIPATE NOT HAVING TO DEBATE AND PROVIDE ADDITIONAL FUNDS.

SADLY, CONGRESS COULD NOT EVEN BRING ITSELF TO RAISE THE GASOLINE TAX ENOUGH FOR MINIMAL MAINTENANCE EXPENSES OF A FEW HUNDRED MILLION DOLLARS A YEAR WITH THE RESULT THAT WHAT WAS OUR SHOWCASE HIGHWAY SYSTEM NOW SHOWS SIGNS OF DECADES OF DETERIORATION, IS UNSAFE AND WILL REQUIRE ABOUT \$1.5 TRILLION TO MEET CURRENT TRAFFIC, SAFETY AND STRUCTURAL STANDARDS,

* * *

SOME RECENT RESEARCH HAS STATED THAT THE AVERAGE AMERICAN WATCHES 5 HOURS OF TELEVISION DAILY — A SHOCKING FIGURE. BUT WHAT'S EVEN MORE SHOCKING IS WHAT THEY WATCH, WHAT IS AVAILABLE ON OUR SMALL SCREENS. IT'S MOSTLY A VERY LOW MIX OF SEX, VIOLENCE, TRASHY HUMOR, GAME SHOWS, SITCOMS AND ENDLESS COMMERCIALS ALL DUMBED DOWN TO THE LOWEST LEVELS THAT OUR NATIONAL MARKETERS ARE CONVINCED WILL BRING THEM EVER LARGER SALES AND PROFITS.

THIS SITUATION RESULTS FROM A FATEFUL DECISION MADE BY CONGRESS IN THE EARLY DAYS OF THE GROWTH OF TELEVISION TECHNOLOGY AND BROADCASTING. RECOGNIZING THAT THE BROADCAST FREQUENCIES USED BY TV WERE A NATIONAL PUBLIC ASSET, CONGRESS SOUGHT A SYSTEM THAT WOULD RETAIN PUBLIC OWNERSHIP AND YET GIVE THE GOVERNMENT THE AUTHORITY TO MANAGE THE MEDIUM'S GROWTH AND SET POLICY FOR ITS DEVELOPMENT AND DIRECTION.

WHAT RESULTED WAS A LICENSING SYSTEM UNDER CONTROL OF THE FEDERAL COMMUNICATIONS COMMISSION (FCC) WHICH HELD REGULAR AUCTIONS OF THE BROADCAST FREQUENCIES TO COMMERCIAL INTERESTS. THIS PROGRAM REACHES AS FAR BACK AS THE LATE 1940S, DURING WHICH TIME THE CAST OF LICENSEES DOESN'T SEEM TO HAVE CHANGED VERY MUCH. CBA, NBC, ABC AND OTHER EARLY ENTITIES, EITHER IN THEIR ORIGINAL OR MODIFIED OWNERSHIP FORM, ARE STILL BROADCASTING FROM THEIR ACCUSTOMED CHANNELS.

THE BROADCASTING INDUSTRY AND THE FCC HAVE ALWAYS MAINTAINED A CLOSE RELATIONSHIP, AS MIGHT BE EXPECTED WHEN SUCH VALUABLE PROPERTIES AS COMMUNICATION RIGHTS AND BIG MONEY ARE INVOLVED AND EXCHANGED. THE FAILURE IN THIS PARTICULAR MIX OF GOVERNMENT AND COMMERCE IS THE PRODUCT THAT HAS RESULTED.

IN BRITAIN OUR ENGLISH COUNTERPARTS SOLVED THE PROGRAMMING PROBLEM BY ESTABLISHING THE GOVERNMENT OWNED AND OPERATED BRITISH BROADCASTING CORP. (BBC) TO CONDUCT ALL ASPECTS OF RADIO AND TV BROADCASTING — EDITORIAL, COMMERCIAL, ENTERTAINMENT — AND TO SET POLICY FOR THIS GLOBAL ORGANIZATION. DIFFERENT TYPES OF PROGRAMMING ARE ASSIGNED TO SPECIFIC BANDS SO THAT CLASSICAL MUSIC LOVERS, FOR INSTANCE, CAN TUNE TO ITS DESIGNATED BAND AND NOT HAVE TO LISTEN TO "RAP" OR "ROCK".

THE ANSWER MOST COMMONLY GIVEN BY SUPPORTERS, OF OUR SYSTEM IS THAT THE BBC'S GOVERNMENT INVOLVEMENT RUNS COUNTER TO OUR CAPITALISTIC, FREE ENTERPRISE TRADITION AND THAT, ALTHOUGH IT MAY WORK WITH A MUCH SMALLER POPULATION SUCH AS THAT OF THE UNITED KINGDOM (UK), IT WOULD NOT BE SUCCESSFUL HERE.

* * *

FINALLY, CONGRESS' MOST FAR REACHING FAILURE TO UNDERSTAND THE CONSEQUENCES OF ITS OWN ACTIONS WAS ITS MAKE-OVER OF OUR IMMIGRATION LAWS DURING THE JOHNSON ADMINISTRATION IN 1965. OVERTURNING A CENTURY OF SUCCESSFUL POLICY KEYED TO ASSIMILATION, WHICH WELL SERVED THE INTERESTS OF BOTH HOST AMERICANS AND NEW ENTRANTS, THE 1965 ACT SET NEW POLICY FOR THE SOURCES, NUMBERS AND ENTRY REQUIREMENTS OF OUR IMMIGRATION PROCESS. TRADITIONAL SKILL BASED ADMISSIONS FROM WCIV'S EUROPEAN NATIONS WERE DISCARDED IN FAVOR OF THIRD WORLD ADMISSIONS BASED ON FAMILY TIES.

THE VERY FORESEEABLE RESULTS WERE DRAMATIC INCREASES IN THE NUMBERS AND ETHNIC MAKE-UP OF NEW ARRIVALS, AS WELL AS THE FINANCIAL COSTS OF PROVIDING SOCIAL AND ECONOMIC SUPPORT FOR THEM AND THEIR DEPENDENTS WHICH HAS BEEN ESTIMATED TO AMOUNT TO ABOUT \$300 BILLION ANNUALLY⁵ NET OF ANY TAX, FEES OR OTHER PAYMENTS BY THEM. SEN. EDWARD KENNEDY OF MA, WHO SERVED AS THE MAIN FORCE IN SPEARHEADING THIS BILL THROUGH CONGRESS, CLAIMED IT WOULD NOT ALTER THE NUMBERS OR THE NATURE OF OUR IMMIGRATION PROGRAM AND CONGRESS PASSED THE ACT OVER THE PROTESTS OF THOSE WHO UNDERSTOOD THE NUMBERS AND COULD PROJECT THEIR IMPACT ON OUR COUNTRY.

* * *

THESE POINTS HAVE BEEN DEBATED FOR DECADES, BUT TODAY WE FACE A NEW AND FAR MORE SERIOUS CHALLENGE THAN THE ONE OF JUST PROVIDING THE MINIMAL AMOUNTS OF LEGISLATION AND FUNDING NECESSARY TO MEET THE GOVERNMENT'S BASIC NEEDS.

WE HAVE ARRIVED AT A STAGE OF ALMOST CONTINUAL STALEMATE IN WHICH OUR ELECTED LEADERS ENGAGE IN CONSTANT QUARRELING OVER THEIR IDEOLOGICAL CREDENTIALS TO GOVERN WITH THE RESULT THAT THE REAL WORK OF GOVERNMENT IS HELD HOSTAGE BY BOTH PARTIES, AND THE CRITICAL TIME, EFFORTS AND ENERGY NEEDED TO PROVIDE EFFECTIVE GOVERNMENT ARE LOST.

IN OUR AGE, THIS LOSS IS MAGNIFIED AND ACCELERATED BY THE SOCIAL CHANGES THAT HAVE RESULTED FROM NEAR STEROIDAL EXPANSION OF OUR MEDIA AND TECHNOLOGICAL SECTORS. IN ALL OF THESE AREAS — GOVERNMENT, COMMUNICATIONS, SCIENCE — THEIR RAPID AND EXTENSIVE TRANSFORMATIONS HAVE OPENED UP FISSURES IN OUR SOCIETY.

PREVIOUSLY, UNDER A WIDE RANGE OF NATIONAL CHALLENGES — OUR FOUNDING, WESTWARD EXPANSION, INDUSTRIALIZATION, THREE MAJOR WARS (ONE CIVIL AND TWO WORLD), AND GD — WE WERE ABLE TO CALL UPON OUR HISTORICAL COHESION TO OVERCOME THE OBSTACLES THAT SEEMED TO BLOCK OUR PATH AND OBSCURE OUR DESTINY.

"WE ARE BARELY NIBBLING AT THE EDGES OF THE MAJOR ISSUES THAT FACE OUR NATION AND THE PERILS TO WHICH THEY EXPOSE US."

WE NO LONGER HAVE THAT CAPABILITY. THE SAME AURA OF CONTENTION THAT PERVADES OUR GOVERNMENT IS MIRRORED IN OUR PEOPLE. CALL IT WHAT WE MAY --- MALAISE, FATIGUE, CORRUPTION, UNCERTAINTY, DECADENCE, GREED, DECLINE, DOGMATISM, INCOMPETENCE, PRIVILEGE, POWER, ANY OR ALL OF THESE — AMERICA IS NOW SUFFERING THE EFFECTS OF GOVERNMENT THAT FUNCTIONS ONLY FITFULLY UNDER A FAILING LEADERSHIP. ALL TOO OFTEN ITS MINIMAL ACHIEVEMENTS ARE MANAGED BY STOPGAP MEASURES, CONTINUING RESOLUTIONS OR ENACTMENTS THAT OFFER PARTIAL RESULTS OR FUNDING. WE ARE BARELY NIBBLING AT THE EDGES OF THE MAJOR ISSUES THAT FACE OUR NATION AND THE PERILS TO WHICH THEY EXPOSE US.

ADMISSIONS SUCH AS THESE, ALTHOUGH NECESSARY IF WE ARE TO SURVIVE, ARE NEVER PLEASANT, AND YET THEY DEMAND AND DESERVE TO BE HEARD. THE FACT IS THERE ARE FAR TOO MANY AMERICANS WHO DISMISS THEM WITH COMMENTS SUCH AS, "WE'RE NOT IN THAT BAD SHAPE" OR "WE'LL GET THROUGH, WE ALWAYS DO".

THEY SEEM TO THINK THAT OUR PAST SUCCESSES ASSURE US OF CONTINUING DOMINANCE OVER OUR ENEMIES. THEY FAIL TO REMEMBER THAT OUR VICTORIES WERE FORGED BY CITIZENS WITH A COMMON WILL, PURPOSE AND COURAGE TO DRAW UPON, AND THEY ARE WRONG IN ASSUMING IT IS STILL AVAILABLE ON DEMAND. IT IS GONE NOW, REPLACED BY A CULTURE OF DRUGS AND VIOLENCE, THE CONFUSION OF OUR NATIONAL IDENTITY AND OUR DISREGARD OF OUR HISTORIC CONSTITUTIONAL VALUES.

ALL OF THESE OFFER OPPORTUNITIES TO OUR ENEMIES. OUR VALUES ARE NOT BEYOND OUR REACH; THEY CAN BE RECLAIMED, BUT ONLY BY A TRULY NATIONAL EFFORT OF COMMITMENT. THERE ARE OTHER FORCES NOW WORKING AGAINST US AND WCIV. THEY VIEW OUR PRESENT FAILURES OF LEADERSHIP AS INVITATIONS TO DISLodge WCIV AS THE WORLD'S PREEMINENT CULTURAL, ECONOMIC AND POLITICAL ENTITY AND TO DIMINISH, AND THEN

COLLAPSE, AMERICA'S WCIV AND GLOBAL LEADERSHIP POSITIONS.

SOME OF THESE FORCES ARE NEW; SOME ARE OLD AND MAKING A NEW EFFORT. THEY ARE CHINA, RUSSIA, ISLAM AND MANY OF THE WORLD'S POOR POPULATIONS WHICH THROUGH OUR ADVANCING TECHNOLOGY HAVE BEEN ALLOWED TO SEE AND HEAR THE DIFFERENCES BETWEEN LIFE IN THE THIRD AND THE DEVELOPED WORLDS. WHATEVER THEIR IDENTITY OR BACKGROUND, THEY SHARE AMONG THEMSELVES, AND WITH OTHER CULTURAL AND COMMERCIAL INTERESTS, THE DESIRE TO DO AWAY WITH WCIV'S SYMBOLIC AND ACTUAL SUPERIORITY. AND THEY ALSO SHARE LONGSTANDING RESENTMENT OF DIFFERENCES IN RACE, WEALTH, ETHNICITY, GOVERNMENT, EDUCATION, APPEARANCE, CLIMATE, NATURAL RESOURCES, ETC.

BOTH THE TWO COMMUNIST STATES OF THE VAST ASIAN LANDMASS AND THE RESURGENT "SWORD OF ISLAM" BELIEVE THAT THEIR PATH TO TOTAL POWER WOULD BE FACILITATED BY THE DEMISE OF WCIV AND THE U.S. IN FACT, IT WOULD ONLY SET UP A FINAL CONFRONTATION FOR DOMINANCE BETWEEN SECULAR, GODLESS WORLD COMMUNISM AND THE FAITH OF MILITANT ISLAM PROCLAIMED BY MOHAMMAD IN THE QUR'AN. AS EACH HAS ITS OWN LEGAL, FINANCIAL AND POLITICAL FORMS FROM WHICH NO VARIATIONS ARE ALLOWED, WESTERN THOUGHT ABOUT HUMAN, SOCIAL, PROPERTY, RELIGIOUS, POLITICAL AND CULTURAL FREEDOMS WILL VANISH UNLESS EUROPE AND AMERICA CAN MOUNT A STRONG DEFENSE.

EUROPE HAS ALREADY MOVED WITH ALARMING HASTE TO ACCEPT THE SOCIAL AND POLITICAL DYSFUNCTION THAT HAS ACCOMPANIED THREE YEARS OF UNCHECKED, MOSTLY MALE, MUSLIM MIGRANTS. ITS POPULAR WILL TO RESIST THE MUSLIM INVASION IS NOW CAPABLE ONLY OF SMALL, NOT LARGE, RESPONSES AND IS OVERSHADOWED AT THE STATE LEVEL BY WILLINGNESS TO ACCOMMODATE MIGRANT DEMANDS FOR STATUS, RESIDENCE AND SOCIAL SUPPORT.

BEYOND THE STATE LEVEL, MATTERS DETERIORATE FURTHER AS THE EUROPEAN UNION (EU) EXERCISES THE POWER OF ITS MULTI-NATION BUREAUCRACY TO FIND EXPENSIVE (IN TIME AND MONEY) WAYS TO MANAGE, RECEIVE AND SHELTER THE CONTINUING STREAM OF ENTRANTS NOW ARRIVING FROM AFRICA, THE NEAR EAST (NE), AFGHANISTAN, TURKEY AND PAKISTAN.

* * *

WE ARE APPROACHING A BLANK SPOT, A MISSING LINK BETWEEN DEEPLY DIFFERENT CULTURES, BUT FIRST WE MUST REPORT ANOTHER SAD TALE FROM SWEDEN INVOLVING A 45-YEAR-OLD SWEDISH MOTHER WHO WORKED IN A GROUP HOME FOR "UNACCOMPANIED REFUGEE CHILDREN".

IN NOVEMBER 2016, SHE TOOK INTO HER HOME AN 18-YEAR-OLD AFGHAN MUSLIM, ABDUL D., FROM THE HOME WHERE HIS AGE MADE HIM INELIGIBLE FOR FURTHER RESIDENCE. IN TIME, ABDUL AND HIS HOSTESS BEGAN SAME-BED SLEEPING ARRANGEMENTS AND, IN MORE TIME, ABDUL CRIMINALLY MOLESTED HIS BENEFACTOR'S 12-YEAR-OLD DAUGHTER. AS THE MOTHER TOOK NO ACTION, THE DAUGHTER REPORTED

THE INCIDENT TO HER FATHER WHO IS SEPARATED FROM HER MOTHER. THE CHILD'S FATHER INFORMED THE POLICE, A COURT HEARING TOOK PLACE AND ABDUL D. WAS GIVEN A THREE-MONTH SUSPENDED SENTENCE, FINED A MINOR AMOUNT AND TOLD TO PERFORM COMMUNITY SERVICE.

WHEN QUESTIONED BY AUTHORITIES REGARDING HER SILENCE, THE MOTHER OFFERED THAT SHE WAS AFRAID ABDUL D. WOULD BE DEPORTED. THE EMOTIONAL PAIN AND SCARRING FROM THIS INCIDENT IS SOMETHING THE CHILD WILL HAVE TO ENDURE FOR MANY YEARS.

LIFE IN EUROPE NOW IS NOT LIKE IT WAS IN EVEN THE RECENT PAST AND IT IS NOT LIKE OUR PRESENT LIFE IN AMERICA, BUT WE, TOO, NOW HAVE GROWING INSTANCES OF SEXUAL ABUSE INCLUDING GANG RAPES. THE GAP IS CLOSING AND, UNLESS WE TAKE ACTION, WE WILL FIND OURSELVES LIVING IN A TOTALLY DIFFERENT SOCIETY THAN THAT CREATED BY OUR FOREBEARS AND WHICH WE ASSUMED WOULD BE OUR INHERITANCE. IT IS NOT WORKING OUT THAT WAY.

REMEMBER ROTHERHAM ! THERE ARE STRIKING SIMILARITIES AT WORK. THE MAIN DIFFERENCE BETWEEN THE ENGLISH AND THE SWEDISH ABUSE TRAGEDIES IS ONE OF SCALE — MULTIPLE VICTIMS IN ROTHERHAM AND ONLY ONE IN THE SWEDISH CASE CITED ABOVE. BUT IN MANY PLACES IN EUROPE LIFE IS LIVED IN GUARDED WAYS TO PROTECT AGAINST COMMUNAL LAWLESSNESS — MOST NOTABLY SEXUAL AGGRESSION. WE ARE NOT REFERRING TO A BUNCH OF GUYS WORKING ON A CONSTRUCTION SITE WHISTLING OR CALLING OUT PASSING GIRLS WEARING SHORT SKIRTS ON A WARM, SPRING DAY. FAR FROM IT; IN TOO MANY CITIES/TOWNS IN EUROPE SEXUAL ABUSE IS A CONSTANT SPORT INITIATED BY INDIVIDUALS, SMALL TEAMS OR EVEN LARGE GROUPS THAT ARE ABLE TO NEUTRALIZE LOCAL LAW ENFORCEMENT.

TO THIS END, WOMEN TRY TO AVOID APPEARING IN PUBLIC PLACES ALONE DURING THE DAY AND GOING OUT AT ALL AT NIGHT. THEIR FEAR IS REAL, AS THE NARROW, WINDING STREETS FOUND IN MANY EUROPEAN CITIES/TOWNS OFFER OPPORTUNITY TO AN ATTACKER; AND OPEN PUBLIC SPACES ARE OFTEN OCCUPIED BY LARGE GROUPS OF UNEMPLOYED MIGRANT MEN (MANY OF WHOM CARRY KNIVES) WHOSE NUMBERS AND ATTITUDES THREATEN LOCAL POLICE. AND AT THE FAR END OF OUR SCALE OF ALTERED LIVING IN EUROPE ARE THE MUSLIM CITIES WITHIN CITIES — THOSE ENCLAVES INHABITED ENTIRELY BY MUSLIMS WITH THEIR OWN CIVIC AUTHORITY OVER BUSINESSES, SCHOOLS, RELIGION AND COURTS THAT ADMINISTER SHARIA LAW.

THE MISSING LINK

IN AMERICA, WHICH HAS NOT BEEN EXPOSED TO THE SAME DEGREE OF ISLAMIC OCCUPATION AND CONFRONTATION AS EUROPE, LIFE ON THE SURFACE GOES ON PRETTY MUCH AS IT HAS IN THE PAST; WE ARE STILL SEPARATED FROM EUROPE BY ABOUT 3,000 MILES OF ATLANTIC OCEAN AND A NO LONGER VALID "IT CAN'T HAPPEN HERE" MENTALITY. WE PROCLAIM THAT WE ARE BOTH A NATION OF LAWS AND ALSO OF IMMIGRANTS. IN CASE OF CONFLICT, WHICH WILL WE BE ?

WHAT IS MOST HORRIFYING ABOUT WCIV'S PLIGHT IN EUROPE HAS BEEN THE FAILURE OF NATIVE POPULATIONS TO MOUNT ANY EFFECTIVE RESISTANCE TO THE LOSS OF THEIR SOVEREIGNTY AND CIVIC AUTHORITY. THEY SEEM TO ACCEPT WITHOUT QUESTION OR CONTRADICTION THE REGULATIONS MADE IN BRUSSELS OR IN THEIR OWN CAPITALS THAT OFFER NO ALTERNATIVE TO THE RELENTLESS ADDITION OF MIGRANTS AND THEIR SUBSEQUENT SUPPORT WITH TAXPAYER FUNDS.

BEYOND THAT, THEY ARE UNABLE TO CONFRONT THE FAILURE OF THEIR ELECTED OFFICIALS, WHETHER IN ROTHERHAM OR SWEDEN, TO DELIVER LOCAL PUNISHMENT FOR CRIMES THAT CLEARLY DESERVE IT. SOMETHING VITAL IN THE FORM OF HUMAN SENSIBILITY AND EMPATHY HAS BEEN TURNED OFF IN THE MINDS OF LOCAL GUARDIANS OF OUR CULTURE AND OUR STATE WHEN THEY TURN A BLIND EYE TO THE SEXUAL ABUSE OF YOUNG GIRLS IN ORDER NOT TO OFFEND MUSLIM PERPETRATORS.

"...TIME AND HISTORY WILL NOT CONFIRM THE VISION OF A SAFE AMERICA..."

FOR REASONS WE SHALL PROVIDE LATER WE ARE NOT AS SAFE IN AMERICA AS WE CLAIM, AND ARE LED, TO BELIEVE. WHAT'S MORE, SOME WHO PROCLAIM OUR SAFETY MOST STRONGLY DO SO WITH AN AIR OF SMUGNESS AND SUPERIORITY. IF EUROPE CANNOT OFFER US A "TEACHING MOMENT" AND UNLESS WE BEGIN TO TAKE PROACTIVE MEASURES, TIME AND HISTORY WILL NOT CONFIRM THE VISION OF A SAFE AMERICA BEYOND REACH OF AW ELEMENTS.

THE EU'S FREQUENT CLAIMS OF UNITY AMONG ITS MEMBERS ARE NOT ALWAYS REAL AND SEEM TO PAPER OVER INTRACTABLE DIFFERENCES THAT HAVE RESISTED THE PROCESS OF ECONOMIC AND POLITICAL UNIFICATION, A NOTABLE EXAMPLE BEING THE MIGRANCY WAVE WHICH IS A CONTINENTAL PROBLEM THAT HAS PRODUCED A VARIETY OF RESPONSES IN THE COUNTRIES THAT HAVE BEEN EXPOSED TO IT.

TWO REACTIONS THAT ARE POLES APART OCCURRED RECENTLY — ONE IN WESTERN EUROPE AND THE OTHER ON ITS EASTERN EDGE. IN THE WEST, TOURISTS AND LOCALS ENJOYING A DAY AT A MEDITERRAENAN SPANISH BEACH WERE STARTLED BY THE ARRIVAL OF AN OPEN BOAT FROM AFRICA CONTAINING ABOUT 50 MIGRANTS WHO, WHEN IT REACHED THE BEACH, QUIETLY AND QUICKLY DISEMBARKED AND MADE THEIR WAY INLAND, SCATTERING INTO SMALL GROUPS OF ONE OR TWO INDIVIDUALS. IT WAS EVIDENT THAT SPANISH AUTHORITIES HAD MADE NO EFFORT TO TRACK, TURN BACK OR TAKE THIS VESSEL INTO CUSTODY. NOR DID THOSE ENJOYING THEIR TIME AT THE BEACH TAKE ANY ACTION TO ALERT POLICE OR IMMIGRATION CONTROL FORCES.

IN EASTERN EUROPE, FROM POLAND IN THE NORTH TO BULGARIA IN THE SOUTH, A DIFFERENT ATTITUDE IS FOUND. THERE, EUROPE'S EASTERN POPULATIONS WERE SUBJECTED TO A POSTWAR RUSSIAN COMMUNIST INVASION. AS IT HAS BEEN EASTERN EUROPE'S LOT TO DEFEND AGAINST ISLAMIC INVASIONS FROM THE SOUTH AS WELL AS OTHERS FROM RUSSIA AND ASIA TO THE EAST, IT HAS BEEN HARDENED BY HISTORY AND WANTS NO MORE OF INVASION, REGARDLESS OF ITS SOURCE OR CAUSE.

IN FEBRUARY, PRIME MINISTER VICTOR ORBAN OF HUNGARY, IN HIS ANNUAL STATE OF THE NATION SPEECH STATED THAT

“CHRISTIANITY IS EUROPE’S LAST HOPE” AND THAT THE CONTINENT’S POLITICAL LEADERS WHO FAVOR MIGRATION HAVE “OPENED THE WAY TO THE DECLINE OF CHRISTIAN CULTURE AND THE ADVANCE OF ISLAM”.

HUNGARY LIES ON THE NORTHERN RIM OF THE BALKANS AND ITS EASTERNMOST SECTOR SHARES ITS BORDERS WITH CZECHOSLOVAKIA ON THE NORTH, UKRAINE TO ITS EAST AND ROMANIA TO THE SOUTH. WHEN ANGELA MERKEL GREASED THE HINGES OF EUROPE’S GATES BY DECLARING GERMANY OPEN TO MEDITERRANEAN MIGRANTS, SHE TRANSFORMED A NORMAL WAR ZONE EXODUS INTO AN INTERCONTINENTAL INVASION OF WHICH ONE OF THE PREFERRED ROUTES CONSISTED OF LANDING IN GREECE, PROCEEDING NORTH THROUGH YUGOSLAVIA TO HUNGARY OR AUSTRIA AND CULMINATING IN GERMANY OR SCANDINAVIA.

ORBAN IMMEDIATELY RECOGNIZED THE SCALE OF THE CULTURAL THREAT POSED BY MILLIONS OF MUSLIMS RELOCATING TO EUROPE AND HAS CLEARLY PROTESTED ITS ACCEPTANCE BY THE UN AND EU. ONE COMMENT — “BORN GERMANS ARE BEING FORCED BACK FROM MOST LARGE CITIES, AS MIGRANTS ALWAYS OCCUPY BIG CITIES FIRST” — DREW WIDE DENIAL FROM UN AND EU BUREAUCRATS BUT GAINED CREDIBILITY A COUPLE OF WEEKS LATER (SEE BELOW).

IN HUNGARY’S NATIONAL ELECTIONS EARLIER THIS MONTH ORBAN WON WITH 67% OF THE POPULAR VOTE AND ESTABLISHED A COMMANDING MAJORITY IN HUNGARY’S PARLIAMENT. DURING HIS CAMPAIGN SOME EU OBSERVERS HAD DESCRIBED IT AS “INTIMIDATING AND XENOPHOBIC” WHICH ILLUSTRATES HOW OUT OF STEP THE EU CAN BE WITH VOTERS. ORBAN HAS PLEDGED TO RESIST THE MIGRANT INVASION IN EVERY WAY POSSIBLE. WILL HE BE ABLE TO PROVIDE THE EU WITH THE THOUGHT AND ACTION THAT WILL CAUSE THE BRUSSELS BUREAUCRACY TO SOFTEN ITS “COME ONE, COME ALL” ADMISSIONS POLICIES ? HIS LONELY WARNING CALLS AND PLEAS FOR ACTION ARE REMINISCENT OF CHURCHILL’S PREDICTIONS OF THE NAZI MENACE IN THE 1930S. WILL EUROPE’S RESPONSE BE ANY DIFFERENT ?

GERMANY — IN EARLY MARCH, MERKEL, WHO HAD STEADFASTLY DEFENDED HER ADMISSIONS POLICY AND DEFLECTED CRITICISM OF IT, STARTLED AN AUDIENCE SHE WAS ADDRESSING BY ADMITTING THERE WERE ZONES IN GERMANY WHICH LAW ENFORCEMENT OFFICERS DO NOT ENTER, EVEN THOUGH SHE HAD PREVIOUSLY DENIED THE PROBLEM EXISTED. AND, ADDING TO HER ADMISSION, SHE STATED THAT PLANNING IS TAKING PLACE TO DESIGN AND IMPLEMENT A PROGRAM THAT WILL ELIMINATE THE PROTECTIONS THESE AREAS PROVIDE FOR CRIMINAL ACTIVITIES.

BECAUSE OF HER KEY ROLE IN THE ONGOING MIGRANCY CRISIS, MERKEL’S ATTITUDES AND ACTIONS CARRY GREAT WEIGHT. IS THERE STILL A FAINT WESTERN PULSE THAT CAN BE RECLAIMED, ENERGIZED AND RESTORED ? PRESSURE BUILDS AS MIGRANT POPULATIONS GROW IN THEIR SIZE AND THEIR DEMANDS, WORKING THEIR WAY FROM EUROPE’S MEDITERRANEAN AND EASTERN EDGES TO THE INTERIOR. SOON, FATEFUL DECISIONS WILL HAVE TO BE MADE IN GERMANY AND ITALY ON MATTERS THAT REFLECT A CONTINENT UNDER SIEGE — MATTERS WHICH THE EU’S FOUNDERS COULD NOT IMAGINE AND ONE ON WHICH BRUSSELS NOW FINDS LITTLE AGREEMENT FOR A PLAN OF CONCERTED ACTION.

EUROPE’S LACK OF RESPONSE TO THE PRESENT ATTACK ON

WCIV IS PARTIALLY DUE TO ITS POLITICAL HISTORY. WE SHOULD REMEMBER THAT IT WAS THE BIRTHPLACE OF MARXIST SOCIAL AND ECONOMIC THEORY WHICH ENERGIZED THE POLITICAL GROWTH OF SOCIALISM AND COMMUNISM; AND IT WAS ONLY AS RECENTLY AS A CENTURY AGO THAT THESE AND OTHER FORCES COMBINED TO END THE ANCIENT MONARCHICAL SYSTEM OF RULE UNDER WHICH CONTEMPORARY EUROPE HAD EVOLVED. IN 19TH AND EARLY 20TH CENTURY AMERICA WE LACKED BOTH EUROPE’S HISTORICAL RELATION TO MARXISM AND THE SYSTEM OF ROYAL POWER AND PRIVILEGE WHICH IT HELD RESPONSIBLE FOR MUCH OF THE INJUSTICE AND INEQUALITY OF THAT TIME.

OUR OWN EXPOSURE TO MARXIST POLITICAL ACTIVITY AT MORE THAN A TOKEN LEVEL ARRIVED WITH DISPLACED EUROPEAN ACADEMICS DURING OUR GD AND THEN EXPANDED IN SIZE AND IMPACT IN THE POSTWAR PERIOD OF INTENSE, GLOBAL ATTEMPTS TO SEED AND PLANT WORLD COMMUNISM BY RUSSIA AND CHINA. AND, ALTHOUGH WE WERE FULLY ENGAGED WITH EUROPEAN ALLIES IN RESISTING THESE EFFORTS, EUROPE’S EXPERIENCE OF MARXIST POLITICAL EXPRESSION, BOTH SOCIALIST AND COMMUNIST, WAS MORE LASTING AND ACCEPTED THAN OURS.

* * *

“IN THE GAME OF HISTORY, LONG OR SHORT, SUCH LAPSSES ARE MARKED WITH A VERY HIGH PRICE TAG.”

THE MISSING LINK BETWEEN EUROPE’S NON-REACTION TO ATTACKS UPON WCIV AND OUR DISTURBINGLY SIMILAR ATTITUDE MAY NOT BE MISSING AT ALL. IT MAY JUST BE UNRECOGNIZABLE TO BOTH BECAUSE, IN ADDITION TO ALLOWING OURSELVES TO BE DECEIVED BY OTHERS, WE HAVE DECEIVED OURSELVES. IN THE GAME OF HISTORY, LONG OR SHORT, SUCH LAPSSES ARE MARKED WITH A VERY HIGH PRICE TAG.

LOOKING AT A MAP OF THE WORLD TODAY PROVIDES CRITICAL INFORMATION REGARDING THE REAL STATE OF WCIV. THEORETICALLY, IT COMPRISES EUROPE, ALL OF OUR WESTERN HEMISPHERE AND AUSTRALIA, BUT NOT ALL PARTS ARE EQUAL. OVER 90% OF AUSTRALIA’S POPULATION RESIDES IN A BAND ALONG ITS COAST WHILE ITS ‘INTERIOR’ IS ONLY VERY SPARSELY INHABITED DUE TO CLIMATE AND RESOURCE CONDITIONS. CANADA’S SITUATION IS SIMILAR WITH ITS POPULOUS AREAS LIMITED TO ITS SOUTHERN AREA ABOVE WHICH POPULATION AND TEMPERATURE NUMBERS DROP SHARPLY AS THEY MOVE TO THE NORTH.

CENTRAL AND LATIN AMERICA ARE INCLUDED IN WCIV BECAUSE OF THEIR IBERIAN LANGUAGES AND THE EXTENSIVE PRESENCE OF THE CATHOLIC CHURCH, BUT BOTH WERE COLONIAL ADD-ONS TO NATIVE MAYAN/INCA CULTURES THAT SHARED NO ROOTS WITH THE WEST; AND IN ADDITION TO THESE DIFFERENT CULTURAL ORIGINS OUR HEMISPHERE’S SOUTHERN LANDMASS CONTAINS LARGE SWATHS OF TROPICAL JUNGLE, A HIGH MOUNTAIN RANGE THAT RUNS ITS ENTIRE WESTERN FACE, HAS HAD A TENUOUS EXPERIENCE WITH REPRESENTATIVE GOVERNMENTS AND HAS LONG SUFFERED FROM CORRUPTION, ILLITERACY AND POVERTY.

FROM VIEWING OUR GLOBAL MAP, IT IS FOR MOSTLY NATURAL REASONS THAT AUSTRALIA, CANADA AND CENTRAL/SOUTH AMERICA ARE PERIPHERAL, NOT CENTRAL, ELEMENTS OF WCIV, THAT EUROPE HAS BEEN BOTH ITS BASE AND ITS HEART AND THAT, UNLESS EUROPE CAN GATHER STRENGTH FROM ITS EXTRAORDINARY PAST, IT WILL SUCCUMB AND THE U.S. WILL BE ISOLATED AND BEAR THE IMMENSE BURDEN OF BEING WCIV'S SOLE DEFENDER.

KNOW THE ENEMY

WHAT ARE THE FORCES THAT ARE ALIGNED AGAINST THE WEST ? FIRST AND MOST DANGEROUS IS ISLAM'S LATEST EFFORT (EMPLOYING MODERN SOCIAL, POLITICAL AND MILITARY MEANS) TO BREAK OUT OF ITS MEDITERRANEAN AND ASIAN HOMELANDS AND EXTEND ITS UNCOMPROMISING ATTITUDES AND PRESENCE TO ALL OF EUROPE AND THE U.S. WE LABEL ISLAM "MOST DANGEROUS" BECAUSE IT REJECTS ASSIMILATION AND AIMS TO REPLACE THE POLITICS, LAWS, GOVERNMENT AND CULTURE OF WESTERN COUNTRIES WITH ITS OWN VERSIONS AS SPECIFIED IN THE QUR'AN.

MODERN TECHNOLOGY HAS MADE THE FULL-BORE TYPE OF INFILTRATION PRACTICED BY ISLAM MORE LIKELY TO SUCCEED, AS VISUAL IMAGES GIVE EVIDENCE OF PROGRESS AND ACHIEVEMENTS THAT ENCOURAGE PARTICIPATION BY BOTH YOUNGER AND MORE MODERATE ELEMENTS. AND, BEYOND THE DAILY STRUGGLE IN GOVERNMENT DEPARTMENTS AND THE MUSLIM RESIDENTIAL ENCLAVES, ISLAM'S HIGH FERTILITY PRACTICE IS QUIETLY, BUT CONFIDENTLY, PREPARING TO COMMAND THE FUTURE.

OTHER INTERESTS THAT THREATEN WCIV COMBINE UNDER THE COLLECTIVE TITLE OF "GLOBALISTS". THEIR PURSUITS ARE PRIMARILY COMMERCIAL IN THE REALMS OF TRADE, FINANCE, PRODUCTION AND THE POWER THAT ATTACHES TO THESE ACTIVITIES. MANY GLOBALISTS HAVE BACKGROUNDS IN BANKING, MANUFACTURING AND INTERNATIONAL LAW WHICH PROVE USEFUL IN DEVELOPING AND SECURING THE MAXIMUM REWARDS POSSIBLE FROM WORLD TRADE.

THE GLOBALISTS' OPPOSITION TO WCIV IS FOCUSED ON POLITICAL/COMMERCIAL BARRIERS TO TRADE SUCH AS BORDERS, SOVEREIGNTY, TARIFFS, WAGES, LABOR AVAILABILITY, ENERGY AND EVEN SECURITY — MOST OF WHICH ARE SUBJECT TO NATIONAL REGULATION. IDEALLY, GLOBALISTS WOULD PREFER THAT WORLD TRADE TAKE THE FORM OF A CALM, UNIMPEDED FLOW WITH OCCASIONAL IRREGULARITIES DEALT WITH BY A SMALL, EFFICIENT OVERSIGHT GROUP COMPOSED OF FELLOW GLOBALISTS.

THE "ONE SIZE FITS ALL" GOAL HAS BEEN PURSUED BY IMPERIAL CONQUERORS AND AGGRESSIVE THOUGHT SYSTEMS (I.E., ISLAM, COMMUNISM, ETC.) THROUGHOUT HISTORY, AND GLOBALIST EFFORTS TO REGULATE WORLD TRADE CAN BE SEEN AS A COMMERCIAL VARIANT OF IT. REGARDLESS OF ITS SPONSOR, OR HOW AND WHERE IT IS IMPOSED, OR WHETHER IT IS STATED OR NOT, THIS PURSUIT OF UNIFORMITY IS INTENDED TO CIRCUMVENT THE BORDERS, ERASE THE IDENTITIES AND ALTER THE CULTURES OF NATIONS AND THEIR PEOPLE. WCIV WITH ITS MANY FREEDOMS AND DIFFERENCES IS AN INVITING TARGET.

FINALLY, AND MOST IMPORTANTLY FROM OUR VIEWPOINT, IT IS NOT JUST ECONOMIC AND POLITICAL LIFE THAT FOLLOWS AND IS DETERMINED BY BOUNDARIES. CULTURE, TOO, IS BOTH A FOLLOWER AND FORMER OF HISTORICAL PATTERNS. IT IS NOT AS EASILY MOVED OR TRANSFORMED AS BOUNDARIES ARE BY CONQUEST OR PURCHASE, BUT IT IS EVER PRESENT IN THE DETERMINATIONS OF HISTORY AND THE IDENTITIES OF PEOPLE EVERYWHERE.

"...CAMOUFLAGE FAILS AND CULTURE ENDURES."

GLOBALISTS FAIL, IN OUR OPINION, BECAUSE THEIR COMMERCIAL POLICY VALUES ARE NOT INTRINSIC, BUT DERIVE FROM THE MONEY AND POWER THEY ARE ABLE TO DELIVER. THIS HAS NOT BEEN READILY APPARENT IN OUR POSTWAR WORLD AND MANY TRADE CONFERENCES, TREATIES, ORGANIZATIONS, PACTS, COMMITTEES, ETC. HAVE BEEN FORMED WITH, IF NOT THE INTENTION, THEN SURELY THE EFFECT OF CAMOUFLAGE. IN TIME, THE GLOBALISTS WILL LEARN THAT CAMOUFLAGE FAILS AND CULTURE ENDURES.

* * *

OUR FIRST CATEGORY, ISLAM, WAS RELIGIOUS; THE SECOND, GLOBALISM, CENTERS ON WORLD TRADE AND IS OF A COMMERCIAL NATURE. THE LAST CATEGORY IS A POLITICAL ONE COMPOSED OF MANY DIFFERENT ENTITIES ALL SHARING AND DIRECTING VARYING AMOUNTS OF HATE AND RESENTMENT TOWARDS WCIV. THESE ARE OFTEN SPECIFIC ISSUE, OPEN BORDERS, PRO-IMMIGRATION FORCES DEDICATED TO REPLACING WCIV'S PREDOMINANTLY WHITE EUROPEAN POPULATIONS WITH A MIXTURE OF THIRD WORLD ETHNICITIES COLLECTIVELY DESCRIBED AS "PEOPLE OF COLOR".

BEYOND THE IMMIGRATION ISSUE THERE ARE INNUMERABLE CAUSES AND COHORTS THAT DEEPLY RESENT WCIV'S CULTURAL, ECONOMIC, INTELLECTUAL AND POLITICAL ACHIEVEMENTS AND ITS POSITION OF WORLD LEADERSHIP. THEY WANT THE WEALTH, THE TERRITORY, THE FOOD/WATER RESOURCES, THE POLITICAL POWER AND THE STATUS THAT WCIV HAS ACCUMULATED. AND OVER TIME THEY WANT TO DILUTE AND ERASE WESTERN CULTURE SO THAT IT CAN BE REPLACED WITH THEIR OWN. ON THE CULTURAL FRONT ISLAM IS BY FAR WCIV'S STRONGEST AND MOST HOSTILE OPPONENT BOTH IN NUMBERS AND IN MOTIVATION.

THESE VARIOUS GROUPS OF DIFFERING SIZE AND INTERESTS OCCUPY POLITICAL SPACE SIGNIFICANTLY LEFT OF CENTER. THEY COME AND GO AND INTERMITTENTLY FUNCTION AS PART OF THE LIBERAL LEFT (LL) UMBRELLA IDENTITY. THIS IS OF MAJOR IMPORTANCE BECAUSE THIS ALLIANCE PROVIDES ITS MEMBERS WITH MESSAGING AND PLANNING ASSISTANCE AS WELL AS BENEFITS THAT CAN DERIVE FROM BEING A SMALL PART OF A LARGER WHOLE. IN THE ACTIVITIES OF THE LL AT EVERY LEVEL OF OPERATION — NATIONAL, REGIONAL OR GLOBAL — CROSS FERTILIZATION IS FOSTERED SO THAT TECHNIQUES OR SYSTEMS THAT WORK WELL IN ONE AREA CAN DO THE SAME IN OTHERS.

WHEN WE MENTION WEAPONS WE TEND TO THINK MOSTLY IN TERMS OF HARDWARE — THE LONG BOW, THE RIFLE, ARTILLERY, TANKS AND BOMBS. SOME ARE SO SUCCESSFUL THAT THEY CAN ALTER THE COURSE OF BATTLE — AND HISTORY ! THE DESIGN OF OTHERS MAY ALLOW TARGETS TO EMPLOY A SUCCESSFUL DEFENSE AND MAY REDUCE THE ACT OF BATTLE TO A STALEMATE OR WITHDRAWAL.

IN THE PRIMARILY CULTURAL ATTACK ON WCIV, AS IN MILITARY WARFARE, THE AVAILABILITY AND CHOICE OF WEAPONS HAS PLAYED A CRITICAL ROLE, AND TWO — PC AND MULTICULTURALISM (MC) — HAVE BEEN VERY EFFECTIVE IN SILENCING OPPOSITION AMONG THE GENERAL PUBLIC AND ALSO IN GOVERNMENT CIRCLES WHERE WE MIGHT EXPECT OUR POLITICAL APPARATUS TO MOUNT A CONCERTED COUNTER-ATTACK.

“CONGRESS SHALL MAKE NO LAW ...ABRIDGING THE FREEDOM OF SPEECH, OR OF THE PRESS; ...”⁶

THE BROAD AND CONTINUING ATTACK BY THE AW IN THE 20TH AND THE PRESENT CENTURY HAS BEEN CONDUCTED IN OUR FULL VIEW AND WITH THE PERMISSION CLAIMED TO BE GRANTED ABOVE BY OUR CONSTITUTION. THERE IS NOTHING MORE BASIC TO OUR CULTURE, OUR GOVERNMENT OR OUR IDENTITY. IT HAS BEEN A KEY PART OF OUR HISTORY. WE HAVE FOUGHT AND DIED FOR IT. IT IS WHO WE ARE, A RIGHT WE EXTENDED TO ALL KNOWING IT WOULD BE ABUSED BY SOME AND TURNED AGAINST US.

AND ARGUABLY THE MOST SUCCESSFUL FORM OF SUCH ABUSE HAS BEEN OUR OPPONENTS’ PRACTICE OF PC BY WHICH THEY ATTACK, EVADE OR DISCREDIT OUR LAWS AND INSTITUTIONS UNDER THE PROTECTION OF FREE SPEECH AND, WHEN WE RESIST, SHUT US DOWN WITH ACCUSATIONS OF “WHITE SUPREMACY”, “RACISM”, “HATE SPEECH” AND OTHER REFUTATIONS THAT THEY CLAIM ARE ASSURED BY THEIR CONSTITUTIONAL RIGHTS.

IN SUCH INSTANCES OUR RIGHTS HAVE BECOME THEIRS. WE HAVE SEEN PC’S APPLICATION IN EVERY PART OF OUR WORSENING IMMIGRATION PROBLEM WHERE “RIGHTS” CLAIMED BY MIGRANTS UNDER OUR CONSTITUTION ARE USED TO CHALLENGE AND UNDERMINE IT. THIS HAS BEEN A FAVORITE TACTIC OF MUSLIM MIGRANTS WHO CLAIM REFUGEE AND ASYLUM STATUS FOR ENTRY AND RESIDENCY HERE, AND THEN LITIGATE IN COURT AGAINST OUR LAWS THAT DO NOT ACCEPT THEIR RELIGIOUS AND SOCIAL DICTATES.

MC AIMS TO DIVIDE ALL PEOPLES AND CULTURES INTO EVER SMALLER AND MORE NUMEROUS UNITS OF THE SAME CULTURAL AND POLITICAL VALUE. THIS IS NOTHING LESS THAN A RESTATEMENT OF THE HISTORIC SOCIALIST GOAL IN MODERN DRESS, AND IT IS GIVEN FUNCTIONAL SUPPORT BY PC’S PRIMARY RULE OF ENGAGEMENT THAT ALL GROUPS/INDIVIDUALS — REGARDLESS OF RELIGION, RACE, GENDER, ETHNICITY, SEXUAL IDENTITY, NATIONALITY, POLITICAL BELIEF, ETC. — BE TREATED EQUALLY AND IN WAYS OF UNIVERSAL RESPECT AND DIGNITY FROM WHICH NO OFFENSE MUST BE GIVEN, OR TAKEN.

STRANGELY FOR AMERICA, TOO MANY OF OUR CITIZENS AND ELECTED LEADERS HAVE BEEN COWED AND GULLED BY THE AW FORCES’ USE, OR EVEN THREAT, OF MC/PC TACTICS. THEIR COMPLIANCE HAS STIFLED OUR TRADITIONAL AMERICAN RESISTANCE TO ATTACK.

TWICE IN OUR LIFETIME — AT PEARL HARBOR AND THE WORLD TRADE CENTER — WE HAVE SUFFERED A GRIEVOUS AND UNPROVOKED ASSAULT UPON OUR PEOPLE, GOVERNMENT AND CULTURE, AND ON EACH OCCASION OUR LEADERS MADE THE PROMISE OF “NEVER AGAIN”. BUT “AGAIN” IS NOW HERE. THE PLANES THAT BOMBED OUR FLEET AND FLEW INTO THE TWIN TRADE TOWERS ARE ABSENT BUT WE FACE A THREAT THAT MOVES AMONG US DAILY — IN THE MSM, IN OUR GOVERNMENT, IN OUR IMMIGRANT ARRIVALS, IN OUR CHURCHES AND WORKPLACES AND (MOST SADLY, PERHAPS, BECAUSE THEY TEACH OUR CHILDREN) IN OUR SCHOOLS AND COLLEGES WHERE THE THOUGHT AND LANGUAGE ENFORCERS OF PC ARE HARD AT WORK.

PC WAS FIRST INTRODUCED TO THE WORLD’S POLITICAL VOCABULARY BY KARL MARX IN 1921 AND HAS BEEN GREATLY EXTENDED IN ITS MEANING AND USAGE IN THE NEAR CENTURY SINCE THEN. LIKE OTHER ASPECTS OF THE LL AGENDA, IT AIMS TO ELIMINATE MOST OF THE DIFFERENCES IN OUR EXPERIENCE OF LIFE THAT HAVE MARKED THE WEST’S REMARKABLE PROGRESS OVER TWO MILLENNIA.

AT THE HEART OF PC’S LEVELLING PROCESS IS THE ASSERTION THAT ALL CULTURES ARE EQUAL AND MUST BE SO RECOGNIZED BY MEN AND GOVERNMENTS. BY EXTENSION, IF ALL CULTURES ARE EQUAL, THEN THEIR PEOPLE, ART, LAWS AND GOVERNMENTS MUST ALSO BE EQUAL; AND BY FURTHER EXTENSION, THE REWARDS OBTAINED FROM OUR SOCIETY MUST BE DISTRIBUTED IN PROPORTION TO NUMBERS/VALUES OF EACH SUBSET.

THIS EFFECTIVELY PLACES A SOCIO-ECONOMIC FLOOR OR SAFETY NET TO SUPPORT OUR SOCIETY’S LOWEST LEVELS AND STATES THAT ALL SOCIAL MOVEMENT MUST BE UPWARDS. PC CLAIMS TO ELEVATE THE STATUS OF BOTH THE MINORITY GROUP AND INDIVIDUAL IN WAYS THAT PRODUCE STRONG EMOTIONAL AND POLITICAL RESPONSES AND ARE NOT READILY REFUTED.

MC STARTS FROM A DIFFERENT PLACE, BUT THEN WORKS BACK TOWARDS PC. IT TARGETS MINORITIES TO CELEBRATE THEIR ORIGINS AND MAINTAIN THEIR IDENTITY IN AMERICA’S ENORMOUS MIX OF TRIBES AND CULTURES. THIS IS AN ACT OF DIVISION WHICH SETS UP MEETINGS, COMMUNICATES IN THE NATIVE LANGUAGE, ENCOURAGES CONTACTS WITH RELATIVES IN THE HOME COUNTRY AND ARRANGES COMMUNAL EVENTS THAT ARE MINORITY SPECIFIC.

THE INTENTION OF MC IS TO EMPHASIZE MINORITY SEPARATENESS AND TO KEEP THESE GROUPS FROM MOVING TOWARDS THE MAIN STREAM. BY DOING THIS MC CAN RETAIN POLITICAL CONTROL OVER THESE GROUPS AND, AS TIME PASSES, SHIFT THEIR POLITICAL AWARENESS OF THEMSELVES FROM THEIR NATIVE ORIGINS TO BEING PART OF A LARGER AND MORE POWERFUL BODY OF MINORITY CULTURES.

BOTH METHODS, MC AND PC, PLAY ON THE FEAR AND UNCERTAINTY THAT NEW ARRIVALS FACE. FOR ITS FIRST CENTURY, OUR IMMIGRATION POLICY WAS BASED ON LIMITED ADMISSIONS WITH THE GOAL OF ASSIMILATION AND WORKED VERY WELL, BUT THE 1965 ACT’S GREATLY INCREASED NUMBERS HAVE DIMINISHED

* * *

ANY MENTION OF AW TECHNIQUES MUST INCLUDE THE ACCUSATION OF RACISM AS A KEY ELEMENT OF WCIV. WHEREAS MC AND PC ARE EMPLOYED IN SITUATIONS OF CHOICE, “RACISM” AS A LABEL OF SUPREME EVIL HAS “GONE GLOBAL” AND IS NOW USED AS A GENERAL TERM OF CONDEMNATION IN CIRCUMSTANCES AND FOR EFFECT THAT FAR SURPASS ITS ORIGINAL MEANING. IN MILITARY TERMS, THE ATTACK AGAINST WCIV BY BOTH PC AND MC MAY BE SEEN AS TACTICAL WEAPONS LIKE PLANES OR TANKS; THE CHARGE OF “RACISM” IS LIKE THE UBIQUITOUS FOOT SOLDIER — MANY IN NUMBER, ALWAYS ON CALL, THE FACE OF THE WAR.

THERE IS ANOTHER WEAPON WHICH WE HAVE ALLOWED THE AW TO USE AGAINST US. IT IS THE PHRASE “WE ARE A NATION OF IMMIGRANTS”, AND WE HAVE BEEN BLUDGEONED BY IT FOR SO LONG THAT MANY AMERICANS ACCEPT IT AS TRUTH.

IT IS NOT TRUE, EVEN ‘THOUGH ITS PROPONENTS HAVE MANAGED TO INSERT IT, WITH LITTLE OR NO RESISTANCE FROM THE AMERICAN PEOPLE OR THEIR POLITICAL AND ACADEMIC LEADERS, INTO OUR CONVERSATION ABOUT THE HISTORY AND FUTURE OF OUR AMERICAN CULTURE AND WCIV.

THE TRUTH IS THAT PRIOR TO OUR CIVIL WAR OUR NEW COUNTRY SHOWED LITTLE INTEREST IN IMMIGRATION. MOST OF OUR FOUNDERS HAD OPPOSED IT AND IT WAS SUBJECT TO A MIXTURE OF STRICT FEDERAL/STATE REGULATIONS. IN 1864 CONGRESS CREATED AN AGENCY TO MONITOR IMMIGRATION POLICY AND IN 1882 PASSED LEGISLATION THAT ESTABLISHED FEDERAL CONTROL OVER ITS IMPLEMENTATION.

FROM THAT TIME UNTIL 1965, IMMIGRATION WAS REGULATED AS AN ECONOMIC INSTRUMENT TO CONTROL THE NATION’S LABOR SUPPLY AND WAGES. IT WAS NOT KEYED TO HUMANE EFFORTS TO “RIGHT” THE WORLD’S ECONOMIC, ETHNIC OR SOCIAL “WRONGS”. IT WAS ABOUT LABOR AND WAGES AND THEN, AS WW II APPROACHED, ALSO ABOUT NATIONAL SECURITY. THERE WERE OCCASIONAL FLUCTUATIONS IN NUMBERS, AND ADJUSTMENTS IN LANGUAGE UNTIL IN 1965, AS PART OF THE JOHNSON ADMINISTRATION’S GREAT SOCIETY, OUR IMMIGRATION LAW WAS TOTALLY CHANGED.

THE PHRASE, “A NATION OF IMMIGRANTS”, GIVES THE IMPRESSION THAT, AS FAR BACK AS THE BEGINNING OF OUR NATIONALITY, IMMIGRANTS COMPRISED AN IMPORTANT, IF NOT ESSENTIAL, ELEMENT OF OUR POPULATION. THIS IS NOT SO. AMERICA IN 1789 HAD FOUGHT AND WON A REVOLUTION BY AMERICANS SEEKING INDEPENDENCE FROM THE BRITISH CROWN. IT ENJOYED THE BENEFITS OF AN ECONOMY SUPPORTED BY A MIX OF TRADE, AGRICULTURE AND INDUSTRY DEVELOPED OVER A CENTURY AND A HALF BY THE ORIGINAL COLONISTS AND THEIR ISSUE.

THE STORY OF AMERICAN IMMIGRATION UNTIL 1965 IS REMARKABLE BECAUSE OF ITS SCOPE, METHODS, PURPOSE AND SUCCESS. IT WAS BASED ON THE NEEDS OF BOTH THE IMMIGRANT AND THE NATION. THESE WERE JOINED IN THE GOAL OF ASSIMILATION WHICH PROVIDED BENEFITS TO INITIAL AND FUTURE GENERATIONS UNTIL 1965 WHEN IT WAS EFFECTIVELY ABANDONED. BY THIS LEGISLATION THE PURPOSE OF IMMIGRATION WAS

CHANGED AND THE POWER TO DETERMINE ITS NUMBERS, SOURCES AND OTHER ASPECTS OF POLICY PASSED FROM THE GOVERNMENT TO THE MIGRANT. OUR REMARKABLE IMMIGRATION TALE ENGAGES OUR AMERICAN HISTORY, CULTURE, POLITICS AND CHARACTER IN MANY WAYS. IT SHOULD BE TOLD AND RETOLD NOW AND IN THE FUTURE TO INFORM THE AMERICAN PEOPLE AND TO DISPROVE THE AW CLAIM THAT “WE ARE A NATION OF IMMIGRANTS” WHICH IS NOT ONLY FALSE, BUT WHICH ALSO DRAWS LINES OF DIVISION AND INFERS SUPERIOR STATUS TO IMMIGRANTS I.E. — IF WE ARE “A NATION OF IMMIGRANTS”, WHAT IS THE PLACE OR VALUE OF A NON-IMMIGRANT ?

THESE ARE ONLY A FEW WAYS BY WHICH THE WAR AGAINST WCIV IS WAGED. THERE ARE MANY OTHERS DESIGNED TO CREATE VULNERABILITIES AND TO SWAY PUBLIC OPINION. THE QUESTION THE WEST CANNOT EVADE ANY LONGER IS “HOW HAVE THEY SUCCEEDED TO THEIR PRESENT LEVEL ?”

MEA CULPA

AMONG THE WORLD’S BILLIONS OF PEOPLE AND MULTIPLE CULTURES THERE IS NO SHORTAGE OF LEADERS, CAUSES, BORDERS, TRIBES, RELIGIONS OR OTHER FORCES THAT WOULD LIKE TO EXPAND THEIR REACH AT THE EXPENSE OF WCIV. EVERY SUCCESSFUL CULTURE ATTRACTS THE ENVY AND RESENTMENT OF THOSE THAT STAGNATE, SHRINK AND FAIL. IN PRIOR YEARS THIS PROCESS WAS MORE REMOTE AND LESS VISIBLE. NOW, VIA THE MIRACLE OF OUR ELECTRONIC AGE, IT OCCURS 24/7 IN FULL VIEW GLOBALLY.

WE REGARD EUROPE TODAY, LAMENT ITS DECLINE IN THE VALUES AND STRENGTHS WE SHARE AND ASK, “HOW COULD THIS HAPPEN ? WHY DID NO ONE DO ANYTHING TO PREVENT IT ?” THE ANSWER IS NOT A STATEMENT, IT IS ANOTHER QUESTION — “WHY DON’T WE ?” — AND THE ANSWER IS THAT BEGINNING IN THE LATE 19TH CENTURY, WITH DISCOVERIES SUCH AS THE TELEGRAPH, OIL, ELECTRIC LIGHT AND TELEPHONE, OUR TECHNOLOGICAL PROGRESS ACCELERATED AT A RATE CONSIDERABLY GREATER THAN OUR HUMAN PROGRESS. THESE ADVANCES, WHICH EMPHASIZED DIFFERENCES BETWEEN THE WEST AND LESSER CULTURES, WERE FELT THROUGHOUT THE WORLD — OFTEN IN FORMS OF SOCIAL, ECONOMIC OR POLITICAL UPHEAVAL. AND THEY DEEPENED THE DIVISIONS BETWEEN THE WEST AND THE REST OF THE WORLD’S MORE NUMEROUS POPULATIONS. THESE DIVISIONS WERE EXPLOITED BY THE COVERT ACTIONS OF AW GROUPS, WHOSE APPEAL WAS GENERALLY UNDERESTIMATED HERE AND IN EUROPE, WITH THE RESULT THAT TOO OFTEN ONLY MODEST RESPONSES WERE MADE TO EFFORTS TO DESTROY, WEAKEN, OR COMPROMISE THE WORKINGS OF OUR GOVERNMENT AND THE PROTECTIONS IT IS CHARGED TO PROVIDE FOR ITS CITIZENS.

* * *

THE ATTACKS AGAINST WCIV ARE REAL. WITH NO REASON TO EXPECT THAT THEY WILL DIMINISH, ANY FURTHER ABDICATION OF OUR NATION’S LEADERS WILL ENSURE DISASTER, AS WE ARE THE

“LAST, BEST HOPE OF EARTH”⁷ AND WILL HAVE TO BOTH PROTECT OURSELVES AND RALLY EUROPE’S PEOPLES AND GOVERNMENTS TO OUR COMMON CAUSE.

AND JUST AS OUR POLITICAL CLASS HAS FAILED US, SO ALSO HAS OUR PUBLIC/PRIVATE EDUCATIONAL SYSTEM. THIS IS ANOTHER EVENT IN THE TALE OF WCIV’S DECLINE THAT HAS RESULTED FROM BOTH EXTERNAL ATTACKS AND INTERNAL ERRORS WHICH WE WILL EXPLORE IN FUTURE CHAPTERS. FOR THE PRESENT, WE ARE FACED WITH INITIATING A NATIONAL EFFORT THAT WILL PRESSURE OUR LEADERS INTO RECOGNIZING THE PRESENT THREAT, CONFRONTING ITS SOURCES AND TAKING COUNTER MEASURES TO REDUCE IT NOW AND TERMINATE IT IN THE FUTURE. NOT EASY, BUT NOT IMPOSSIBLE.

THE WAY AHEAD – HOW?

THE EFFORT NOW NEEDED TO DEFEND WCIV IS NOTHING LESS THAN ENORMOUS. IDEALLY, IN AN OPEN SOCIETY SUCH AS OURS, WE WOULD CALL UPON THE MSM’S SPEED AND FREQUENCY TO ESTABLISH PUBLIC AWARENESS OF OUR MESSAGE. THIS OPTION, HOWEVER, IS NOT REALISTIC, AS THE MSM WILL ALIGN ITSELF AGAINST OUR PURPOSE. WE MUST, THEREFORE, APPROACH OUR TASK FROM A DIFFERENT PERSPECTIVE:

THE BASIC ELEMENT IN A HUMAN GROUP OF ANY TYPE — NATION, TRIBE, SOCIETY — IS ITS PEOPLE.

GOVERNMENTS CONTROL PEOPLE BY CREATING LAWS AND REGULATIONS THAT LIMIT INDIVIDUAL BEHAVIORS IN FAVOR OF GROUP COHESION AND ITS BENEFITS.

POLITICIANS CONTROL GOVERNMENTS BY SECURING SUFFICIENT SUPPORT, TO ATTAIN PUBLIC OFFICE AND THEN MANAGING THE KEY GOVERNMENT FUNCTIONS.

POLITICAL PARTIES CONTROL POLITICIANS BY THEIR MONEY, TECHNIQUES, IDEOLOGY AND, IN REPRESENTATIVE GOVERNMENTS, THEIR POWER TO DETERMINE ACCESS TO THE ELECTORAL BALLOT.

BEYOND OUR ELECTORAL SYSTEM, THERE IS ONLY ONE FORCE POWERFUL ENOUGH TO CONTROL POLITICIANS, THEIR PARTIES AND THE GOVERNMENTS THEY FORM. THIS FORCE IS THE POPULAR MOVEMENT (POMO). IN THE FIRST TWO CENTURIES OF OUR POLITICAL LIFE ITS FORMATION, ADVOCACY AND COMMUNICATION WERE DIFFICULT AND ITS SUCCESSES WERE SPORADIC. NOW, THANKS TO THE SEEMINGLY LIMITLESS VERSATILITY OF OUR ELECTRONIC COMMUNICATIONS TECHNOLOGY, NO AMERICAN IS UNREACHABLE, NOR ANY MESSAGE UNCONVEYABLE.

AN AMERICAN DEFENSE OF WCIV WILL INITIALLY REQUIRE THAT ITS LEADERS IDENTIFY AND ENERGIZE A FEW KEY ELEMENTS WITHIN OUR CULTURE TO SERVE AS ITS NUCLEUS. THIS SHOULD NOT BE DIFFICULT, AS THERE ARE MANY INDIVIDUALS AND ORGANIZATIONS WHO HAVE FREQUENTLY AND SEPARATELY EXPRESSED THEIR OPINIONS AND CONCERNS OVER OUR LACK OF ANY COORDINATED RESPONSE TO AW ATTACKS.

ONCE THE MOST BASIC STRUCTURE AND DIRECTION ARE IN PLACE, THEN AND ONLY THEN, SHOULD THE NEXT CRITICAL STEP — TO BECOME A POMO — BE TAKEN. FROM THIS POINT FORWARD

ONLY TWO THINGS CAN BE ASSURED — THE POMO WILL, AS IT GROWS AND SUCCEEDS, TAKE ON A FORCE AND SHAPE OF ITS OWN; AND SECONDLY, THE AW WILL INCREASE THEIR EFFORTS

THE ONLY WAY AVAILABLE TO WCIV TO RESIST THE INCREASING NUMBER AND VARIETY OF ATTACKS AGAINST IT IS TO INITIATE A POMO IN AMERICA USING THE INTERNET AND OTHER ELECTRONIC AND PRINT TECHNIQUES CURRENTLY AVAILABLE TO:

1. ANNOUNCE ITS PRESENCE AND ISSUE A PURPOSE STATEMENT.
2. ATTRACT MEMBERS AND FINANCIAL SUPPORT.
3. DESCRIBE THE WAYS AND MEANS OF THE AW ATTACKS ON WCIV SO THAT WCIV SUPPORTERS CAN RECOGNIZE THEM IF THEY APPEAR IN LOCAL MEDIA IN DISGUISED FORM.
4. IDENTIFY WHENEVER POSSIBLE SOURCES BEHIND ATTACKS ON WCIV REGARDLESS OF WHETHER THEY ARE OF RELIGIOUS, SOCIAL, CHARITABLE OR POLITICAL ORIGINS.
5. CONDUCT THE EXTENSIVE SEARCH AND PUBLIC RELATIONS EXERCISES NECESSARY TO CREATE AWARENESS OF THE POMO’S ACTIVITIES, GOALS, ACCOMPLISHMENTS, CHALLENGES; AND IDENTIFY KEY NATIONAL/LOCAL FOUNDERS, DIRECTORS, STAFF MEMBERS, SUPERVISORS, VOLUNTEER ORGANIZERS AND POMO CONTACTS FOR MEMBERSHIP, COMMUNICATIONS, SPECIAL EVENTS, MEDIA, FINANCE, ETC. NAMES AND FACES ARE IMPORTANT! BUT THEY SHOULD NOT BE “FLUFF”; CREDIBILITY AND GRAVITAS SHOULD DRIVE THEIR FAMILIARITY.
6. SELECT A NAME FOR THE POMO. THIS CAN BE A QUICK OR LENGTHY PROCESS. EITHER WAY, IT’S ESSENTIAL TO GET IT RIGHT!
7. ONCE A NAME IS CHOSEN, A BODY (DESIGNATED AS AN EXECUTIVE COMMITTEE, ORGANIZING OR FOUNDERS’ BOARD, STEERING COMMITTEE OR SOME OTHER TITLE) SHOULD BE ESTABLISHED TO CREATE INITIAL MOMENTUM AND TO ATTRACT SUPPORT OF PEOPLE WITH NAMES OR FACES THAT ARE FAMILIAR TO THE PUBLIC THROUGH THEIR PERSONAL OR PROFESSIONAL ACTIVITIES.
8. AT SOME EARLY STAGE IN THIS PROCESS SOMEONE WITH THE NECESSARY MIX OF ENERGY, CREDIBILITY AND CHARISMA WILL EMERGE, OR HAVE TO BE CHOSEN, AS THE INITIAL PUBLIC FACE AND FOCUS OF THIS MOVEMENT. HE/SHE WILL BECOME AN IDENTITY SYMBOL TO BOTH FRIENDS AND FOES. THIS IS AN IMPORTANT STEP THAT CAN CREATE OR REVEAL PERSONAL MAGNETISM THAT SUCCEEDS AT PUBLIC EVENTS AND LEVELS.

WITHIN THE AREAS MENTIONED IN ITEMS 1-8 THERE WILL BE COMMUNICATIONS, CROSS COMMUNICATIONS AND MISCOMMUNICATIONS. THESE MULTIPLE FUNCTIONS MUST BE ORGANIZED AND DIRECTED WITH PURPOSE AND DISCIPLINE TO REDUCE ERROR AND CONFUSION TO THE LOWEST LEVEL POSSIBLE. THIS PROCESS OF FORMATION IS NOT LINEAR. THERE ARE MANY ELEMENTS THAT CAN BE FORMED AND CAN FUNCTION AT THE SAME TIME AS OTHERS. THERE WILL BE PERIODS OF MIXED RESULTS AND UNEVEN PROGRESS WHICH CAN BE OVERCOME BY THE POMO’S ENERGY AND CREDIBILITY.

THE WAY AHEAD — WHY?

HAVING ESTABLISHED A FRAMEWORK WITHIN WHICH WE CAN DEVELOP AND PROJECT OUR EFFORTS, WE MUST BE SURE THAT AT ALL TIMES THEY CONFORM TO THESE GENERAL PRINCIPLES:

A) THE PROCESS OF ACTIVATING A BROAD AND COORDINATED RESISTANCE TO THE CURRENT ATTACKS ON WCIV IS PRIMARILY AN EDUCATIONAL ONE BY WHICH WE MUST FIRST CREATE AWARENESS OF THE PROBLEM AND THEN ORGANIZE THAT AWARENESS INTO AN ENERGIZED BODY OF OPINION.

B) IT IS ABSOLUTELY ESSENTIAL THAT THE POMO'S COMMUNICATIONS NEVER ATTACK THE FORCES THAT OPPOSE IT. THE POMO'S ONLY LEGITIMATE POSTURE MUST BE THAT IT IS DEFENDING ITS OWN WCIV CULTURE, NOT ATTACKING OTHERS. THE AW ASSAULT IS THE COMBINED PRODUCT OF MANY DIFFERENT INTERESTS — SECULAR, RELIGIOUS, ECONOMIC, POLITICAL, ETC. IT WOULD BE FOLLY TO TRY TO RESPOND TO THEIR INDIVIDUAL TOPICS, ATTACKS AND METHODS. REPEAT: THE POMO MUST AT ALL TIMES BE SEEN AND CLEARLY LABELLED, AS A PROVIDER OF INFORMATION AND AWARENESS AS TO WHY AND HOW WCIV MUST BE ACTIVELY DEFENDED.

ANY TACTIC OR MESSAGE THAT MAY BE SEEN AND CLAIMED BY AW GROUPS TO BE AN ATTACK ON ALL OR ANY PART OF THEIR EFFORTS WILL IMMEDIATELY RESULT IN THEIR CASTING THEMSELVES AS VICTIMS AND WILL CREATE A RESPONSE MECHANISM FOR THEM WITH GLOBAL RESONANCE AMONG POPULATIONS THAT HAVE VIEWED THEMSELVES AS VICTIMS FOR CENTURIES.

PLAYING THE VICTIM IS A ROLE THAT COMES EASILY TO THE AW AND IS A WEAPON OF PROVEN SUCCESS. ANY SEMBLANCE OF ATTACK BY WCIV WILL ONLY MAKE IT MORE EFFECTIVE.

C) THE TEMPTATION IS ALWAYS PRESENT IN A POMO FOR ITS SUPPORTERS TO USE IT TO ADVANCE THEIR OWN POLITICAL, RELIGIOUS OR IDEOLOGICAL BELIEFS. THIS MAY SEEM TO SERVE THE INDIVIDUAL'S PURPOSE, BUT CAN BE DEADLY FOR THE POMO AND MUST NEVER BE ALLOWED. THE POMO'S PURPOSE MUST ALWAYS BE PROCLAIMED AND SEEN AS AWARENESS OF, AND DEFENSE AGAINST, AW ACTIONS BY OTHERS. ANY DEVIATION FROM THIS TEMPLATE INVITES WIDER ATTACKS WHICH OFFER ADVANTAGE TO GLOBAL AW FORCES.

* * *

ANOTHER REASON FOR MAINTAINING LASER-LIKE FOCUS IS THAT WE MUST NOT REPEAT THE WEST'S ERRORS OF THE PAST. WE HAVE ALREADY MENTIONED THE APPALLING LACK OF LAW ENFORCEMENT BY OFFICIALS IN EUROPE, AND THERE HAVE BEEN INSTANCES REPORTED HERE, AS WELL, IN WHICH LAWS HAVE BEEN BENT OR SUSPENDED TO FAVOR ILLEGAL ACTIVITIES.

WHETHER THESE DENIALS OF OUR CONSTITUTIONAL/TRADITIONAL PRINCIPLES RESULT FROM POLITICAL OR JUDICIAL OVERREACH IS OF SECONDARY IMPORTANCE. THEY DISRUPT AND DIVIDE OUR SOCIETY IN WAYS THAT HAVE THE POWER TO PUT OUR FORM OF GOVERNMENT AT RISK. TOO OFTEN, OVER TIME, WE HAVE FAILED TO ACT. LIKE ROTHERHAM, THIS FAILURE ENLARGES INTO A

DOUBLE CRIME — THE ORIGINAL ACT OF VIOLENCE FOLLOWED BY THE BETRAYAL OF OFFICIAL INACTION.

AND ALSO, TOO OFTEN, OUR LEADERS TURN AWAY BECAUSE AN ISSUE IS UNPROFITABLE, UNPOPULAR OR TOO CHALLENGING IN SOME OTHER WAY. IN BOTH SOCIETY AND GOVERNMENT, SUCH DENIAL IS LETHAL. UNDER GROWING PRESSURE FROM THE AW, DENIAL IN VARIOUS FORMS HAS OCCURRED, AND CONTINUES TO OCCUR, HERE. WE MUST EXPOSE IT AS THE PERIL IT IS AND DEVELOP BOTH THE AWARENESS AND MEANS TO DEFEND AGAINST IT.

THE PROCESS OF INTROSPECTION AND CALLING ATTENTION TO OUR PAST ERRORS POSES TWO VERY REAL PROBLEMS AGAINST WHICH WE MUST BE CONTINUALLY ON GUARD. THE FIRST WILL BE AN ATTITUDE OF AVOIDANCE PROFFERED BY A RANGE OF CONSTITUENCIES THAT BELIEVE CORRECTIVE ACTION IS NOT NECESSARY NOR POSSIBLE; THE PAST IS PAST AND ACTION NOW WOULD ONLY FURTHER ROIL OUR DIVIDED STATE, THEY WILL CLAIM.

NOT AS EVIDENT, PERHAPS, BUT EQUALLY TEMPTING IS THE OPPORTUNITY THAT WILL BE PRESENTED FOR MEMBERS WITHIN THE POMO TO IDENTIFY WITH THE ISSUES/EVENTS THAT ARE EXPOSED AND THEN TO ATTACH THEIR IDEOLOGIES, NEEDS, PREFERENCES, ETC. TO THEM. THIS IS A RESTATEMENT OF A POINT WE MADE BEFORE ABOUT PEOPLE LOADING THE POMO WITH THEIR PERSONAL IMPRINTS. THE REASON IT IS SO IMPORTANT AND BEARS REPEATING IS THAT EVERY STAGE OF THE POMO'S GROWTH, WHETHER MEASURED IN NUMBERS, DOLLARS OR AURA, WILL INVITE MORE INSTANCES OF PERSONAL PROJECTION.

POMOS ARE AMAZING OCCURRENCES. THEY CAN APPEAR SUDDENLY AND THEN, IF NOT MANAGED WELL, CAN FIZZLE OUT AND FADE AWAY. IF PROPERLY DIRECTED, HOWEVER, THEY CAN GAIN ACCEPTANCE AND THEN BECOME PART OF OUR SOCIETY'S MAINSTREAM. FOUNDERS SHOULD ALWAYS KEEP THESE TWO VERY DIFFERENT POSSIBILITIES IN MIND. SUCCESSFUL ONES HAVE THE ABILITY TO OUTLIVE THEIR FOUNDERS, AND OFTEN DO. THEIR EARLY, FORMATIVE STAGE CAN OFTEN DETERMINE WHETHER THEY ARE ACCEPTED OR REJECTED BY HISTORY, AS AT THIS CRITICAL TIME THE CHARACTER, THE PRINCIPLES AND THE CONDUCT OF THE PM MUST BE ESTABLISHED. ONCE SET, THEY CAN BE PUT TO WORK IN THE PM'S ACTIVITIES AND MESSAGING. THEY MUST BE STATED AND RESTATED AT EVERY OPPORTUNITY SO THAT THE PUBLIC WILL ASSOCIATE THEM WITH THE PM'S CAUSE AND PEOPLE.

POMOS CAN ASSUME DIFFERENT FORMS. CALL THIS ONE WHAT YOU WILL — A BLUEPRINT, ROAD MAP, MANIFESTO, CALL TO ARMS, WARNING FLAG, ACTION ALERT, WAKE-UP CALL — IT IS A MESSAGE THAT HAS NOT BEEN HEARD OR ACTED UPON FOR FAR TOO LONG. TIME PASSES; THE HOUR GROWS LATE. WCIV IS IN DANGER AND UNDER ATTACK. IF IT IS TO BE DEFENDED SUCCESSFULLY, AMERICA WILL HAVE TO ASSUME THE DEFINING RESPONSIBILITY.

IN THE CONFUSION OF WW II'S AFTERMATH, POLITICAL, ECONOMIC AND COMMERCIAL SYSTEMS AROUND THE WORLD HAD TO BE, AT BEST, RECENTERED AND, AT THE WORST, REDESIGNED AND RECONSTRUCTED. THIS PRESENTED A GOLDEN OPPORTUNITY

FOR WORLD COMMUNISM TO EXPLOIT PAST RESENTMENTS, AS WELL AS EXTENSIVE SOCIAL AND POLITICAL INEQUALITY THROUGHOUT THE WORLD. ADDED TO THE POSTWAR ECONOMIC/POLITICAL TRANSFORMATION, THEORIES EMANATING FROM THE NEW UN BROUGHT NEW THINKING ABOUT HOW TO SHAPE THE POSTWAR WORLD.

THE GRIP OF 19TH CENTURY EUROPEAN COLONIALISM LOOSENED AND, ONE BY ONE, ITS COLONIES BROKE FREE, SET UP INDIGENOUS GOVERNMENTS, ESTABLISHED A UN MISSION IN NYC AND BECAME INDEPENDENT NATIONS. IN TIME, A NEW COLONIALISM WITH NEW PARTICIPANTS AND METHODS, BUT WITH STRIKINGLY SIMILAR RESULTS, WOULD REPLACE THE OLD; AND IT REMAINS IN PLACE TODAY. THROUGHOUT THIS PERIOD OF POSTWAR FERMENT OVER TRIBAL, NATIONAL, CULTURAL, ECONOMIC AND POLITICAL STATUS AND IDENTITY, AW INTERESTS OF VARIOUS TYPES AND BACKGROUNDS CAME TOGETHER IN REALIZING THAT THE SHIFTING IDENTITIES AND FORTUNES OF THE POSTWAR WORLD PROVIDED IDEAL COVER FOR A CONCERTED ATTACK AGAINST WCIV — ITS CULTURE, HISTORY, RELIGIONS, GENETICS, POLITICS AND THEIR UNDERLYING VALUES.

COMMUNISM, SOCIALISM, AND COLONIALISM HAVE BEEN SIMULTANEOUSLY PRESENT ON THE WORLD STAGE SINCE THE LATE 19TH CENTURY, BUT COMMENCING IN THE '60s, MANY OF THE WORLD'S POLITICAL, SOCIAL AND TECHNOLOGICAL DIRECTIONS WERE JOINED AND CREATED AN IGNITION THAT WAS ABLE TO INFLUENCE INSTITUTIONS AND PEOPLE EVERYWHERE. NOT LONG THEREAFTER, IT APPEARS, THE AMERICAN POLITICAL LEFT CONCEIVED A PLAN TO MAKE USE OF THIS GLOBAL DISCONTENT TO TRANSFORM OUR POLITICAL IDENTITY AND CULTURE BY MOVING AMERICA'S POLITICAL POSITION SHARPLY LEFTWARD. TO MAKE MATTERS WORSE, THE LL HAS HAD OCCASIONAL HELP FROM A REPUBLICAN PARTY SO DIVIDED OVER IDEOLOGICAL PURITY THAT IT COULD NOT EXERCISE ITS OWN MAJORITY POWER !

ONE OF THE AW'S PREFERRED ATTACK TECHNIQUES HAS BEEN TO USE OUR OWN VALUES AS THEIR WEAPONS. FOR INSTANCE, AMERICA BEING A PREDOMINANTLY CHRISTIAN NATION, THE VALUES OF INCLUSION, EQUALITY, CHARITY AND ACCEPTANCE OF STRANGERS ARE WIDELY HONORED HERE. RECOGNIZING THIS, THE AW'S ARGUMENTS ON BEHALF OF UNLIMITED ADMISSIONS OF THIRD WORLD POPULATIONS TO OUR COUNTRY CITE THESE SAME VALUES AS MORAL AND SOCIAL IMPERATIVES THAT OUR IMMIGRATION LAWS AND POLICIES MUST REFLECT.

THIS TACTIC HAS SERVED THE AW WELL BY CREATING CONFUSION AND UNCERTAINTY OF RESPONSE AMONG FAR TOO MANY AMERICANS. THEIR SILENCE, AND THAT OF OUR ELECTED LEADERSHIP, CLEARLY SUGGESTS THAT THE ROTHERHAM AND SWEDISH SYNDROMES HAVE COUNTERPARTS HERE. THE "IT CAN'T HAPPEN HERE" MENTALITY FAILED US AT PEARL HARBOR IN 1941 AND AGAIN ON 9/11/01 AT THE WORLD TRADE CENTER. IT SERVED ITS TIME; WE SHOULD NEVER GIVE IT ANOTHER CHANCE. AND REMEMBER THAT ONE OF THE MOST FREQUENTLY REPEATED PHRASES FROM OUR GOVERNMENT IS "SO THAT THIS WILL NEVER HAPPEN AGAIN". BUT IT DOES, BECAUSE OUR POLITICAL LEADERS' MEMORIES ARE SHORT, THEIR WILL IS ABSENT AND THEY MUST BE READY TO CHASE TOMORROW'S HEADLINE OR SOUND-BYTE. MEANWHILE, THE NATIONAL THREATS ARE GATHERING AGAIN.

OUR CONSTITUTION GRANTS EXTRAORDINARY RIGHTS AND PRIVILEGES TO THE AMERICAN PEOPLE BECAUSE OUR FOUNDERS VISION OF AMERICA WAS THAT OF A HOMOGENEOUS SOCIETY BASED ON THE CENTURY AND A HALF EXPERIENCE OF THEIR NORTHERN EUROPEAN COLONIST PREDECESSORS. THERE WAS NO NECESSITY THEN, AND THERE IS NO MENTION NOW, THAT THE CONSTITUTION'S GENEROUS BENEFITS WERE TO BE SPECIFIED "FOR CITIZENS ONLY". THIS VERY NATURAL OMISSION WAS NOT A PROBLEM AS LONG AS OUR IMMIGRATION POLICY WAS UNDER FIRM CONTROL AND BASED ON ASSIMILATION. BUT THAT POLICY AND THE CONDITIONS THAT RESULTED FROM IT NO LONGER EXIST, BECAUSE OUR IMMIGRATION POLICY, LAW AND ENFORCEMENT HAVE BEEN ABANDONED UNDER THE PRESSURE OF COMPETING DEMANDS AND GOALS FROM GLOBAL POPULATIONS THAT COME TO LIVE HERE (LARGELY AT TAXPAYER EXPENSE) RATHER THAN REMAIN IN THEIR HOME COUNTRIES.

NOT SURPRISINGLY, THE MOST EGREGIOUS EXAMPLE OF THE CONSEQUENCES OF THE CONSTITUTION NOT BEING CITIZEN-SPECIFIC IN ITS GRANTS IS FOUND IN MANY OF THE EFFORTS OF MUSLIM ARRIVALS WHO HAVE THEIR OWN LAW SYSTEM (SHARIA) TO CLAIM RIGHTS FOR IT AND FOR THEM, EVEN THOUGH IT BROADLY CONTRADICTS OUR CONSTITUTION AND THE LAWS THAT DERIVE FROM IT.

THE PRINCIPLES OF SHARIA ARE CLEARLY STATED IN THE QUR'AN. THEY APPROVE PHYSICAL AND SEXUAL ABUSE OF WOMEN AND NON-MUSLIMS AS WELL AS VIOLENT FORMS OF TORTURE/PUNISHMENT FOR THOSE WHO DO NOT KEEP THE LAW. BECAUSE SHARIA IS A LIFE/LEGAL SYSTEM THAT DETERMINES RELIGIOUS, PERSONAL AND CIVIL BEHAVIOR, IT IS A FEARSOME WEAPON WHEN WIELDED BY AN ENEMY IN ATTACKING WCIV.

HERE'S WHAT WE FACE. A MUSLIM PERSON, GROUP OR INTEREST IS ALLOWED TO ENTER THE U.S. VIA ITS ASYLUM, REFUGEE OR FAMILY STATUS. GENERALLY, MUSLIMS PREFER TO FORM AND LIVE IN THEIR OWN COMMUNITIES RATHER THAN JOIN THE MAINSTREAM AND, WHEN THEY DO, THEY MAINTAIN MANY OF THEIR NATIVE CUSTOMS, CODES, CONDUCT — I.E., THEIR CULTURES TO WHICH ISLAMIC LAW, SHARIA, IS CENTRAL.

BECAUSE IT IS SO OPPOSITE TO OUR ANGLO-SAXON LEGAL SYSTEM AND BECAUSE IT DEFINES RELIGIOUS, PERSONAL AND POLITICAL BEHAVIOR, SHARIA FREQUENTLY AND QUICKLY FINDS ITSELF IN COURT IN CONFLICT WITH OUR LAWS.

IN SUCH INSTANCES MUSLIMS CLAIM THAT, AS SHARIA IS THEIR RELIGIOUS LAW, THEY ARE GUARANTEED ITS OBSERVANCE AND PROTECTION BY OUR CONSTITUTION'S FIRST AMENDMENT RIGHT OF RELIGIOUS FREEDOM. THERE ARE MANY OTHER ASPECTS OF OUR LEGAL SYSTEM IN WHICH MUSLIMS ATTEMPT TO TRANSFER RIGHTS UNDER OUR CONSTITUTION TO THEIR OWN PERSONS AND PURPOSES.

IF PERMITTED, THIS WILL RESULT IN A DIVIDED SOCIETY WITH ONE PARTY CLAIMING AUTHORITY FROM THE CONSTITUTION AND THE OTHER FROM THE QUR'AN. ONE CAN ONLY IMAGINE HOW CASES WOULD BE ARGUED IN COURT BY LEGAL AND RELIGIOUS SCHOLARS AND THE DIFFICULTIES THAT WOULD ATTACH TO JURY SELECTION AND PERFORMANCE.

"HISTORY INDICATES THAT THEY ARE WRONG,

SADLY, IN ENGLAND AND FRANCE THERE ARE ALREADY MUSLIM COMMUNITIES THAT ARE ALLOWED TO DEFINE SOME FUNCTIONS OF THEIR CIVIL LAW ACCORDING TO SHARIA, AND PRESSURES TO EXPAND THIS ACCEPTANCE ARE CONSTANT. IN AMERICA, THE CAMEL'S NOSE IS BARELY UNDER THE TENT, BUT WE ALSO HAVE SOME JUDGES WHO THINK OUR SYSTEM OF LAWS/GOVERNMENT CAN ACCOMMODATE SHARIA AS A PARALLEL ORDER. HISTORY INDICATES THAT THEY ARE WRONG, VERY WRONG.

THE INABILITY/UNWILLINGNESS OF OUR NATION TO RECOGNIZE THE PERILS POSED BY IMMIGRATION AND OTHER MEANS OF INFILTRATION AND ATTACK AGAINST WCIV IS A FORM OF SURRENDER AND, EVEN WHILE WATCHING ITS PROGRESS IN EUROPE OVER THE PAST GENERATION, WE HAVE OPTED FOR INACTION, BELIEVING, PERHAPS, IN THOSE PHRASES THAT WE HAVE USED TOO MUCH IN THE PAST — “IT CAN'T HAPPEN HERE” AND “SO THAT THIS CAN NEVER HAPPEN AGAIN”.

WE ARE THE AMERICA THAT RESPONDED TO EUROPE'S PLIGHT IN WW I AND TURNED THE TIDE OF THREE YEARS OF TRENCH WARFARE ON THE WESTERN FRONT; AND THE SAME AMERICA THAT A GENERATION LATER DELIVERED VICTORIES AT NORMANDY, IWO JIMA, MIDWAY AND THE BATTLE OF THE BULGE. AND WHAT IS OUR RESPONSE NOW, TWO GENERATIONS LATER, TO ANOTHER ATTACK ON OUR WAYS OF LIFE, GOVERNMENT AND CULTURE? SILENCE!

IT WOULD BE NAÏVE TO THINK THAT THE AW FORCES, SEEING OUR FAILURE TO ACT, WILL NOT USE EVERYTHING THEY CAN TO SERVE THEIR INTERESTS BY DISGUIISING AND ATTACHING THEIR CAUSES TO OUR ENVIRONMENTAL, ECONOMIC AND POLITICAL PROBLEMS. WE SHOULD BE ALERT TO THESE ATTEMPTS, EXPOSE THEM AND TAKE ACTION!

IT IS CLEAR FROM OUR BEHAVIOR NOW THAT WE ARE NOT THE SAME UNITED STATES THAT WE WERE WHEN WE FOUGHT TWO WORLD WARS IN ONE GENERATION! IN THE PAST, OUR SENSE OF NATIONAL IDENTITY PLAYED AN IMPORTANT ROLE IN OUR NATIONAL AND INTERNATIONAL UNDERTAKINGS. THAT IDENTITY NOW SEEMS LACKING.

TODAY, AS OUR ELECTED LEADERS DON'T SEEM ABLE TO COME TOGETHER AND IDENTIFY WITH NATIONAL GOALS AND VALUES, THEIR LEADERSHIP IS DIMINISHED. ANOTHER CONTRIBUTING FACTOR HAS BEEN THE DUMBING DOWN AND FAILURE OF OUR EDUCATIONAL SYSTEMS WHICH HAS CAUSED THE GREAT ARGUMENTS OVER OUR GOVERNMENT'S PURPOSE AND IDENTITY TO VANISH AND GIVE WAY TO BICKERING OVER POWERS, SMALL AND LARGE.

IN POLITICS AND EDUCATION OUR INDIVIDUAL IMAGES HAVE BEEN DISCARDED IN FAVOR OF GROUP IDENTITIES, AUTHORITY AND THOUGHT. WE SHOULD QUESTION HOW, IN A NATION THAT CELEBRATES ITS INDIVIDUALISM, WE HAVE ARRIVED AT A TIME WHEN OUR POLITICAL PROCESS HAS BECOME A STAGE ON WHICH WE SHOWCASE GROUP IDENTITIES. THIS PROCESS HAS BEEN WELL NAMED “IDENTITY POLITICS” BECAUSE IT DIVIDES OUR POLITICAL POWER INTO MORE NUMEROUS AND SMALLER GROUPS, EACH WITH ITS OWN IDENTITY, LABEL AND LOYALTY.

IN ADDITION TO THESE ELECTORAL CONFLICTS, IDENTITY POLITICS CREATES OPPOSITION BETWEEN THE IMPORTANT INDIVIDUAL RIGHTS ESTABLISHED IN OUR CONSTITUTION AND GROUP CONTROL OF OUR THOUGHT, SPEECH, PRAYER, PROTESTS, ETC.

ONCE WE ALLOW OUR TRADITIONAL, HISTORICAL IDENTITIES, AS INDIVIDUALS AND AS A NATION, TO BE REASSIGNED TO POLITICAL ONES, AS MC DOES, OUR CULTURE IS LOST. WE HAVE HAD FIFTY YEARS OF DEATH BY A THOUSAND CULTURAL CUTS WHICH WE HAVE BEEN ABLE TO SURVIVE. IF THEY CONTINUE, EVENTUALLY THEY WILL PROVE LETHAL.

“LIBERTY OR DEATH”

THESE RINGING WORDS THAT PATRICK HENRY SPOKE HAVE INSPIRED US FOR GENERATIONS. THEY POSE A STARK, EITHER-OR CHOICE WHICH IS DRAMATIC, BUT WHICH HISTORY USUALLY DISCARDS IN FAVOR OF SOMETHING MORE GRADUAL, OR EVEN NUANCED, WHICH IS WHAT THE DEFENDERS OF WCIV WILL HAVE TO EMPLOY.

THERE ARE ALWAYS NAYSAYERS ON HAND TO OPPOSE NEW EFFORTS AND DIRECTIONS AND QUASH THEM AT THEIR EARLIEST, MOST VULNERABLE STAGE. THIS IS ESPECIALLY TRUE OF POMOS THAT DISTURB THE SOURCES AND BALANCE OF POWER FOR BOTH POLITICAL PARTIES. STILL, THERE IS REASON (AS RECENTLY AS IN THE LAST HALF CENTURY) FOR ENCOURAGEMENT.

THE YEAR 1971, WHEN SEN. GAYLORD NELSON (R-WI) CALLED FOR THE CELEBRATION OF AN EARTH DAY TO CREATE AWARENESS OF OUR WASTE AND ABUSE OF OUR NATURAL RESOURCES, IS GENERALLY RECOGNIZED AS BEING THE START OF OUR POPULIST, NATIONAL ENVIRONMENTAL MOVEMENT. IN THE 50 YEARS SINCE, IT HAS GAINED THE SUPPORT OF MANY MILLIONS OF AMERICANS; ALTERED OUR ECONOMIC AND SCIENTIFIC ATTITUDES ABOUT OUR PLANET AND OUR RELATIONSHIP TO IT; AND BEEN SUCCESSFUL IN GREATLY REDUCING THE IMPACT OF INDUSTRIAL AND COMMUNITY WASTE UPON OUR LANDSCAPE.

THE COURSE OF PROGRESS FOR ENVIRONMENTAL AWARENESS AND CHANGE WAS NOT EASY, AS IT HAD TO WITHSTAND THE CONSIDERABLE POWER AND RESISTANCE OF PUBLIC AND PRIVATE INTERESTS THAT PROFITED FROM THE STATUS QUO — THE AGRICULTURAL LOBBY, THE CHEMICAL INDUSTRY, FOOD PRODUCERS AND THE SUPERMARKETS THROUGH WHICH THEY SOLD THEIR CANNED GOODS, PRODUCE, MEATS, CEREALS, ETC. A DAUNTING LIST OF ENEMIES; AND YET, ALMOST 60 YEARS LATER, THE ENVIRONMENTALIST CAUSE HAS CHANGED OUR AWARENESS AND TREATMENT OF THE ENVIRONMENT ALL HUMANS SHARE.

THE STRUGGLE TO DEFEND AGAINST THOSE WHO ATTACK WCIV WILL FACE MANY OF THE SAME TYPES OF ARGUMENT, DENIAL, LIES, DECEIT AND OTHER METHODS OF OBSTRUCTION AS ENVIRONMENTALISTS DID; AND THE PRESENCE OF DOUBT AND HOSTILITY WILL BE CONSTANT. IT WOULD BE MUCH EASIER TO HAVE A YES-NO, EITHER-OR DECISION, BUT IT IS NOT AVAILABLE. WHATEVER EFFORTS WE MAKE TO DEFEND WCIV, WE KNOW THAT THEY WILL PROVOKE MORE NUMEROUS WAYS TO ATTACK IT. AND YET, WE REALLY HAVE NO CHOICE. THE TIME IS NOW, AND ACTION

MUST BE TAKEN. IF NOT, WCIV IN EUROPE IS HIGHLY LIKELY TO BE UNRECOGNIZABLE BY MID-CENTURY, AND PART OF ITS PAST BY 2100.

“LEAVE THE MEDIA MADNESS TO THE POLITICIANS. IT INTERFERES WITH AWARENESS.”

AS FOR OUR COUNTRY, WE MUST ENGAGE IN A CONTEST OF OPINION AND AWARENESS THAT ONLY DETERMINED PEOPLE CAN WAGE, AND WHICH WILL PROBABLY BE THE LONGEST AND MOST IMPORTANT OF OUR WESTERN HISTORY. THIS SHOULD NOT BE A BLOODY-YOUR-NOSE STREET FIGHT, BUT MORE LIKE UNDERSEA SUBMARINE WARFARE --- KNOW THE ENEMY, TRACK HIM, QUIETLY NEUTRALIZE OR ELIMINATE HIM, MOVE ON AND REPEAT. LEAVE THE MEDIA MADNESS TO THE POLITICIANS. IT INTERFERES WITH AWARENESS.

FINALLY, AVOIDANCE, AS IN THE PAST, IS NO LONGER AN OPTION BECAUSE IT HAS SERVED OUR ENEMIES FAR BETTER THAN IT HAS US. OUR ELECTED REPRESENTATIVES, PERHAPS WORKING ON THE “DO WHAT YOU DO BEST” THEORY, HAVE BECOME EXPERTS IN NOT TAKING ACTION, IN “KICKING THE CAN DOWN THE ROAD”. THIS IS EXACTLY WHAT THE AW FORCES WANT AND WHAT HAS ENABLED THEIR PAST SUCCESS. THAT RESPONSE MUST NOW END AND BE REPLACED WITH A UNIFIED, PURPOSEFUL EFFORT BY AMERICA TO DEFEND ITS CIVILIZATION AND CULTURE.

IT SHOULD BE APPARENT THAT THE POMO THAT WE HAVE OUTLINED HERE WILL HAVE TO DRAW UPON MORE AND DIFFERENT SOURCES OF SUPPORT THAN THOSE THAT HAVE BEEN AVAILABLE TO MoC IN THE PAST. THE POMO WILL HAVE TO OBTAIN FUNDING FROM A VARIETY OF SOURCES — INSTITUTIONAL AND INDIVIDUAL — MOST OF WHICH WILL BE IDENTIFIED ONLY AS TIME PASSES AND PROGRESS IS ACHIEVED.

POMOs, ESPECIALLY IN THEIR EARLY STAGES, REQUIRE LEAPS OF FAITH AND ENERGY FROM THEIR SUPPORTERS. TO ENGAGE THOSE WHO ARE WILLING AND ABLE TO PROVIDE THESE QUALITIES IS A PRIORITY SECOND TO NONE.

IT WILL BE NECESSARY IN ASSEMBLING OUR INITIAL GROUP TO REACH BEYOND OUR AGING GENERATION DOWN TO THOSE OF OUR CHILDREN AND GRANDCHILDREN TO ACQUIRE THE SKILLS, TIME AND ENDURANCE OF THEIR YOUNGER YEARS. PLEASE KEEP THIS IN MIND AS YOU CONSIDER WHAT IS NEEDED IN OUR DEFENSE OF WCIV.

THROUGHOUT ITS EARLY STAGES — WHETHER IN RAISING FUNDS OR AWARENESS, OR PUTTING HUMAN HANDS AND HEARTS TO WORK — WORD OF MOUTH CAN MAKE THE DIFFERENCE BETWEEN SUCCESS AND FAILURE. IT WILL HAVE TO BE USED AS WIDELY AND EFFECTIVELY AS POSSIBLE TO CREATE THE AWARENESS THAT IS THE POMO’S GOAL.

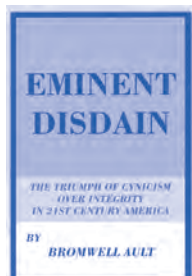
